#### Public Hearing

HB 2277

Removes exemption from regulation by Department of Consumer and Business Services for self-insured plans of insurance operating solely in this state.

HB 2294 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes program within Apprenticeship and Training Division of Bureau of Labor and Industries to make grants to local service districts and local joint committees that develop and administer pilot projects for firefighter apprenticeship training.

HB 2556

Requires that itemized statements provided to employees explain, in plain language, amount and purpose of each deduction.

HB 2722

Permits minors 16 and 17 years of age to operate power-driven machinery in certain circumstances.

#### Work Session

HB 2056

Modifies provisions relating to use of contributions and reserves of self-insurance programs established by multiple public bodies to insure against tort liability or property damage.

HB 2282

Authorizes Department of Consumer and Business Services to contract with more than five independent review organizations at one time.
