#### Public Hearing

HB 2008

CARRIED OVER FROM THE 3/6/2023 AGENDA: Specifies property and funds of judgment debtor that are exempt from execution or garnishment.

HB 2057

Makes contractor liable for unpaid wages, including other benefit payment or contributions of employee of subcontractor at any tier.

HB 2922

Increases bond amounts that persons licensed by Construction Contractors Board must maintain.

HB 3049

Directs Oregon Liquor and Cannabis Commission to establish annual registration program and labeling requirements for industrial hemp commodity or product that contains cannabinoids and is intended for human or animal consumption.

#### Work Session

HB 2620

Punishes violation of laws that regulate home solicitation sales as unlawful practice under Unlawful Trade Practices Act.

HB 2818

Expands definition of "consumer contract" to include purchases of used motor vehicles used primarily for personal, family or household purposes.

HB 2915

Prohibits retail pet store from offering to sell or selling dogs or cats.
