Work Session

HB 2057

CARRIED OVER FROM THE 3-22-2023 MEETING: Makes contractor liable for unpaid wages, including other benefit payment or contributions of employee of subcontractor at any tier.

HB 2515

CARRIED OVER FROM THE 3-22-2023 MEETING: Allows marijuana producer, marijuana wholesaler, marijuana processor or marijuana retailer to use motion detection camera system at licensed premises.

HB 2517

CARRIED OVER FROM THE 3-22-2023 MEETING: Exempts cannabis businesses from first-source hiring agreement requirements in enterprise zones.

HB 2556

Requires that itemized statements provided to employees explain, in plain language, amount and purpose of each deduction.

HB 2649

CARRIED OVER FROM THE 3-22-2023 MEETING: Provides that qualifying agency must require as material provision of public improvement contract that contractor establish and implement plan for outreach to and recruitment and retention of women, minority individuals and veterans to perform work under public improvement contract, with aspirational target of having individuals in one or more of these groups perform at least 15 percent of total work hours that workers perform under public improvement contract.

HB 2870

Permits contractors to submit bonds in lieu of retainage for construction projects and public improvement contracts.

HB 2921

Requires hospitals to file certain reports showing demographics of hospitals' workforces with Commissioner of the Bureau of Labor and Industries for posting to Bureau of Labor and Industries' website.

HB 3049

CARRIED OVER FROM THE 3-22-2023 MEETING: Directs Oregon Liquor and Cannabis Commission to establish annual registration program and labeling requirements for industrial hemp commodity or product that contains cannabinoids and is intended for human or animal consumption.

HB 3205

Modifies definition of "compensation," for purposes of pay equity requirements, to exclude hiring bonuses and retention bonuses.

HB 3227

Makes changes to Custodians' Civil Service Law to remove barriers to filling employment vacancies and remove certain qualifications for members of civil service board.

HB 3306

Requires entity that receives funds for certain workforce program initiatives to establish wage standards for individuals who participate in program administered by entity if, under program, entity provides individuals with paid work experience.

HB 3307

Provides that individuals who participate in certain on-the-job training programs are entitled to certain rights and protections concerning civil rights, discrimination and harassment as employees in employment relationship with employer.

HB 3385

Requires certain residential general contractors proposing remodel or repair project of more than \$20,000 in value to tour residential structure with property owner and provide property owner with itemized and detailed description for each feature of proposed construction work.

HB 3471

Prohibits employer from entering into settlement or agreement disposing of workers' compensation claim that bars worker from seeking further employment with employer unless such provision is first requested by worker.

Note Change: HB 2057, HB 2515, HB 2517, HB 2649, and HB 3049 have been carried over from the 3-22-2023 meeting.
