Public Hearing and Work Session

SB 881 A

Directs Director of Department of Revenue to reimburse worker leasing company for any employer contribution payments made by worker leasing company if Department of Revenue determines pursuant to amended combined quarterly report that refund is due.

SB 907 A

Prohibits employer from retaliating or discriminating against employee or prospective employee who, in good faith and with no reasonable alternative, refuses exposure arising from hazardous condition at place of employment.

SB 999 B

Clarifies meaning of "one-year period" for purposes of determining amount of unpaid family leave that eligible employee is entitled to take within any given one-year period.

Work Session

SB 228

Specifies additional circumstances under which Construction Contractors Board may revoke, suspend, condition or refuse to issue or reissue license for construction contractor, or impose civil penalty for violation of laws that regulate work of construction contractors in this state.

SB 692 A

CARRIED OVER FROM THE 5-8-2023 MEETING: Directs state agencies to use information system maintained by Oregon Department of Administrative Services to track internal investigations conducted by state agency regarding allegations of workplace discrimination and harassment concerning employees of state agency.

SB 851 A

CARRIED OVER FROM THE 5-8-2023 MEETING: Requires Bureau of Labor and Industries to prepare model respectful workplace policy that employers may adopt.
