Public Hearing

HB 3176 ** **Subsequent Referral(s) to Ways and Means
Requires Department of Human Services, in consultation with Office of Immigrant and Refugee Advancement, to award contracts to organizations to provide support services to immigrants and refugees.

Work Session

HB 2954 ** **Subsequent Referral(s) to Ways and Means
Directs Department of Early Learning and Care to establish and adopt by rule child care assistance pilot program to provide assistance and support to long term care employees with child care needs.

HB 2728 ** **Subsequent Referral(s) to Ways and Means
Requires Department of Human Services to contract with nonprofit organization to implement and administer program to assist recipients of supplemental nutrition assistance in purchasing locally grown fruits and vegetables from farmers' markets, farm share sites and retail outlets that participate in program.

HB 3076
Extends safe surrender period for anonymously leaving infant at authorized facility to 60 days from infant's date of birth.
