#### Public Hearing

HB 3031

Requires Department of Education to study matters related to ventilation and energy efficiency in schools.

HB 2638 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs district school boards to ensure that buildings regularly used by students have proper heating, air conditioning and ventilation systems to provide temperatures within acceptable range for learning and safety.

HB 2703 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Expands applicability of requirement to discuss class size and caseload as mandatory subject of bargaining for purposes of school district collective bargaining.

HB 3383

Increases membership of State Board of Education to include additional representative of congressional district and to include member engaged as classified staff member for public school or education service district.

#### Work Session

HB 3144

Directs Department of Education to develop and implement statewide education plan for students who are Native Hawaiian or Pacific Islander.

HB 2905

Expands list of individuals whose histories, contributions and perspectives are required to be included in social studies academic content standards and in related textbooks and instructional materials.

HB 2669

Declares children who are deaf, hard of hearing or deaf-blind have same rights and potential as children who are not deaf, hard of hearing or deaf-blind.
