Public Hearing and Possible Work Session

HB 3584

Directs schools or school districts to provide electronic communication to parents and guardians of students attending, and to school district employees employed at, school at which safety threat action occurred.

HB 3236 **

**Subsequent Referral(s) to Ways and Means

Authorizes expenditures from Statewide Education Initiatives Account for funding of regional career and technical education programs.

Work Session

HB 3177 **

**Subsequent Referral(s) to Ways and Means

Appropriates moneys from General Fund to Department of Education for deposit in Educator Advancement Fund for recruiting and retaining educators and providing professional learning opportunities for educators.

HB 3178

Expands criteria for awarding scholarships to diverse teacher candidates.

HB 2609

Changes operative date from January 1, 2026, to effective date of Act, for law removing authority of Teacher Standards and Practices Commission from establishing and collecting fee from educator preparation provider based on number of license applications received by commission from provider or type of educator preparation programs offered by provider.

SB 279 A

Enacts Interstate Teacher Mobility Compact.

HB 3288

Directs State Board of Education to adopt uniform standards related to collection of specified data.

HB 3135

Preserves additional funding for small school districts that merge with one or more school districts if certain conditions are met.

HB 3204

Modifies timelines and requirements for when school district makes determination whether to give approval for student to enroll in virtual public charter school not sponsored by school district.

HB 2281

Requires school districts and public charter schools to designate civil rights coordinator.

HB 2753

Allows district school board to choose to provide directors with monthly stipend.

HB 3199

Requires Department of Education to convene advisory group to review physical education requirements for certain students in grades six through eight.

HB 2710

Requires school districts to file with Superintendent of Public Instruction information about allocations and expenditures of moneys received from State School Fund.

HB 2739

Directs Oregon Department of Administrative Services to prepare tentative budget for funding of State School Fund.

HB 2751 **

**Subsequent Referral(s) to Ways and Means

Establishes Task Force on School Starting Times.

HB 2703 **

**Subsequent Referral(s) to Ways and Means

Expands applicability of requirement to discuss class size and caseload as mandatory subject of bargaining for purposes of school district collective bargaining.

HB 2959 **

**Subsequent Referral(s) to Ways and Means

Establishes Task Force on Health Care Services in Oregon Schools to examine scope of duties of employment and practice for licensed health care providers employed by schools, school districts or education service districts to provide health care services.

Note change: HB 3068 was removed. HB 3177, HB 3135, HB 3204, HB 2281, HB 2751, HB 2703, HB 2959, HB 2753, HB 3199, HB 2710, and HB 2739 were added.
