Allows district school board to enter into agreement with superintendent for payment in lieu of 12 months' notice required when superintendent's employment is terminated without cause.

HB 3595

CARRIED OVER FROM THE 03/22/2023 AGENDA: Establishes factors to be considered when Superintendent of Public Instruction enters into contract with education service district or school district to provide educational services to youths in Youth Corrections Education Program or Juvenile Detention Education Program.

HB 2281

CARRIED OVER FROM THE 03/22/2023 AGENDA: Requires school districts and public charter schools to designate civil rights coordinator.

CARRIED OVER FROM THE 03/22/2023 AGENDA: Requires school district to pay classified school employee not less than 10 percent more than minimum wage that applies to all employees who work in this state and not less than 15 percent more than minimum wage if classified school employee provides support to students with individualized education program or who are enrolled in special education.
