Public Hearing

HB 2472

Requires public universities to develop specified policies and accountability mechanisms for behavior at interscholastic activities, including sporting events.

HB 2961 **

**Subsequent Referral(s) to Ways and Means

Appropriates \$5,000,000 to Higher Education Coordinating Commission for allocation to expand scope and community reach of college access and success programs at public universities and community colleges.

HB 3115

Requires each community college and public university to have at least 45 percent of total number of credit hours offered taught by full-time employee during 2024-2025 academic year, at least 55 percent of total number of credit hours taught by full-time employee during 2025-2026 academic year, at least 65 percent of total number of credit hours offered taught by full-time employee during 2026-2027 academic year and at least 75 percent of total number of credit hours offered taught by full-time employee every academic year thereafter.

HB 2824

Requires Higher Education Coordinating Commission, in coordination with public universities and community colleges, to conduct study to determine appropriate of return State of Oregon should receive for each patent obtained as result of public moneys provided to public university or community college.

Work Session

HB 2802

Establishes pilot program at Portland State University and Eastern Oregon University to enhance hiring of public university students by nonprofit organizations.
