HB 2802

CARRIED OVER FROM THE 02/28/2023 AGENDA: Establishes pilot program at Portland State University and Eastern Oregon University to enhance hiring of public university students by nonprofit organizations.

HB 3089

Authorizes Higher Education Coordinating Commission to award "Hunger Free Campus" designation to public universities and community colleges that demonstrate required actions taken to combat hunger.

HB 3115

CARRIED OVER FROM THE 02/28/2023 AGENDA: Requires each community college and public university to have at least 45 percent of total number of credit hours offered taught by full-time employee during 2024-2025 academic year, at least 55 percent of total number of credit hours taught by full-time employee during 2025-2026 academic year, at least 65 percent of total number of credit hours offered taught by full-time employee during 2026-2027 academic year and at least 75 percent of total number of credit hours offered taught by full-time employee every academic year thereafter.

HB 2204 \*\*

\*\*Subsequent Referral(s) to Tax Expenditures

Creates income or corporate excise tax credit for taxpayer that employs youth through Oregon Youth Employment Program.

HB 2961 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Appropriates \$5,000,000 to Higher Education Coordinating Commission for allocation to expand scope and community reach of college access and success programs at public universities and community colleges.
