Public Hearing and Possible Work Session

HB 2961 **

**Subsequent Referral(s) to Ways and Means

Appropriates \$5,000,000 to Higher Education Coordinating Commission for allocation to expand scope and community reach of college access and success programs at public universities and community colleges.

HB 3427

Requires public university to submit any proposed change in affiliation with athletic association, conference or organization with authority over intercollegiate sports to appropriate legislative committees for review.

HB 2471

Requires Oregon Health and Science University, in consultation with Oregon Department of Administrative Services and Department of Revenue, to conduct study to determine how best to revise repayment method for individuals who receive scholarship from Scholars for a Healthy Oregon Initiative, but who do not fulfill required service agreement.

Work Session

HB 2472

Requires public universities to develop specified policies and accountability mechanisms for behavior at interscholastic activities, including sporting events.

HB 2263

CARRIED OVER FROM THE 3/23/2023 MEETING: Requires Higher Education Coordinating Commission to conduct study to determine how best to coordinate post-secondary education in Oregon.

HB 2265

CARRIED OVER FROM THE 3/23/2023 MEETING: Requires Higher Education Coordinating Commission to conduct study to determine best method for increasing percentage of students enrolled in public universities who graduate in four years.

HB 2740

CARRIED OVER FROM THE 3/23/2023 MEETING: Establishes uniform method for calculating eligibility of part-time faculty member of community college or public university for certain health care, retirement and other benefits.

HB 3120

CARRIED OVER FROM THE 3/23/2023 MEETING: Requires Higher Education Coordinating Commission to conduct study to determine best method for connecting public higher education to workforce and economic development needs of Oregon.

HB 3121

CARRIED OVER FROM THE 3/23/2023 MEETING: Requires Higher Education Coordinating Commission to conduct study to determine best method for making public higher education affordable for Oregonians.

HB 3456

CARRIED OVER FROM THE 3/23/2023 MEETING: Establishes Sexual Misconduct Survey Council.

HB 3561

CARRIED OVER FROM THE 3/23/2023 MEETING: Specifies that term "early childhood care and education" includes early childhood behavioral and mental health services for purposes of scholarships and grants awarded to ensure state has adequate supply of early childhood care and education professionals.

HB 3563

CARRIED OVER FROM THE 3/23/2023 MEETING: Creates Oregon Youth Works Advisory Board to advise on and oversee implementation and alignment of youth workforce development programs for which Higher Education Coordinating Commission is responsible.

HB 3564

CARRIED OVER FROM THE 3/23/2023 MEETING: Increases number of members of Higher Education Coordinating Commission representing congressional districts from five to six and decreases number of members of commission representing general public from four to three.

HB 3565

CARRIED OVER FROM THE 3/23/2023 MEETING: Establishes Oregon Tribal Student Grant program.

Note change: HB 2263, HB 2265, HB 2740, HB 3120, HB 3121, HB 3456, HB 3561, HB 3563, HB 3564, and HB 3565 were carried over.
