HB 2330

Redesignates Uniform Fraudulent Transfer Act as Uniform Voidable Transactions Act.

HB 2324

Modifies provisions relating to mailing of notice of appeal.

HB 2325

Allows public member of board of governors of Oregon State Bar to be elected as president or president-elect of board.

HB 2329

Modifies execution formalities for appointment of person to make decisions concerning disposition of remains and for declaration for mental health treatment.
