#### Public Hearing

- HB 2427 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Modifies mileage rate paid to witnesses for travel to and from civil and criminal proceedings.
- HB 2431  
Prohibits termination of medical assistance for person who is residing in correctional facility in pretrial detention pending adjudication.
- HB 2497 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs State Court Administrator to fund assessment of courthouses in small counties.

#### Work Session

- HB 2645  
Provides that "attempted transfer," for purposes of Uniform Controlled Substances Act, includes possession of controlled substance with intent to transfer to another person.
