- HB 2535 ** **Subsequent Referral(s) to Ways and Means
Requires Department of Corrections to establish doula program for pregnant and postpartum adults in custody at Coffee Creek Correctional Facility.
- HB 2731 ** **Subsequent Referral(s) to Ways and Means
Directs Oregon Criminal Justice Commission to establish, in collaboration with Department of Corrections, Family Preservation Project pilot program at Coffee Creek Correctional Facility.

Public Hearing

- HB 2327 ** **Subsequent Referral(s) to Ways and Means
Permits county juvenile department to provide preventive services to certain persons under 12 years of age.
- HB 3036 ** **Subsequent Referral(s) to Ways and Means
Permits education provider to operate video recording device for purpose of recording persons who fail to stop for bus safety lights.
