#### Placeholder Bills

- HB 2312 \*\* \*\*Subsequent Referral(s) to Behavioral Health and Health Care  
Requires Oregon Health Authority to study access to behavioral health treatment in rural and medically underserved areas of this state.
- HB 2319  
Directs Oregon Criminal Justice Commission to study use of technology in improving efficiency of criminal proceedings, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2331  
Requires State Court Administrator to study courts.
- HB 2334  
Directs Oregon Criminal Justice Commission to study ways to improve expunction process, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2337  
Directs Oregon Criminal Justice Commission to study effect of sentencing types on recidivism rates, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2338  
Directs Department of Transportation to study issues related to driving privileges and to report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2024.
- HB 2341  
Requires State Court Administrator to study court civil proceedings.
- HB 2344  
Requires Department of Human Services to study domestic violence.

- HB 2347  
Directs Oregon Criminal Justice Commission to study effect of different types of sentences on recidivism rates, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2357  
Requires State Department of Agriculture to study animals.
- HB 2359  
Directs Department of Corrections to study whether changes to community corrections funding are needed, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2362  
Directs Department of Corrections to study issues relating to prison evacuations due to wildfire, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2364  
Directs Oregon Criminal Justice Commission to study recidivism rates of persons convicted of property crimes, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2365  
Directs Public Defense Services Commission to study ways to improve provision of public defense services within this state, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2371  
Requires Oregon Youth Authority to study juveniles.
- HB 2372  
Requires Oregon Youth Authority to study issues related to youth.
- HB 2374  
Directs Department of Justice to study ways to improve provision of crime victim services, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2375  
Requires Oregon Youth Authority to study its practices and procedures.
- HB 2380  
Requires Oregon State Bar to study rules of evidence.
- HB 2388  
Directs Oregon Criminal Justice Commission to study effect of payment of restitution on recidivism rates, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2024.
- HB 2392 \*\*  
Appropriates moneys to Department of Justice for distribution to district attorneys for purposes of paying expenses relating to review of body camera footage.
- HB 2932  
Requires Oregon Liquor and Cannabis Commission to study cannabis.
