Work Session

SB 212 A

Makes confidential and exempts from discovery and public records certain communications and information conveyed during, to facilitate or to follow up on peer support check-in sessions with Oregon Youth Authority employees.

SB 355 A

Provides that public university is required to make annual report on use of outside counsel for legal matters available on website, rather than provide report to Attorney General.

SB 618 A

CARRIED OVER FROM THE 5-16-2023 MEETING: Directs court to consider, when determining aggravation at sentencing, whether defendant was wearing body armor at time of crime.

SB 699

CARRIED OVER FROM THE 5-16-2023 MEETING: Expands definition of "public safety officer" to include certain regulatory specialists as persons who may be eligible for benefit awards from Public Safety Memorial Fund.

SB 745 A

Directs county juvenile department to ensure that specified youth or adjudicated youth receives sex trafficking screening.

SB 780 A

Creates offense of unlawful fender height modifications.

SB 787

CARRIED OVER FROM THE 5-16-2023 MEETING: Expands crime of assault in the third degree to include assault of public transit vehicle operator acting in course of official duty.

SB 807 A

CARRIED OVER FROM THE 5-16-2023 MEETING: Provides procedure whereby elected judge may challenge party, attorney, law firm, district attorney's office, defense consortium or public

defender's office that files motions to disqualify judge that effectively deny judge assignment to criminal or juvenile delinquency docket.

SB 862 A

CARRIED OVER FROM THE 5-16-2023 MEETING: Permits owner of self-service storage facility to advertise or publish notice of sale of personal property that is subject to lien once in newspaper of general circulation or on publicly accessible website that regularly advertises or offers personal property for auction or sale.

SB 951

Provides that certified parole and probation officer employed by State Board of Parole and Post-Prison Supervision qualifies as police officer under Public Employees Retirement System.

SB 957 A

Expands types of prior convictions that increase offense level for crime of public indecency.

SB 974 A

Creates crime of sexual abuse by fraudulent representation.

SB 1052

Modifies crimes related to involuntary servitude and human trafficking.
