- HB 2107 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4/18/2023 MEETING: Extends automatic voter registration to Oregon Health Authority in certain circumstances.
- HB 2422 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4/18/2023 MEETING: Directs Legislative Administrator to pay costs of reasonable accommodation of member of Legislative Assembly who is afforded rights and protections as person with disabilities under specified federal and state law.
- HB 2955
CARRIED OVER FROM THE 4/18/2023 MEETING: Designates ___ of each year as Bracero Program Day.
- HCR 20
CARRIED OVER FROM THE 4/18/2023 MEETING: Commemorates 150th anniversary of opening of Willamette Falls Locks.
- SB 207
CARRIED OVER FROM THE 4/18/2023 MEETING: Authorizes Oregon Government Ethics Commission to proceed on own motion to review and investigate, if commission has reason to believe that public body conducted meetings in executive session that were not in compliance with laws authorizing executive sessions.

HB 3197

Limits requirement that development regulations be clear and objective to development of housing within urban growth boundaries.

HB 3608

Provides that, for purpose of specifying prevailing rate of wage for electrical workers, locality is geographical area within which each local union is exclusive representative for local union's membership, and collective bargaining agreement is collective bargaining agreement to which local union is party.

Work Session

HB 3306 A

Requires entity that receives funds for certain workforce program initiatives to establish wage standards and develop training plan for individuals who participate in program administered by entity if, under program, entity provides individuals with paid work experience.

HB 2683

Provides that child who has open case in child welfare system is eligible to participate in Employment Related Day Care subsidy program.
