#### Public Hearing

SB 123

Requires Department of Environmental Quality to study recyclability claims.

#### Work Session

SB 542

Requires original equipment manufacturer to make available to owner of consumer electronic equipment or independent repair provider on fair and reasonable terms any documentation, tool, part or other device or implement that original equipment manufacturer makes available to authorized repair provider for purpose of diagnosing, maintaining or repairing consumer electronic equipment.

SB 546

Requires Oregon Health Authority to adopt and maintain list of designated high priority chemicals of concern used in cosmetic products and to periodically review and revise list.

SB 1015 \*\*

\*\*Subsequent Referral(s) to Tax Expenditures

Allows taxpayer to fully depreciate, over two tax years, property that shows demonstrable reduction in carbon emissions.

*The Work Session on SB 678 is scheduled solely for the purpose of moving it to the Rules Committee.*

SB 678

Establishes state policy that benefits from offshore wind energy development go to local and regional communities, ecosystems and environments and economies and that interconnection of offshore energy projects be carried out in manner that promotes electric grid reliability and resilience.
