#### Public Hearing

SB 892

Amends statutes relating to housing laws and to authority of Housing and Community Services Department and Oregon Housing Stability Council, including changes to department's procurement authority and ability to provide down payment assistance.

SB 893

Directs Housing and Community Services Department to study issues related to homelessness and to report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2025.

SB 406

Requires certain cities in Tillamook County to allow middle housing on residentially zoned lands, to adopt housing production strategies and to accommodate estimated housing needs upon lands inventoried as buildable lands.

SB 1051

Requires Department of Land Conservation and Development to study urban reserves.

#### Work Session

SB 225

Provides that unused portion of amount of pass-through revenue bonds authorized for issuance in preceding biennium carries forward until legislation authorizing amount of pass-through revenue bonds for current biennium is enacted.

SB 1013

Requires counties to allow certain rural homeowners to site one recreational vehicle on their property.

*The following bill is scheduled solely for the purpose of moving the bill to the Senate Committee on Rules.*

SB 1078

Requires state agencies that acquire public property to comply with local ordinances mandating notice to or consultation with local government or mandating compliance with conditions of local government.

*Note change: SB 892 and SB 893 added, SB 919 removed.*
