#### **Public Hearing**

SB 979

Provides that constructing child care facility within project for affordable housing does not subject project for affordable housing to prevailing wage requirements if child care facility meets specified requirements.

SB 859

Allows local governments, and during emergency period allows Governor or certain agencies, to abate waste, graffiti and vandalism associated with homelessness and other factors.

SB 919

Requires Housing and Community Services Department to study housing.

SB 998

Authorizes cities to include modifications to system development charges in housing productions strategy.

#### **Work Session**

SB 892

Amends statutes relating to housing laws and to authority of Housing and Community Services Department and Oregon Housing Stability Council, including changes to department's procurement authority and ability to provide down payment assistance.

SB 893

Directs Housing and Community Services Department to study issues related to homelessness and to report to appropriate committee or interim committee of Legislative Assembly on or before September 15, 2025.

SB 936 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Housing and Community Services Department to provide grants to developers of single-family homes made available for affordable homeownership.

SB 937 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Housing and Community Services Department to make grants to nonprofit institutions to provide low-interest loans to purchasers of homes with limited equity.
