Public Hearing

SB 1030

Requires Judicial Department, in collaboration with Public Defense Services Commission, to study child welfare investigations and improvements necessary to align rights and procedural protections of parents and children involved in child welfare investigations with those afforded to defendants in criminal proceedings.

HB 2447 A

Provides that declarations of Department of Human Services or Oregon Health Authority relating to deceased depositors of certain financial institutions must be made within specified time period.

HB 3076 A

Extends safe surrender period for anonymously leaving infant at authorized facility to 60 days from infant's date of birth.
