Work Session

HB 2599 A

Waives background check fee for employees and volunteers of certain respite service providers.

HB 2804 A

Requires Department of Human Services to conduct annual assessment of workforce capacity and needs in each program and unit of department and report results to interim committees of Legislative Assembly no later than September 30 of each even-numbered year.

HB 3234

Prohibits commitment of children with intellectual disabilities without consent of parent or legal guardian.

HB 3256

Prohibits child who is receiving developmental disability services in developmental disability child foster home from being attended by parent or guardian without approval of Department of Human Services.

HB 3558

Modifies definitions related to child care for purposes of implementation and enforcement.
