- SB 766 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs Oregon Criminal Justice Commission to award noncompetitive grants through Illegal Marijuana Market Enforcement Grant Program to Department of State Police for specified purposes related to unlawful marijuana cultivation or distribution operations.
- SB 696 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Appropriates moneys to Department of Justice out of General Fund to fund animal cruelty-focused attorney within department's Criminal Justice Division.
- HB 2325  
Allows public member of board of governors of Oregon State Bar to be elected as president or president-elect of board.
