Permits consumers to obtain from a controller that processes consumer personal data confirmation as to whether controller is processing consumer's personal data and categories of personal data controller is processing, list of specific third parties to which controller has disclosed consumer's personal data and copy of all of consumer's personal data that controller has processed or is processing.
- HB 2324  
Modifies provisions relating to mailing of notice of appeal.

- SB 806  
Permits obligor who is required to maintain life insurance policy to cover child support obligations to move court to modify portion of judgment requiring maintenance of life insurance policy under specified circumstances.
