#### Public Hearing and Possible Work Session

SB 616

CARRIED OVER FROM THE 1/31/2023 AGENDA: Allows holder of direct shipper permit to ship up to five cases of cider or malt beverages, each containing not more than nine liters, per month to Oregon resident.

SB 228

Specifies additional circumstances under which Construction Contractors Board may revoke, suspend, condition or refuse to issue or reissue license for construction contractor, or impose civil penalty for violation of laws that regulate work of construction contractors in this state.

SB 403

Allows person who retires from Department of State Police as police officer to participate in group benefit plan offered by Public Employees' Benefit Board with no increase in premiums.

#### Public Hearing

SB 631

Permits employees of certain state agencies to refuse to work additional mandatory overtime shift scheduled by employer when employee has already worked mandatory overtime in same month.

SB 692 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs Department of Human Services to develop or acquire and maintain information system for tracking investigations related to allegations of workplace discrimination and harassment.
