#### Possible Work Session

HB 2274 A

Permits Director of Department of Consumer and Business Services to make any proper inquiry of person or matter connected with offering, purchasing or selling any security or conducting securities business and requires person to reply promptly and truthfully to inquiry.

HB 2285

Removes obsolete provisions relating to Social Security Revolving Account.

HB 2759 A

Provides that person that knows or consciously avoids knowing that another person is engaging in act or practice that violates laws that regulate telephone solicitations or use of automatic dialing and announcing devices and nonetheless provides substantial assistance or support for violation is liable for loss and subject to penalty to same extent as person that engaged in violation.

HB 2982 A

Requires insurer to offer 70 percent of coverage insured previously purchased for contents of residence to insured without requiring inventory of loss if total loss of contents occurs as result of major disaster.

HB 3412 A

Authorizes physician assistants to provide same level of service as nurse practitioners for workers' compensation claims in managed care organization setting.

#### Public Hearing

HB 2053

Provides that person that carries on, conducts or transacts business in county of this state under assumed business name that person has not registered or for which person does not maintain registration lacks standing in courts of this state to maintain action on behalf of business.

HB 2283 A

Modifies provisions relating to public employee retirement.

HB 2870 A

Requires contracting agency to accept from contractors bonds in lieu of retainage for construction projects and public improvement contracts.

HB 3307 A

Provides that individuals who participate in certain on-the-job training programs are entitled to certain rights and protections concerning civil rights, discrimination and harassment as employees in employment relationship with employer.
