Work Session

HB 3362 A

Allows county to validate unit of land that had been approved for recognition that was later revoked after sale to innocent purchaser.

HB 2238 A

Authorizes method by which Department of State Lands may dispose of personal property left on state lands.

Possible Work Session

HB 2192 A

Aligns criteria for alteration, restoration or replacement of a dwellings on lands zoned for forest use consistent with criteria applicable to dwellings on lands zoned for farm use.

HB 3458 A

Limits issues that may be basis for appeal of land use decisions where local government amends comprehensive plan or land use regulations.

HB 3187 A

Makes individuals who possess relevant technical experience and are employed seven or more years by certain types of districts, and certain types of registered professionals, eligible to apply for certification as water right examiners.
