SUMMARY

Amends statutes relating to housing laws and to authority of Housing and Community Services Department and Oregon Housing Stability Council, including changes to the department's procurement authority and ability to provide down payment assistance.

Declares emergency, effective on passage.

7 **Be It Enacted by the People of the State of Oregon:**

8 9 TRIBAL ACCESS TO HOUSING FUNDS

10
11 **SECTION 1.** ORS 458.210 is amended to read:

12 458.210. For the purposes of ORS 456.550 and 458.210 to 458.240, a com-
13 munity development corporation is:

14 **(1)** An organization that:

15 [(1)] **(a)** Is established under the provisions of ORS chapter 65;

16 [(2)] **(b)** Has qualified for tax exempt status under section 501(c)(3) of the
17 Internal Revenue Code;

18 [(3)] **(c)** Has a purpose, stated in the articles of incorporation, to serve

1 low and moderate income people's need for community development and
2 community self-help;

3 [(4)] (d) Has a board of directors, of not fewer than five members, that
4 is locally controlled by including 51 percent of the board members from the
5 service area; and

6 [(5)] (e) Has a defined geographic service area[.]; **or**

7 **(2) A housing entity or housing authority designated by a tribe, as**
8 **defined in ORS 182.162, to receive funds and administer housing pro-**
9 **grams.**

10 **SECTION 2.** ORS 458.225 is amended to read:

11 458.225. (1) In carrying out the provisions of ORS 456.550 and 458.210 to
12 458.240, the Housing and Community Services Department shall give prefer-
13 ence to a community development corporation **described in ORS 458.210 (2)**
14 **or** that:

15 (a) Has a defined geographic service area outside an entitlement commu-
16 nity or county;

17 (b) Has a defined geographic service area inside an entitlement commu-
18 nity or county but does not include more than 50,000 people in the service
19 area;

20 (c) Has a defined geographic service area that includes five or fewer
21 nonentitlement counties; and

22 (d) Can demonstrate support from the community.

23 (2) As used in this section, "entitlement community or county" means any
24 area within the state that is:

25 (a) A "metropolitan city" as defined in 42 U.S.C. 5302(4) (1995); or

26 (b) An "urban county" as defined in 42 U.S.C. 5302(6) (1995).

RULEMAKING

30 **SECTION 3.** ORS 456.555 is amended to read:

31 456.555. (1) The Housing and Community Services Department is estab-

1 lished.

2 (2) The department *[shall be under the supervision and control of]* **is**
3 **supervised and controlled by** a director who is responsible for the per-
4 formance of the duties imposed upon the department. The Governor shall
5 appoint the Director of the Housing and Community Services Department.
6 The director shall hold office at the pleasure of the Governor. The person
7 appointed as director *[shall]* **must** be a person who, by training and experi-
8 ence, is well qualified to perform the duties of the office.

9 (3) The director shall receive such salary as may be provided by law, or,
10 if not so provided, as may be fixed by the Governor. In addition to the salary
11 of the director, the director shall, subject to the limitations otherwise pro-
12 vided by law, be reimbursed for all expenses actually and necessarily in-
13 curred by the director in the performance of official duties.

14 (4) The director may establish department divisions including but not
15 limited to divisions for administration, housing programs and community
16 services programs.

17 *[(5) The Oregon Housing Stability Council shall:]*

18 *[(a) With the advice of the director, set policy and approve or disapprove*
19 *rules and standards for housing programs;]*

20 *[(b) Approve or disapprove loans, grants and other funding award pro-*
21 *posals under ORS 456.561;]*

22 *[(c) Provide policy direction and oversight to the department regarding the*
23 *department's financial planning and biennial budget proposal prior to its*
24 *submittal to the Oregon Department of Administrative Services; and]*

25 *[(d) Carry out the provisions of ORS 456.571.]*

26 [(6)] **(5)** The *[Housing and Community Services]* department *[and the*
27 *council]* shall consider advice on housing and community service programs
28 from:

29 (a) Persons who have experienced housing instability;

30 (b) Tribes;

31 (c) The Community Action Partnership of Oregon;

- 1 (d) Continuums of care, as defined in 24 C.F.R. part 578;
- 2 (e) Local governments;
- 3 (f) Nonprofit organizations;
- 4 (g) Homeless services providers;
- 5 (h) Culturally specific organizations;
- 6 (i) Housing providers;
- 7 (j) Veterans' services organizations; and
- 8 (k) Other entities identified by the department by rule.

9 [(7)] **(6)** The director shall report regularly to the **Oregon Housing Sta-**
10 **bility** Council to keep the council informed on progress made by the de-
11 partment in carrying out the department's responsibilities for housing
12 programs.

13 [(8)] **(7)** The department shall administer federal programs [*with advice*
14 *from the council*]. Federal funds for housing stabilization must, to the extent
15 consistent with federal law, be allocated statewide in a manner proportionate
16 to a needs-based and geographically based formula.

17 [(9)] **(8)** The department may adopt rules to carry out the programs that
18 the department is charged with administering, including, but not limited to,
19 rules regarding:

- 20 (a) Administration and enforcement.
- 21 (b) Criteria for the granting of benefits.
- 22 (c) The establishment of fees and charges.
- 23 (d) The identification of housing programs and community services pro-
24 grams.
- 25 (e) The distinguishing of housing programs from community services pro-
26 grams.

27 **(9) When a statute authorizes or requires that the department or**
28 **the director adopt rules or policies or administer programs, the direc-**
29 **tor may, at any stage in the process, consult with or seek the approval**
30 **of the council.**

31 (10) [*Subject to the approval of the council,*] The department shall establish

1 by rule one or more threshold property purchase prices above which a
2 housing loan proposed by the department requires council review and ap-
3 proval under ORS 456.561. In establishing or modifying a threshold property
4 purchase price under this subsection, the department shall consider any
5 maximum acquisition cost set forth in the Internal Revenue Code or federal
6 rules and regulations implementing the code.

7 (11) [*Subject to the approval of the council,*] The department shall establish
8 by rule one or more threshold amounts above which a housing grant or other
9 housing funding award proposal requires council review and approval under
10 ORS 456.561.

11 **SECTION 4.** ORS 456.559 is amended to read:

12 456.559. (1) The Housing and Community Services Department shall:

13 (a) Maintain current housing data and information concerning available
14 programs, status of funding, programs planned or undertaken which might
15 conflict with, overlap, duplicate or supersede other planned or existing pro-
16 grams and call these to the attention of appropriate state agencies, govern-
17 mental bodies and public or private housing sponsors.

18 (b) Maintain current data from local, state and federal sources concerning
19 publicly supported housing as that term is defined in ORS 456.250, the status
20 of existing affordability restrictions as that term is defined in ORS 456.250
21 and rental assistance contracts at publicly supported housing.

22 (c) Provide to appropriate state agencies, governmental bodies and public
23 or private housing sponsors such advisory and educational services as will
24 assist them in the development of housing plans and projects.

25 (d) Subject to the approval of the Oregon Housing Stability Council, make
26 noninterest bearing advances, in accordance with ORS 456.710 and the poli-
27 cies of the department, to qualified nonprofit sponsors for development costs
28 of housing projects until mortgage funds are released to repay the advances
29 as provided in ORS 456.710.

30 (e) Advise and assist appropriate state agencies, governmental bodies and
31 public or private housing sponsors, cities and counties, in all programs and

1 activities which are designed or might tend to fulfill the purposes of ORS
2 456.548 to 456.725 and ORS chapter 458.

3 (f) Encourage and assist in the planning, development, construction, re-
4 habilitation and conservation of dwelling units for persons and families of
5 lower income.

6 (g) Be the central state department to apply for, receive and distribute,
7 on behalf of appropriate state agencies, governmental bodies and public or
8 private housing sponsors in the state, grants, gifts, contributions, loans,
9 credits or assistance from the federal government or any other source for
10 housing programs except when the donor, grantor, or lender of such funds
11 specifically directs some other agency to administer them. Moneys received
12 under this section shall be deposited with the State Treasurer in an account
13 separate and distinct from the General Fund. Interest earned by the account
14 shall be credited to the account.

15 (h) For the purposes of acquiring moneys, credits or other assistance from
16 any agency or instrumentality of the United States or from any public cor-
17 poration chartered by the United States, comply with any applicable agree-
18 ments or restrictions for the receipt of such assistance and become a member
19 of any such association or public corporation chartered by the United States.

20 (i) Assist individuals, appropriate state agencies, governmental bodies and
21 public or private housing sponsors through a program which provides hous-
22 ing information, planning, educational services and technical assistance.

23 (j) Comply with the requirements of ORS 443.225 in assisting in the de-
24 velopment of any housing for residential care, training or treatment for
25 persons with intellectual or developmental disabilities or mental or emo-
26 tional disturbances.

27 (2) Except as otherwise provided in ORS 456.255 to 456.265, 456.625 (7) and
28 458.480 to 458.490, the department may not itself develop, construct, rehabil-
29 itate or conserve housing units; and neither the department nor any housing
30 sponsor, including but not limited to any association, corporation, cooper-
31 ative housing authority or urban renewal agency organized to provide hous-

1 ing and other facilities under ORS 456.548 to 456.725, may own, acquire,
2 construct, purchase, lease, operate or maintain utility facilities, including
3 facilities for the generation of electricity, for the distribution of gas and
4 electricity, and for the conveyance of telephone and telegraph messages.

5 (3) In accordance with the provisions of this section and with the advice
6 of the council, the department shall establish statewide priorities for housing
7 programs. State agencies shall coordinate their housing programs with the
8 department. All state agencies intending to apply for federal funds for use
9 in planning, developing or managing housing, or rendering assistance to
10 governmental bodies or sponsors or individuals involved therein shall submit
11 a description of the proposed activity to the department for review not less
12 than 30 days prior to the intended date of submission of the application to
13 the federal agency. The department shall determine whether the proposal
14 would result in a program that would overlap, duplicate or conflict with any
15 other housing program in the state. If the department finds overlapping or
16 duplication or conflict, it shall recommend modifications in the application.
17 The Oregon Department of Administrative Services shall consider these rec-
18 ommendations in making its decision to approve or disapprove the applica-
19 tion. The department shall complete its review and forward its
20 recommendations within 15 working days after receipt of the notification.
21 Failure of the department to complete the review within that time shall
22 constitute approval of the application by the department.

23 (4) The Director of the Housing and Community Services Department may
24 participate in discussions and deliberations of the council. The director may
25 suggest policies [*and rules*] to the council, including those necessary to
26 stimulate and increase the supply of housing for persons and families of
27 lower income.

28 **SECTION 5.** ORS 456.571 is amended to read:

29 456.571. (1) The Oregon Housing Stability Council shall, with the advice
30 of the Director of the Housing and Community Services Department, develop
31 policies to:

1 (a) Aid in stimulating and increasing the supply of housing for persons
2 and families of lower income;

3 (b) Address geographic and racial disparities; and

4 (c) Ensure funds distributed by the Housing and Community Services
5 Department contribute to addressing other state priorities.

6 (2) The council shall make special effort to respond to both private and
7 public actions that may raise the cost of the housing supply in the open
8 market, as the open market is the source of housing for the preponderance
9 of lower income households.

10 (3) The council is responsible for studying and commenting upon, and
11 advising the department, Governor, Legislative Assembly, other state agen-
12 cies and local governments concerning, local, state and federal legislation
13 or rules that affect the cost and supply of housing, both before and after the
14 legislation and rules are enacted. For purposes of this subsection, “legis-
15 lation or rules that affect the cost and supply of housing” includes but is
16 not limited to legislation or rules that would:

17 (a) Provide financing for the construction or rehabilitation of housing;

18 (b) Subsidize new or existing housing costs for lower income households
19 by income support, tax credit, or support service methods;

20 (c) Regulate the division of land;

21 (d) Regulate the use of land;

22 (e) Regulate building construction standards;

23 (f) Regulate fees and charges for inspection services, permits, or profes-
24 sional services related to housing;

25 (g) Encourage alternatives that increase housing choices;

26 (h) Create or avert overlapping jurisdictional functions and the concom-
27 itant increased costs that are reflected in housing prices;

28 (i) Create or avoid conflicting state and federal regulations that deprive
29 lower income households of assistance; and

30 (j) Help or hinder compliance with the housing goals established by the
31 Land Conservation and Development Commission under ORS 197.240.

1 (4) The council, with the approval of the Governor, may initiate legal
2 proceedings in the name of the council to further the council's purposes un-
3 der this section.

4 (5) The council shall exercise the responsibilities and powers of the
5 council in a manner that expedites the acquisition, construction, improve-
6 ment or rehabilitation of housing.

7 (6) With respect to the Community Development Incentive Project Fund
8 established under ORS 458.720, the council shall develop program guidelines,
9 including specific project criteria and financing mechanisms, review appli-
10 cations seeking funding from the fund and make recommendations for fund-
11 ing approval to the director and review proposals for cooperative agreements
12 or joint projects between the department and other state agencies to facili-
13 tate the goals of the fund.

14 (7) The council[, *in conjunction with the Community Action Partnership*
15 *of Oregon,*] shall advise and assist the department, **at the director's re-**
16 **quest**, with rules, policies and programs [*regarding low income home energy*
17 *assistance under ORS 458.515.*] **under ORS 456.555 (9). In providing advice**
18 **and assistance, the council shall consider advice on housing and com-**
19 **munity service programs from entities listed under ORS 456.555 (5) and**
20 **other entities identified by the department by rule.**

21 (8) **The council shall approve or disapprove loans, grants and other**
22 **funding award proposals under ORS 456.561.**

23 [(8)] (9) The council, in conjunction with the Community Action Part-
24 nership of Oregon, shall ensure the coordination of state agency
25 homelessness relief efforts.

26 **SECTION 6.** ORS 456.608 is amended to read:

27 456.608. (1) The Housing and Community Services Department shall de-
28 velop and implement the Rent Guarantee Program for the purpose of pro-
29 viding incentives and financial assistance to landlords that rent to low
30 income households by guaranteeing payments to landlords for unpaid rent
31 and for eviction and property damage costs as described in this section.

1 *[Department administration of the program is subject to Oregon Housing Sta-*
2 *bility Council policy, rules and standards.]*

3 (2) A tenant is eligible to participate in the program if the tenant:

4 (a) Resides in a low income household;

5 (b) Experiences barriers to obtaining housing, including but not limited
6 to:

7 (A) Poor credit history or ratings;

8 (B) A criminal history;

9 (C) That the tenant has been a ward, as defined in ORS 419A.004, within
10 the past 10 years and is at least 16 years of age and less than 27 years of
11 age; or

12 (D) A history of housing evictions; and

13 (c) Successfully completes the tenant training and certification process
14 implemented by the department under subsection (3) of this section.

15 (3) As part of the program implemented under this section, the department
16 shall provide training to, and a certification process for, tenants from low
17 income households for the purposes of providing tenants with information
18 on how to achieve and maintain a successful tenancy and providing reliable
19 accreditation of tenants to landlords that are considering renting to tenants
20 from low income households.

21 (4) A landlord may submit a request for financial assistance to the de-
22 partment in accordance with rules adopted by the *[council]* **department**. Fi-
23 nancial assistance to landlords under the program is limited as follows:

24 (a) Reimbursement for unpaid rent and payment of eviction and damage
25 costs are limited to circumstances involving rental or lease agreements en-
26 tered into with tenants determined to be eligible under subsection (2) of this
27 section;

28 (b) Financial assistance is limited to reimbursement for unpaid rent and
29 eviction and damage costs incurred during the first 12 months of any single
30 rental or lease agreement;

31 (c) Financial assistance paid under the program to a landlord is limited

1 to a maximum of \$5,000 per eligible request; and

2 (d) Payment of financial assistance is contingent on the landlord's sub-
3 mission of a complete and accurate reimbursement request, verification of
4 unpaid rent and eviction or damage claims by the department or program
5 provider described in subsection (6) of this section and cooperation with the
6 collection of data to measure program performance outcomes as described in
7 subsection (6) of this section.

8 (5) Before receipt of payments of financial assistance under the program,
9 a landlord must provide to the department or the program provider described
10 in subsection (6) of this section a report containing information required by
11 rule [*adopted by the council*]. The report must contain, at a minimum, the
12 following:

13 (a) Information regarding eligible tenants with whom the landlord entered
14 into tenancy agreements including, but not limited to, the length of tenancy
15 and reason for termination of tenancy, if applicable; and

16 (b) The amounts of unpaid rent and eviction and damage costs not reim-
17 bursed by financial assistance received by the landlord under the program.

18 (6)(a) The department may contract with a public or private provider to
19 administer the program within an individual county or region of this state
20 and to distribute financial assistance to eligible landlords as provided in this
21 subsection. The department is not subject to the provisions of ORS chapter
22 279A or 279B in awarding a contract under the provisions of this subsection.
23 The department shall, in consultation with the **Oregon Housing Stability**
24 Council, establish criteria for proposals, prepare and publish requests for
25 proposals, receive proposals and award contracts to eligible providers. Eli-
26 gible providers must, at a minimum:

27 (A) Have experience providing tenant readiness education sufficient to
28 provide tenant training and certification as described in subsection (3) of this
29 section;

30 (B) Have experience placing persons in low income households into per-
31 manent housing;

1 (C) Have experience working collaboratively with local landlords and
2 service providers; and

3 (D) Demonstrate the organizational capacity to administer the program,
4 including the ability to track data and performance measure outcomes and
5 to timely process requests for and payments of financial assistance.

6 (b) Program providers shall, in accordance with rules adopted by the
7 [*council*] **department**:

8 (A) Provide reports regarding the number of landlords and program eli-
9 gible tenants participating in the program, demographic information about
10 tenants, identified tenant risk factors and the number and amount of re-
11 quests for financial assistance made under the program;

12 (B) Review and verify requests for financial assistance and make pay-
13 ments in accordance with established department processes for distributing
14 funds; and

15 (C) Collect data to measure the following program performance outcomes:

16 (i) Increased housing stability, as measured by the percentage of total
17 program participants who reside in and maintain permanent housing for a
18 minimum of 12 months;

19 (ii) Increased landlord participation, as measured by the percentage in-
20 crease in the number of landlords participating in the program; and

21 (iii) Successful tenant readiness education, as measured by the percentage
22 of tenants successfully completing the tenant training and receiving certi-
23 fication as described in subsection (3) of this section.

24 (7) Nothing in this section prohibits a landlord from participating in the
25 Housing Choice Landlord Guarantee Program under ORS 456.375 to 456.390
26 or the Housing Choice Voucher Program under 42 U.S.C. 1437f(o).

27 (8) The department may not pay financial assistance under the Rent
28 Guarantee Program from any source other than available funds in the Rent
29 Guarantee Program Fund established in ORS 456.609. Amounts due and
30 payable under the program shall not constitute a debt of the state or a
31 lending of the credit of the state within the meaning of any constitutional

1 or statutory limitation.

2 (9) The department shall submit an annual report to the interim legisla-
3 tive committees of the Legislative Assembly related to housing no later than
4 September 15th of each year regarding the implementation and status of the
5 program, the number of participants in the program, amounts of financial
6 assistance requested and paid and the performance outcomes measured by the
7 program.

8 (10) [*The council, in consultation with*] The department[,] shall adopt rules
9 to implement the provisions of this section.

10 **SECTION 7.** ORS 458.310 is amended to read:

11 458.310. (1) The [*Oregon Housing Stability Council*] **Housing and Com-**
12 **munity Services Department** shall adopt rules to develop and administer
13 a housing revitalization program for low and moderate income housing.

14 (2) Applicants for revitalization program funds shall be:

15 (a) A unit of local government;

16 (b) A housing authority;

17 (c) A nonprofit corporation; or

18 (d) An applicant eligible under paragraph (a), (b) or (c) of this subsection
19 who contracts with another entity, including a private for-profit corporation.

20 (3) Housing revitalization projects shall bring into use vacant and aban-
21 doned property or rehabilitate substandard property, or both. Eligible project
22 activities include, but are not limited to:

23 (a) Purchase of property;

24 (b) Rehabilitation of housing units;

25 (c) New construction to replace units for which rehabilitation is infeasible;
26

27 (d) Mortgage interest subsidies or reduction of principal loan amounts;

28 or

29 (e) Other activities that have the effect of making properties available to
30 and occupied by persons of lower income, such as loan guarantees.

31 (4) Projects funded by the housing revitalization program shall be rental

1 or owner-occupied single or multifamily housing.

2 (5) The housing rehabilitation program shall create affordable housing in
3 which rent levels are no higher than 30 percent of 80 percent of median in-
4 come levels.

5 (6) Priority shall be given to projects applied for under subsections (1) to
6 (5) of this section that provide opportunities for low and moderate income
7 persons to own their housing units.

8 (7) Priority among rental housing projects shall be given to projects ap-
9 plied for under subsections (1) to (5) of this section that:

10 (a) Have rent levels no higher than 30 percent of 50 percent of the median
11 income level, or less;

12 (b) Are owned and operated by a nonprofit or a governmental unit; and

13 (c) Demonstrate a coordinated local effort to integrate housing, job
14 placement and social services.

15 (8) In implementing this section and ORS 458.305, the [*council*] **depart-**
16 **ment** shall work to ensure a reasonable geographic distribution of funds
17 among different regions of the state and shall place special emphasis on en-
18 suring that funds are available to projects in rural areas.

19 **SECTION 8. ORS 458.480 to 458.490 are added to and made a part of**
20 **ORS chapter 458.**

21 **SECTION 9.** ORS 458.485 is amended to read:

22 458.485. (1) The Housing and Community Services Department shall, [*with*
23 *the advice and consent of*] **after consultation with** the Oregon Housing
24 Stability Council, develop and implement the Local Innovation and Fast
25 Track Housing Program for the purpose of expanding the state's supply of
26 affordable housing for low income households.

27 (2) The department may use funds available pursuant to Article XI-Q of
28 the Oregon Constitution and deposited in the Local Innovation and Fast
29 Track Housing Program Fund established under ORS 458.490 to:

30 (a) Acquire, construct, remodel, repair, equip or furnish qualified property
31 that is or will be owned or operated by the State of Oregon for the purpose

1 of providing affordable housing in this state for low income households; and

2 (b) Pay development costs to develop qualified property that may be con-
3 sidered part of the cost of a capital asset under generally accepted account-
4 ing principles.

5 (3) Interests in real property acquired by the State of Oregon or the de-
6 partment under this section are limited to the following:

7 (a) A fee simple interest in land or improvements;

8 (b) A leased fee interest, meaning an ownership interest with the rights
9 of use and occupancy conveyed by lease to others;

10 (c) A tenancy in common for which the state's or department's interest
11 in the property is proportionate to the contribution of the state or depart-
12 ment to the property's purchase price;

13 (d) A fee simple interest in a condominium; or

14 (e) An easement, right of way, license or similar interest functionally re-
15 lated to and necessary for the use of qualified property acquired by the state
16 or department.

17 (4) In funding the acquisition, construction, remodeling, repairing, equip-
18 ping or furnishing of qualified property under the program, the
19 department[, *with the advice and consent of the council,*] may:

20 (a) Adopt criteria that:

21 (A) Provide the greatest number of affordable housing units for the
22 amount of funding provided;

23 (B) Ensure the longest possible use of the qualified property as affordable
24 housing units;

25 (C) Optimize the function and duration of the affordable housing project;
26 and

27 (D) Take into account the means to reduce the cost of the affordable
28 housing project while considering factors such as the quality of construction,
29 durability, location and local design requirements;

30 (b) Create restrictive covenants and other encumbrances or lien interests,
31 create entities, cooperate or participate with persons or entities and contract

1 with persons and entities; and

2 (c) Operate qualified property.

3 (5) Moneys made available through the program must be distributed or
4 used statewide and concentrated in areas of this state with the greatest need
5 for affordable housing, as determined by the department with the advice and
6 consent of the council.

7 (6) For purposes of implementing the program, the council shall develop
8 strategies to:

9 (a) Reach historically underserved communities, including communities
10 of color and rural communities;

11 (b) Reduce the cost of acquiring, constructing, remodeling, repairing,
12 equipping or furnishing qualified property that is owned or operated by the
13 state for the purpose of providing affordable housing; and

14 (c) Involve Department of Human Services child welfare and self-
15 sufficiency programs.

16 (7) The Director of the Housing and Community Services Department
17 shall report regularly to the council regarding the status and progress of the
18 program and of the Housing and Community Services Department's respon-

12 **SECTION 16.** ORS 456.625 is amended to read:

13 456.625. The Housing and Community Services Department may:

14 (1) Undertake and carry out studies and analyses of housing needs within
15 the state and ways of meeting such needs and make the results of such
16 studies and analyses available to the public, qualified housing sponsors and
17 the private housing sector.

18 (2) Prepare proposals on measures it considers necessary to address ad-
19 ministration, housing programs or community services programs.

20 (3) With the approval of the Oregon Housing Stability Council, assess
21 fees, charges or interest in connection with housing programs.

22 (4) Encourage community organizations to assist in initiating housing
23 projects for persons and families of lower income.

24 (5) Encourage the salvage of usable housing scheduled for demolition or

25 approval of the articles of incorporation and bylaws of any such organization
26 in carrying out ORS 456.515 to 456.725.

27 (10) Cooperate with and exchange services, personnel and information
28 with any federal, state or local governmental agency.

29 (11) With the approval of the State Treasurer, contract for the services
30 of and consultation with trustees, investment and financial advisors, paying
31 agents, remarketing agents and other professional persons or organizations

1 in carrying out ORS 456.515 to 456.725 and ORS chapter 458.

2 (12) Contract for, act on or perform any other duties that the department
3 considers necessary or appropriate to carry out housing programs and com-
4 munity services programs, including but not limited to contracting to provide
5 compliance monitoring or other administrative functions with respect to
6 housing developments and affordable housing, whether or not the housing
7 developments or affordable housing receives department funding and whether
8 or not the housing developments or affordable housing is located within this
9 state. For purposes of this subsection, “affordable housing” has the meaning
10 given that term in ORS 456.055.

11 (13) Purchase, service, sell and make commitments to purchase, service
12 and sell residential loans to the extent permitted by ORS 456.635 and 456.640
13 (1) to (3).

14 (14) Initiate or assist appropriate state agencies, governmental bodies and
15 public or private housing sponsors in the development, construction, acqui-
16 sition, ownership, leasing, rehabilitation or management of housing to carry
17 out the purposes of ORS 456.515 to 456.725 and ORS chapter 458 where such
18 housing is not otherwise affordable or available in the area.

19 (15) Execute and record written instruments that contain terms, including
20 but not limited to restrictive covenants or equitable servitudes, pertaining
21 to the use and enjoyment of housing projects. Notwithstanding any other
22 provision of law, the executed instruments shall constitute and create re-
23 strictive covenants affecting and running with the property according to the
24 terms of the instruments when recorded in the records of the county where
25 the property is located. County clerks shall accept the instruments for re-
26 cording when presented by or on behalf of the department.

27 (16) Subject to the provisions of any agreement then existing with

DOWN PAYMENT ASSISTANCE

SECTION 17. ORS 456.627 is amended to read:

456.627. Notwithstanding the provisions of ORS 456.625 (7) **and except for loans made solely to provide assistance with down payments or closing costs**, the Housing and Community Services Department [*shall*] **may** not make any single-family residential loan directly to any individual unless the Legislative Assembly or Emergency Board finds that private lending institutions are unwilling or unable to participate in the department’s single-family residential loan programs or portions of those programs under ORS 456.548 to 456.725.

SECTION 18. ORS 456.548 is amended to read:

456.548. As used in ORS 456.548 to 456.725, unless the context requires otherwise:

(1) “Bonds” means any bonds, as defined in ORS 286A.001, or any other evidence of indebtedness, issued under ORS 456.515 to 456.725 or issued in anticipation of bonds and payable from the proceeds of bonds issued.

(2) “Capital reserve account” or “capital reserve accounts” means one or more of the special trust accounts that may be established by the Housing and Community Services Department within the Housing Finance Fund.

(3) “Consumer housing cooperative” means a cooperative corporation formed under ORS chapter 62 and whose articles of incorporation provide, in addition to the other requirements of ORS chapter 62, that:

(a) The consumer housing cooperative has been organized exclusively to provide housing facilities for persons and families of lower income and such social, recreational, commercial and communal facilities as may be incidental to such housing facilities.

(b) All income and earnings of the consumer housing cooperative shall be used exclusively for consumer housing cooperative purposes and that no unreasonable part of the net income or net earnings of the cooperative shall inure to the benefit or profit of any private individual, firm, corporation,

1 partnership or association.

2 (c) The consumer housing cooperative is in no manner controlled or under
3 the direction of or acting in the substantial interest of any private individ-
4 ual, firm, corporation, partnership or association seeking to derive profit or
5 gain therefrom or seeking to eliminate or minimize losses in any transaction
6 therewith, except that such limitation shall apply to the members of the co-
7 operative only to the extent provided by rules of the department.

8 (d) The operations of the consumer housing cooperative may be supervised
9 by the department and that the consumer housing cooperative shall enter
10 into such agreements with the department as the department may require to
11 provide regulation by the department of the planning, development and
12 management of any housing project undertaken by the cooperative and the
13 disposition of the property and other interests of the cooperative.

14 (4) "Development costs" means the costs that have been approved by the
15 department as appropriate expenditures and includes, but is not limited to:

16 (a) Payments for options to purchase property for the proposed housing

24 (c) Such other expenses incurred by the qualified housing sponsor as the

26 [(5) "*Federally insured security*" means an evidence of indebtedness insured
27 or guaranteed as to repayment of principal and interest by the United States
28 or an agency or instrumentality thereof.]

29 [(6)] (5) "Housing development" means a development that contains
30 housing units for persons or families of lower income and such other inci-
31 dental elements of residential, commercial, recreational, industrial, com-

1 munal or educational facilities as the department determines improve the
2 quality of the development as it relates to housing for persons or families
3 of lower income and the financial feasibility of the development.

4 [(7)] (6) "Housing finance bond declaration" means a written instrument
5 signed by the Director of the Housing and Community Services Department
6 or the designee of the director and on file with and bearing the certificate
7 of approval of the State Treasurer or the designee of the State Treasurer,
8 and all housing finance bond declarations supplemental to that instrument.

9 [(8)] (7) "Housing Finance Fund" means the Housing Finance Fund es-
10 tablished in ORS 456.720 (1).

11 [(9)] (8) "Lending institution" means any bank, mortgage banking com-
12 pany, trust company, savings bank, credit union, national banking associ-
13 ation, federal savings and loan association or federal credit unit maintaining
14 an office in this state, or any insurance company authorized to do business

16 [(10)] (9) "Limited dividend housing sponsor" means a corporation, trust,
17 partnership, association or other entity, or an individual that is a mortgagor.

18 [(11)] (10) "Manufactured dwelling park nonprofit cooperative" has the
19 meaning given that term in ORS 62.803.

20 [(12)] (11) "Manufactured housing" means a dwelling unit manufactured
21 off-site having a minimum width of 10 feet and a minimum area of 400 square
22 feet built on a permanent chassis and designed to be used for permanent
23 residential occupancy whether or not on a permanent foundation, and that
24 contains permanent eating, cooking, sleeping and sanitary facilities and
25 meets such standards as the department determines, by rule, are reasonable
26 to maintain the quality, safety and durability of the dwelling, the sanitary
27 requirements of the communities in which they are located and the security
28 of the loans that the department may finance for the purchase of the
29 dwellings.

30 [(13)] (12) "Nonprofit housing corporation" means an organization formed
31 under ORS chapter 65 and whose articles of incorporation provide, in addi-

1 tion to the other requirements of ORS chapter 65, that:

2 (a) The corporation has been organized exclusively to provide housing
3 facilities for persons and families of lower income and such other social,
4 recreational, commercial and communal facilities as may be incidental to
5 such housing facilities.

6 (b) All the income and earnings of the corporation shall be used exclu-
7 sively for corporation purposes and that no part of the net income or net
8 earnings of the corporation may inure to the benefit of any private individ-
9 ual, firm, corporation, partnership or association.

10 (c) The corporation is in no manner controlled or under the direction or
11 acting in the substantial interest of any private individual, firm, partnership
12 or association seeking to derive profit or gain therefrom or seeking to elim-
13 inate or minimize losses in transactions therewith.

14 (d) The operations of the corporation may be supervised by the depart-
15 ment and that the corporation shall enter into such agreements with the
16 department as the department may require to regulate the planning, devel-
17 opment and management of any housing project undertaken by the corpo-
18 ration and the disposition of the property and other interests of the
19 corporation.

20 [(14)] (13) "Person of lower income" or "family of lower income" means:

21 (a) A person or family residing in this state whose income is not more
22 than 80 percent of area median income, adjusted for family size, as deter-
23 mined by the [Oregon Housing Stability Council] **Housing and Community**
24 **Services Department** based [upon] **on** information from the United States
25 Department of Housing and Urban Development;

26 (b) A person or family residing in this state whose income, adjusted for
27 family size, is below the level the Housing and Community Services Depart-
28 ment has determined to be necessary in order to obtain in the open market
29 decent, safe and sanitary housing, including the cost of utilities and taxes,
30 for not more than 25 percent of the gross income of the person or family; or

31 (c) Any person or family the department determines is appropriate to treat

4 [(15)] (14) "Project cost" or "costs of the project" means the sum of all
5 reasonable expenses incurred by a qualified housing sponsor in undertaking
6 and completing a housing project approved by the department. "Project
7 costs" or "costs of the project" include but are not limited to the expenses
8 incurred by a qualified housing sponsor for:

9 (a) Studies and surveys;

10 (b) Plans, specifications, architectural and engineering services;

11 (c) Legal, organizational and other special services;

12 (d) Financing, acquisition, demolition, construction, equipment and site
13 development of new and rehabilitated housing units;

14 (e) Movement of existing buildings to new sites; the cost of acquisition,
15 or estimated fair market value, of land and other interests in real estate;

16 (f) Rehabilitation, reconstruction, repair or remodeling of existing
17 buildings;

18 (g) Estimated carrying charges during construction and for a reasonable

20 (h) Placement of tenants or occupants and relocation services in con-

24 [(16)] (15) "Qualified housing sponsor" means[, *subject to the approval of*]
25 **the following entities if approved by** the department under ORS 456.620

27 (a) A consumer housing cooperative;

28 (b) A limited dividend housing sponsor;

29 (c) A nonprofit housing corporation;

30 (d) A for-profit housing sponsor;

31 (e) A housing authority;

1 (f) An urban renewal agency created by ORS 457.035; and

2 (g) Any city or county governing body or agency or department designated
3 by the governing body.

4 [(17)] **(16)(a)** “Residential housing” means a specific work or improvement
5 within this state undertaken primarily to provide dwelling accommodations,
6 including land development and acquisition, construction or rehabilitation
7 of buildings and improvements thereto, for residential housing, and such
8 other nonhousing facilities as may be incidental or appurtenant thereto and

23 (A) Improved by a newly constructed, existing or rehabilitated residential

25 (B) Unimproved if the proceeds of such loan shall be used for the erection

27 guaranteed by the United States or any instrumentality or agency thereof.

28 (b) An insured or guaranteed loan for the acquisition of manufactured

5 **ment, made for the acquisition of a residential structure and made**

9 [(19) "Revolving account" means the Housing and Community Services De-
10 partment Revolving Account created in ORS 456.574.]

FUNDS AND ACCOUNTS

14 **SECTION 19.** ORS 456.574 is amended to read:

15 456.574. (1) There is created in the General Fund of the State Treasury
16 the Housing and Community Services Department [*Revolving Account*]
17 **Fund**. All moneys deposited in the [*account*] **fund** are continuously appro-
18 priated for the purposes of carrying out the programs which the Housing and
19 Community Services Department is charged with administering subject to
20 limitations otherwise prescribed by law.

21 (2) The [*Housing and Community Services*] department may transfer to the

3 **SECTION 20.** ORS 456.710 is amended to read:

4 456.710. (1) The Housing and Community Services Department may use
5 moneys in the [*revolving account*] **Housing and Community Services De-**
6 **partment Fund** to make noninterest-bearing advances to qualified nonprofit
7 housing sponsors or interest-bearing advances to other qualified housing
8 sponsors for use in payment by such sponsors of the development costs of

26 456.720. (1) The Housing Finance Fund is established, separate and dis-
27 tinct from the General Fund. The **Housing Finance** Fund shall consist of
28 the proceeds from the sale of bonds issued under ORS 456.645 and related
29 refunding bonds, fees and other moneys received by the Housing and Com-

17 456.579. (1) There is established separate and distinct from the General
18 Fund an account to be known as the Manufactured Dwelling Parks Account.

21 and responsibilities imposed upon the department under ORS 90.800 to 90.850
22 and 456.581 and this section. Interest earned on the account is credited to

26 (d) A consumer housing cooperative, as defined in ORS 456.548;

29 (4) “Low income household” means a household with income less than or
30 equal to 80 percent of the area median income.

31 (5) “Moderate income household” means a household with income less

1 than or equal to 120 percent and greater than 80 percent of the area median
2 income.

3 (6) "Subsidy" includes, but is not limited to:

4 (a) A grant, loan or contract made by a federal agency, a federally re-
5 cognized Indian tribe or a public body, as defined in ORS 174.109;

6 (b) A grant, loan or contract made by a nonprofit corporation or a limited
7 liability company the sole member of which is a nonprofit corporation;

8 (c) A subsidized loan from a lending institution that makes loans for
9 residential housing; or

10 (d) A subsidized private transaction.

11 (7) "Third-party right of enforcement" means a right provided in an af-
12 fordable housing covenant to a third party to enforce the terms of the
13 covenant.

11 (ii) Political subdivisions, as defined in ORS 271.005.

12 (B) The state agency responsible for selling or transferring the property
13 or the equitable interest may require at the time of the sale or transfer that
14 a political subdivision must use state real property or an equitable interest
15 in real property sold or transferred to the political subdivision for a public
16 purpose or benefit, and that the political subdivision may not resell the real
17 property or the equitable interest to a private purchaser.

18 (c) If a state agency that intends to sell or transfer real property or an
19 equitable interest in real property has not disposed of the real property or
20 the equitable interest under paragraph (a) or (b) of this subsection, the state
21 agency shall cause the real property to be appraised by one or more compe-
22 tent and experienced appraisers in accordance with rules the department
23 adopts. Except as provided in ORS 273.825, if the property has an appraised
24 value exceeding \$5,000, the property or an equitable interest in the property
25 may not be sold to any private person except after notice calling for such
26 proposals as set forth in ORS 270.130.

27 (d) The department shall adopt rules to carry out the provisions of this
28 section.

29 (2) Before a state agency acquires any real property or interest in real
30 property, except for highway right of way that the Department of Transpor-
31 tation acquires, park properties that the State Parks and Recreation De-

1 partment acquires and property within the approved projected campus
2 boundaries for public universities listed in ORS 352.002, the state agency
3 shall report to the Oregon Department of Administrative Services that the
4 state agency intends to acquire the real property or the interest in real
5 property. The department shall notify other state agencies that own land that

7 property to determine whether another state agency desires to sell or trans-
8 fer property that would meet the needs of the acquiring agency. In accord-

11 **OREGON AFFORDABLE HOUSING TAX CREDIT**

12
13 **SECTION 30.** ORS 317.097, as amended by section 25, chapter 83, Oregon
14 Laws 2022, is amended to read:

15 317.097. (1) As used in this section:

16 (a) "Annual rate" means the yearly interest rate specified on the note,
17 and not the annual percentage rate, if any, disclosed to the applicant to
18 comply with the federal Truth in Lending Act.

19 (b) "Bonds" means a bond, as defined in ORS 286A.001, if issued on behalf
20 of the Housing and Community Services Department, or bonds, as defined in
21 ORS 456.055, if issued by a housing authority.

22 (c) "Finance charge" means the total of all interest, loan fees, interest
23 on any loan fees financed by the lending institution, and other charges re-
24 lated to the cost of obtaining credit.

25 (d) "Lending institution" means any insured institution, as that term is
26 defined in ORS 706.008, any mortgage banking company that maintains an
27 office in this state or any community development corporation that is or-
28 ganized under the Oregon Nonprofit Corporation Law.

29 (e) "Manufactured dwelling park" has the meaning given that term in
30 ORS 446.003.

31 (f) "Nonprofit corporation" means a corporation that is exempt from in-

1 come taxes under section 501(c)(3) or (4) of the Internal Revenue Code as
2 amended and in effect on December 31, 2021.

3 (g) "Preservation project" means housing that was previously developed
4 as affordable housing with a contract for rent assistance from the United
5 States Department of Housing and Urban Development or the United States
6 Department of Agriculture and that is being acquired by a sponsoring entity.

7 (h) "Qualified assignee" means any investor participating in the second-
8 ary market for real estate loans.

9 (i) "Qualified borrower" means any borrower that is a sponsoring entity
10 that has a controlling interest in the real property that is financed by a
11 qualified loan. A controlling interest includes a controlling interest in the
12 general partner of a limited partnership that owns the real property.

13 (j) "Qualified loan" means:

14 (A) A loan that meets the criteria stated in subsection (5) of this section
15 or that is made to refinance a loan that meets the criteria described in sub-
16 section (5) of this section; or

17 (B) The purchase by a lending institution of bonds, the proceeds of which
18 are used to finance or refinance a loan that meets the criteria described in
19 subsection (5) of this section.

20 (k) "Sponsoring entity" means a nonprofit corporation, nonprofit cooper-
21 ative, state governmental entity, local unit of government as defined in ORS
22 466.706, housing authority or any other person, provided that the person has
23 agreed to restrictive covenants imposed by a nonprofit corporation, nonprofit
24 cooperative, state governmental entity, local unit of government or housing
25 authority.

26 (2) The Department of Revenue shall allow a credit against taxes other-
27 wise due under this chapter for the tax year to a lending institution that
28 makes a qualified loan certified by the Housing and Community Services
29 Department as provided in subsection (7) of this section. The amount of the
30 credit is equal to the difference between:

31 (a) The amount of finance charge charged by the lending institution dur-

1 ing the tax year at an annual rate less than the market rate for a qualified
2 loan that is made before January 1, 2026, that complies with the require-
3 ments of this section; and

4 (b) The amount of finance charge that would have been charged during
5 the tax year by the lending institution for the qualified loan for housing
6 construction, development, acquisition or rehabilitation measured at the an-
7 nual rate charged by the lending institution for nonsubsidized loans made
8 under like terms and conditions at the time the qualified loan for housing
9 construction, development, acquisition or rehabilitation is made.

10 (3) The maximum amount of credit for the difference between the amounts
11 described in subsection (2)(a) and (b) of this section may not exceed four
12 percent of the average unpaid balance of the qualified loan during the tax
13 year for which the credit is claimed.

14 (4) Any tax credit allowed under this section that is not used by the
15 taxpayer in a particular year may be carried forward and offset against the
16 taxpayer's tax liability for the next succeeding tax year. Any credit remain-
17 ing unused in the next succeeding tax year may be carried forward and used
18 in the second succeeding tax year, and likewise, any credit not used in that
19 second succeeding tax year may be carried forward and used in the third
20 succeeding tax year, and any credit not used in that third succeeding tax
21 year may be carried forward and used in the fourth succeeding tax year, and
22 any credit not used in that fourth succeeding tax year may be carried for-
23 ward and used in the fifth succeeding tax year, but may not be carried for-
24 ward for any tax year thereafter.

25 (5) To be eligible for the tax credit allowable under this section, a lending
26 institution must make a qualified loan by either purchasing bonds, the pro-
27 ceeds of which are used to finance or refinance a loan that meets the criteria
28 stated in this subsection, or making a loan directly to:

29 (a) An individual or individuals who own a dwelling, participate in an
30 owner-occupied community rehabilitation program and are certified by the
31 local government or its designated agent as having an income level when the

1 loan is made of [*less than*] 80 percent of the area median income **or less**;

2 (b) A qualified borrower who:

3 (A) Uses the loan proceeds to finance construction, development, acqui-
4 sition or rehabilitation of housing; and

5 (B) Provides a written certification executed by the Housing and Com-
6 munity Services Department that the:

7 (i) Housing created by the loan is or will be occupied by households
8 earning [*less than*] 80 percent of the area median income **or less**; and

9 (ii) Full amount of savings from the reduced interest rate provided by the
10 lending institution is or will be passed on to the tenants in the form of re-
11 duced housing payments;

12 (c) Subject to subsection (14) of this section, a qualified borrower who:

13 (A) Uses the loan proceeds to finance construction, development, acqui-
14 sition or rehabilitation of housing consisting of a manufactured dwelling
15 park; and

16 (B) Provides a written certification executed by the Housing and Com-
17 munity Services Department that the housing will continue to be operated
18 as a manufactured dwelling park during the period for which the tax credit
19 is allowed;

20 (d) A qualified borrower who:

21 (A) Uses the loan proceeds to finance acquisition or rehabilitation of
22 housing consisting of a preservation project; and

23 (B) Provides a written certification executed by the Housing and Com-
24 munity Services Department that the housing preserved by the loan:

25 (i) Is or will be occupied by households earning [*less than*] 80 percent of
26 the area median income **or less**; and

27 (ii) Is the subject of a rent assistance contract with the United States
28 Department of Housing and Urban Development or the United States De-
29 partment of Agriculture that will be maintained by the qualified borrower;
30 or

31 (e) A qualified borrower who:

1 (A) Uses the loan proceeds to finance construction, development, acqui-
2 sition or rehabilitation of housing; and

3 (B) Provides a written certification executed by the Housing and Com-
4 munity Services Department or the governmental party to the rent assistance
5 contract that the housing preserved by the loan:

6 (i) Is or will be occupied by households earning [*less than*] 80 percent of
7 the area median income **or less**; and

8 (ii) Is the subject of a rent assistance contract with the federal govern-
9 ment or with a state or local government that will be maintained by the
10 qualified borrower and that limits a tenant's rent to no more than 30 percent
11 of their income.

12 (6) A loan made to refinance a loan that meets the criteria stated in
13 subsection (5) of this section must be treated the same as a loan that meets
14 the criteria stated in subsection (5) of this section.

15 (7) For a qualified loan to be eligible for the tax credit allowable under
16 this section, the Housing and Community Services Department must execute
17 a written certification for the qualified loan that:

18 (a) States that the qualified loan is within the limitation imposed by
19 subsection (8) of this section; and

20 (b) Specifies the period, as determined by the Housing and Community
21 Services Department, during which the tax credit is allowed for the qualified
22 loan, not to exceed:

23 (A) 30 years, for a qualified loan with a contract for rent assistance or
24 financing resources from the United States Department of Agriculture, for
25 new housing construction, acquisition of housing or a preservation project;
26 or

27 (B) 20 years, for any other type of qualified loan.

28 (8) The Housing and Community Services Department may certify quali-
29 fied loans that are eligible under subsection (5) of this section if the total
30 credits attributable to all qualified loans eligible for credits under this sec-
31 tion and then outstanding do not exceed \$35 million for any fiscal year. In

1 making loan certifications under subsection (7) of this section, the Housing
2 and Community Services Department shall attempt to distribute the tax
3 credits statewide, but shall concentrate the tax credits in those areas of the
4 state that are determined by the Oregon Housing Stability Council to have
5 the greatest need for affordable housing.

6 (9) The tax credit provided for in this section may be taken whether or
7 not:

8 (a) The financial institution is eligible to take a federal income tax credit
9 under section 42 of the Internal Revenue Code with respect to the project
10 financed by the qualified loan; or

11 (b) The project receives financing from bonds, the interest on which is
12 exempt from federal taxation under section 103 of the Internal Revenue Code.

13 (10) For a qualified loan defined in subsection (1)(j)(B) of this section fi-
14 nanced through the purchase of bonds, the interest of which is exempt from
15 federal taxation under section 103 of the Internal Revenue Code, the amount
16 of finance charge that would have been charged under subsection (2)(b) of
17 this section is determined by reference to the finance charge that would have
18 been charged if the federally tax exempt bonds had been issued and the tax
19 credit under this section did not apply.

20 (11) A lending institution may sell a qualified loan for which a certifica-
21 tion has been executed to a qualified assignee whether or not the lending
22 institution retains servicing of the qualified loan so long as a designated
23 lending institution maintains records, annually verified by a loan servicer,
24 that establish the amount of tax credit earned by the taxpayer throughout
25 each year of eligibility.

26 (12) Notwithstanding any other provision of law, a lending institution
27 that is a community development corporation organized under the Oregon
28 Nonprofit Corporation Law may transfer all or part of a tax credit allowed
29 under this section to one or more other lending institutions that are stock-
30 holders or members of the community development corporation or that oth-
31 erwise participate through the community development corporation in the

1 making of one or more qualified loans for which the tax credit under this
2 section is allowed.

3 (13) The lending institution shall file an annual statement with the
4 Housing and Community Services Department, specifying that it has con-
5 formed with all requirements imposed by law to qualify for a tax credit under
6 this section.

7 (14) Notwithstanding subsection (1)(i) and (k) of this section, a qualified
8 borrower on a loan to finance the construction, development, acquisition or
9 rehabilitation of a manufactured dwelling park under subsection (5)(c) of this
10 section must be:

11 (a) A nonprofit corporation, manufactured dwelling park nonprofit coop-
12 erative, state governmental entity, local unit of government as defined in
13 ORS 466.706 or housing authority; or

14 (b) A nonprofit corporation or housing authority that has a controlling
15 interest in the real property that is financed by a qualified loan. A control-
16 ling interest includes a controlling interest in the general partner of a lim-
17 ited partnership that owns the real property.

18 (15) The Department of Revenue may require that a lending institution
19 that has earned the credit and a lending institution that intends to claim the
20 credit jointly file a notice, as prescribed by the Department of Revenue. The
21 notice must comply with ORS 315.056 (2) or 315.058 (2).

22 (16) The Housing and Community Services Department shall provide in-
23 formation to the Department of Revenue about all certifications executed
24 under this section, if required by ORS 315.058.

25 (17) The Housing and Community Services Department and the Depart-
26 ment of Revenue may adopt rules to carry out the provisions of this section.
