SUMMARY

Transfers Public Defense Services Commission from judicial to executive branch. Modifies appointment and removal process for and qualifications of commission members. Directs commission to designate liaison with office of public defense services and appoint juvenile services director.

Modifies duties of public defense services executive director. Requires director to establish specific divisions within office of public defense services. Requires that trial division provide 25 percent of trial-level public defense services by January 1, 2030, and 35 percent by January 1, 2035.

Directs commission and public defense services executive director to report annually to interim committees of Legislative Assembly on progress with implementing Act.

Takes effect on 91st day following adjournment sine die.

2 Relating to public defense; creating new provisions; amending ORS 151.211,

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 151.211 is amended to read:

6 151.211. For purposes of ORS 151.211 to 151.221:

7 (1) "Bar member" means an individual who is an active member of the8 Oregon State Bar.

9 [(2) "Chief Justice" means the Chief Justice of the Supreme Court.]

10 [(3)] (2) "Commission" means the Public Defense Services Commission.

11 [(4)] (3) "Director" means the public defense services executive director 12 appointed under ORS 151.216.

13 [(5)] (4) "Office of public defense services" means the office established 14 by the commission under the director to handle the cases assigned and to carry out the administrative policies and procedures for the public defense
 system.

3 **SECTION 2.** ORS 151.213 is amended to read:

4 151.213. (1) The Public Defense Services Commission is established in the 5 [judicial] **executive** branch of state government. Except for the appointment 6 or removal of commission members, the commission and employees of the 7 commission are not subject to the exercise of administrative authority and 8 supervision by the [Chief Justice of the Supreme Court as the administrative 9 head of the Judicial Department] **Governor**.

(2)(a) The commission consists of nine members appointed [by order of the 10 Chief Justice. In addition to the nine appointed members, the Chief Justice 11 serves as a nonvoting, ex officio member. The Chief Justice shall appoint at 12least three persons who are not bar members, at least one person who was 13 formerly engaged in the provision of public defense services and at least one 14 person who has been formerly represented by a public defense provider in this 15state. All members must have a demonstrated record of commitment to public 16 defense. Except for the Chief Justice or a senior judge under ORS 1.300, a 17member may not serve concurrently as a judge, a prosecuting attorney or an 18 employee of a law enforcement agency. A person who is primarily engaged in 19 providing public defense services may not serve as a member of the 20commission.] as follows: 21

22 (A) The Governor shall appoint three members.

(B) The Governor shall appoint three members from among persons
 recommended by the Chief Justice of the Supreme Court.

(C) The Governor shall appoint three members from among persons
 jointly recommended by the President of the Senate and the Speaker
 of the House of Representatives.

(b) All members must have a demonstrated record of commitment
to public defense.

30 (c) At least one member must be a person who has been formerly
 31 represented by a public defense provider.

1 (d) At least one member must be a member of the public with no 2 formal legal training.

3 (e) A member may not serve concurrently as a judge, a member of
4 the Legislative Assembly, a prosecuting attorney or an employee of a
5 law enforcement agency.

6 (f) A person who is primarily engaged in providing public defense 7 services may not serve as a member of the commission.

(3) The term of a member is four years beginning on the *[effective date* 8 of the order of the Chief Justice appointing the member] date of the ap-9 pointment. A member is eligible for reappointment if qualified for member-10 ship at the time of reappointment. [A member may be removed from the 11 12commission by order of the Chief Justice.] The Governor may remove a member of the commission at any time for cause. If a vacancy occurs 13 for any cause before the expiration of the term of a member, the [Chief 14 Justice] Governor shall make an appointment to become immediately effec-15tive for the unexpired term. 16

(4) A chairperson and a vice chairperson shall be appointed by [order of
the Chief Justice] the Governor every two years with such functions as the
commission may determine. A member is eligible for reappointment as
chairperson or vice chairperson.

(5) The commission may hire staff and shall designate one or more staff members to serve as the liaison between the commission and the office of public defense services established under ORS 151.216. The liaison shall be tasked with other duties as determined by the commission.

[(5)] (6) A majority of the [*voting*] members constitutes a quorum for the transaction of business.

[(6)] (7) A member of the commission is not entitled to compensation for services as a member, but is entitled to expenses as provided in ORS 292.495 (2).

31 **SECTION 3.** ORS 151.216 is amended to read:

1 151.216. (1) The Public Defense Services Commission shall:

(a) Establish and maintain a public defense system that ensures the provision of public defense services consistent with the Oregon Constitution, the
United States Constitution and Oregon and national standards of justice.

5 (b) Establish an office of public defense services and, by a two-thirds 6 vote of the commission, appoint a public defense services executive direc-7 tor and a juvenile services director who [serves] serve at the pleasure of 8 the commission.

 national and regional best practices;

(d) Establish operational and contracting systems that allow for oversight, ensure transparency and stakeholder engagement and promote equity,
inclusion and culturally specific representation.

(e) Review the caseload policies described in paragraph (c)(A) of this subsection annually, and revise the policies as necessary and at least every four years.

(f) Adopt a statewide workload plan, based on the caseload policies described in paragraph (c)(A) of this subsection, that takes into account the needs of each county or jurisdiction, practice structure and type of practice overseen by the office of public defense services.

(g) Submit the budget of the commission and the office of public defense services to the Legislative Assembly after the budget is submitted to the commission by the **public defense services executive** director and approved by the commission. The [*Chief Justice of the Supreme Court and the*] chairperson of the commission shall present the budget to the Legislative Assembly.

7 (h) Review and approve:

(A) Any public defense services contract negotiated by the director before
the contract can become effective; and

(B) Annually the standard operating expectations for contracted
 entities developed by the director.

(i) Adopt a compensation plan, classification system and personnel plan
 for the office of public defense services that are commensurate with other
 state agencies.

15 (j) Adopt policies, procedures, standards and guidelines regarding:

(A) The determination of financial eligibility of persons entitled to be
 represented by appointed counsel at state expense;

(B) The appointment of counsel, including the appointment of counsel at

(E) Any other costs associated with the representation of a person by appointed counsel in the state courts that are required to be paid by the state under ORS 34.355, 135.055, 138.500, 138.590, 161.346, 161.348, 161.365, 419A.211, 419B.201, 419B.208, 419B.518, 419B.908, 419C.206, 419C.209, 419C.408, 419C.535, 426.100, 426.135, 426.250, 426.307, 427.265, 427.295, 436.265 or 436.315 or any other provision of law that expressly provides for payment of such compensation, costs or expenses by the commission;

(J) Any other matters necessary to carry out the duties of the commission.
(k) Establish a peer review system for the approval of nonroutine fees and
expenses incurred in cases involving aggravated murder and the crimes listed
in ORS 137.700 and 137.707. The review shall be conducted by a panel of attorneys who practice in the area of criminal defense.

12 (L) Establish a complaint process that allows district attorneys, criminal 13 defense counsel and the public to file complaints concerning the payment 14 from public funds of nonroutine fees and expenses incurred in cases.

(m) Reimburse the State Court Administrator from funds deposited in the Public Defense Services Account established by ORS 151.225 for the costs of personnel and other costs associated with location of eligibility verification and screening personnel pursuant to ORS 151.489 by the State Court Administrator.

(2) The commission may advocate for or against legislation upon the agreement of a majority of the members of the commission.

[(2)] (3) Policies, procedures, standards and guidelines adopted by the commission supersede any conflicting rules, policies or procedures of the Public Defender Committee, State Court Administrator, circuit courts, the Court of Appeals, the Supreme Court and the Psychiatric Security Review Board related to the exercise of the commission's administrative responsibilities under this section and transferred duties, functions and powers as they occur.

[(3)] (4) The commission may accept gifts, grants or contributions from any source, whether public or private. However, the commission may not accept a gift, grant or contribution if acceptance would create a conflict of

interest. Moneys accepted under this subsection shall be deposited in the
 Public Defense Services Account established by ORS 151.225 and expended

(c) Interfere with the director or any member of the staff of the director

<u>SECTION 7.</u> Beginning no later than January 1, 2025, and annually thereafter, the chairperson of the Public Defense Services Commission and the public defense services executive director shall report to the interim committees of the Legislative Assembly related to the judiciary, in the manner provided in ORS 192.245, regarding the progress made with respect to:

(1) Transferring trial-level public defense services within this state
 from contracted entities to the trial division of the office of public
 defense services; and

(2) Implementing all other provisions of the amendments to ORS
14 151.211, 151.213, 151.216 and 151.219 by sections 1 to 6 of this 2023 Act.

15 <u>SECTION 8.</u> (1) A person who is a member of the Public Defense 16 Services Commission on the operative date specified in section 10 (1) 17 of this 2023 Act shall remain a member of the commission until the 18 end of the person's term, subject to removal by the Governor for cause 19 as described in ORS 151.213 (3).

<u>SECTION 10.</u> (1) Sections 7 and 8 of this 2023 Act and the amendments to ORS 151.211, 151.213, 151.216 and 151.219 by sections 1 to 4 of this 2023 Act become operative on January 1, 2024.

(2) The Public Defense Services Commission, the Judicial Depart-4 ment and the office of the Governor may take any action before the 5operative date specified in subsection (1) of this section that is neces-6 sary to enable the commission, department or office to exercise, on 7 and after the operative date specified in subsection (1) of this section, 8 all of the duties, functions and powers conferred on the commission, 9 department or office by sections 7 and 8 of this 2023 Act and the 10 amendments to ORS 151.211, 151.213, 151.216 and 151.219 by sections 1 11 12to 4 of this 2023 Act.

(3)(a) The amendments to ORS 151.219 by section 5 of this 2023 Act
become operative on January 1, 2030.

(b) The amendments to ORS 151.219 by section 6 of this 2023 Act

(4) The Public Defense Services Commission may take any action before the operative dates specified in subsection (3) of this section that is necessary to enable the commission to exercise, on and after the operative dates specified in subsection (3) of this section, all of the duties, functions and powers conferred on the commission by the amendments to ORS 151.219 by sections 5 and 6 of this 2023 Act.

23 <u>SECTION 11.</u> This 2023 Act takes effect on the 91st day after the 24 date on which the 2023 regular session of the Eighty-second Legislative 25 Assembly adjourns sine die.
