The Strategic Investment Program

- A 15-year property tax exemption for certain capital investments
- The exemption applies to Real Market Value above a threshold
 - For urban projects, the threshold is \$100 million
 - For rural projects, the exemption depends on the investment amount
 - If < \$500M, the threshold is \$25M
 - If between \$500M and \$1B, the threshold is \$50M
 - If > \$1B, the threshold is \$100M
- Community service fees (negotiated) go to local governments

Original Policy

- Created in 2007 to share marginal income tax gains with local governments
- For property tax exemptions beginning in 2008
- 50% of identified personal income taxes would be sent to local taxing districts
 - Effective for 2009 to 2018
- Businesses submit annual report to OBDD
 - Assessed value of taxable and exempt property tax payments/savings
 - Average number of hires/employed for each eligible project
 - Annual taxable income and total compensation of qualifying hires/employee
 - Jobs data numbers and amounts
- DAS is required to determine/estimate taxes and transfer funds





2013 and 2015 Policy Changes

- Technical changes/clarification (e.g., report deadlines, transfer and reporting responsibilities)
- Distinguishes between new jobs and retained jobs
 - 50% of identified personal income taxes for new jobs
 - 20% of identified personal income taxes for retained jobs
- Create a cap of \$16 million for transfers to an individual county
- Extends distributions through July 15, 2024
- DOR distributes funds to counties, who then distribute funds to taxing districts
 - Consistent with the distribution of community service fees
- 2022 Session: Extended through July 15, 2025




Total Transfer Amounts (\$M) (and Washington County share)
