## **Oregon E-Cycles**

- Statewide program
- Requires electronics manufacturers to provide responsible recycling for computers, monitors, TVs, printers, keyboard and mice.
- Since 2009, collected over 300 million pounds

# Why Modernize?

- Limited list of covered devices
- Cumbersome administration
- Potential instability to collection network






#### 2022 Network Instability Issue

- Current collection network:
  - Baseline of one site per county and per city with population 10,000 or above
  - More sites as needed to meet collections goals (If goals met, sites can be removed)
- Issue was topic of legislation in 2022



## Workgroup Process: Jul. 2022 – Jan. 2023

- Five public workshops
- Numerous smaller group meetings
- Input from Industry, PROs, Collectors, Recyclers, Local Governments, and more





#### HB 3220A: What Stays the Same

- Manufacturers' obligation to finance and manage E-Cycles
- DEQ oversight of program
- Oregon's access to convenient and free electronics recycling

#### **HB 3220A: Streamlines Administration**

- Eliminates the State Contractor Program
- Allows for one or more PROs
- Requires coordination if multiple PROs exist



#### **HB 3220A: Stabilizes Collection Network**

- Sets a robust convenience standard
- Network must include:
  - 95% of residents within 15 miles of a collection site
  - Number of sites in cities with 10,000+ increases with population density
  - Any willing permitted transfer station, landfill or material recovery facility can be a collection site



# HB 3220A: Advances Equity and Reuse

#### **Equity:**

- Program must provide convenient and equitable service
- Requires engagement with historically underserved populations

#### Reuse:

- PRO must coordinate activities with recycling and reuse programs
- Collection sites can recover devices for reuse



# HB 3220A: Overall Impact
