Re: Environmental Defense Fund's support for HB 3124

Chair Helm, Vice-Chair Hartman, Vice-Chair Owens, and Members of the Committee,

Environmental Defense Fund (EDF) supports HB 3124, the Bipartisan Drought Relief and Water Security Package (BiDRAWS).

EDF is a non-profit that utilizes policy, management, science, and data to help build balanced, climate resilient water systems that ensure long-term water security for communities and the environment.

The components of BiDRAWS identified below would improve Oregon's ability to manage both ground and surface water in the face of climate change and drought, better measure and account for water across all uses, increase coordination with Tribal Nations, engage communities that have historically been marginalized, leverage federal and state funding to improve flow and passage conditions for critical fish populations, and focus resources in basins that have undertaken robust planning processes, such as the Deschutes and Harney basins.

- 1-3: Community Funding and Agency Capacity for Place-Based Integrated Water Resources Planning. \$3,850,000
