The LFO recommended 2023-25 budget for the Secretary of State is \$111,716,131 total funds and 240 positions (239.50 FTE), including \$17,648,792 General Fund, \$89,044,692 Other Funds, and \$5,022,647 Federal Funds, which represents a 2.3% increase over the 2021-23 legislatively approved budget. The Secretary of State is Oregon's chief elections officer, auditor of public funds, maintainer of the state's business registrations, and keeper of public records.

The recommended budget includes the following significant adjustments:

- \$1.1 million General Fund for elections improvements, including adding positions to address election complaints, improve security and monitor election threats. Funding was also added to conduct a pilot of risk limiting audits and provide factual information relating to elections.
- \$3.1 million Other Funds and five positions are added for Information Technology expenditures related to improving security, modernization of custom-built legacy systems and management of agency IT assets.

 \$1.2 million Other Funds was added to continue work preserving recordings of legislative hearings and complete the conversion to compact shelving at the Archives Building.

Package 110 Archivists

Package Description Adds two permanent Archivist 1 positions (2.00 FTE) to convert fifty years' worth of legislative recordings that are at risk of being irretrievably lost. Legislative committee hearings dating from 1957 to 2007 were recorded using propriety technology and inherently unstable media, including Sawyer Rols, reel-to-reel tapes and audiocassette tapes. Long-term access to these records is at risk due to the inevitable degradation of the media and the obsolescence of hardware needed to play the recordings. Digitized records will be available online for easy access by those interested. These positions were approved as limited-duration positions for the 2021-23 biennium.
