Attached are the recommendations from the Legislative Fiscal Office for the Criminal Justice Commission. The recommended budget represents a 45.1% increase from the current service level budget. The budget includes funding for grants approved by the Emergency Board and grant programs that received funding in the 2021-23 legislatively approved budget that will carry forward into 2023-25. The budget also includes the continuation of funding for the Justice Reinvestment Grant Program, assumed through passage of SB 344, which extends the statutory sunset on this program from July 1, 2024, to July 1, 2033. The budget is \$106.9 million total funds and 27 positions (27.00 FTE). General Fund in the budget is \$77.4 million and represents a 53.5% increase from current service level.

Package 083 December E-Board 2022

<u>Package Description</u> This package provides Federal expenditure limitation and position authority approved by Emergency Board action in December 2022 for grants received by the agency.

The Emergency Board approved an increase in Federal Funds expenditure limitation of \$909,346 and a limited duration Program Analyst 3 position to the Criminal Justice Commission, for the Prison Rape Elimination Act (PREA) Standards grant and the Justice Counts Implementation grant. This package provides the anticipated Federal Funds expenditure limitation necessary for the continuation of these two grants and the position authority into 2023-25. Of the total provided, \$174,741 is for the PREA Standards grant and will be passed through to the Department of Corrections. The remaining funding is \$312,754 for the full-time limited duration Program Analyst 3 position (1.00 FTE), and \$375,274 for the Justice Counts Implementation grant.

Package 103 Justice Reinvestment Initiative

Package Description This package appropriates \$26,962,315 General Funds to continue the Justice Reinvestment Grant Program (JRI). JRI provides funding for counties to plan, implement and expand initiatives that provide a continuum of community-based responses to criminal offenses with the goal of reducing the prison population and funding evidence-based programs that reduce recidivism, promote successful re-entry of former offenders into their communities, and increase public safety. Under current law, the JRI program has a sunset date of June 30, 2024. The General Fund provided in this package includes the amount necessary to continue the current service level funding for this program into the second year of the 2023-25 biennium, and assumes passage of SB 344, which extends the programs sunset until July 1, 2033. The adult corrections population forecasts provided by the Office of Economic Analysis assume extension of the Justice Reinvestment Initiatives.

Package 801 LFO Analyst Adjustments

<u>Package Description</u> This package includes \$3,127,544 Federal Funds expenditure limitation and position authority for a full-time limited duration Program Analyst 3 position (1.00 FTE) for the State Crisis Intervention Program grant, which is a formula grant provided by the Bureau of Justice Assistance to support efforts to reduce crime and gun violence. The Commission received approval to apply for this grant at the December 2022 Emergency Board.

Additionally, this package includes \$2,255,940 Other Funds expenditure limitation for the carry forward of grant funding that was provided in the 2021-23 biennium. This includes \$210,617 for the IMPACTS program, \$241,954 for the STOP program, \$635,736 for the Illegal Marijuana Market Enforcement Grant program, \$167,831 for the asset forfeiture program, and \$999,802 for the Innovative Grant program.
