Subject: SB 5542 – Relating to Department of Public Safety Standards and

Training Fee Ratification

Work Session Recommendations

SB 5542 is the fee ratification bill for the Department of Public Safety Standards and Trainings (DPSST). The bill, as amended by the -2, provides the enabling legislation necessary to ratify fees adopted through administrative rule hearings and approved by the Department of Administrative Services during the 2021-23 biennium. Statute requires all new agency fees or fee increases adopted between regular sessions of the Legislative Assembly be authorized by enabling legislation or rescinded upon adjournment of the next regular session.

ORS 181A.870 allows the Board on Public Safety Standards and Training to establish fees for issuing certifications and licenses to private security providers. The most recent change to these fees was 2011 when some fees were reduced, and some date back to 2005. The Board administratively increased the following fees:

DPSST anticipates the fee increases will generate approximately \$2 million of Other Funds revenue during the 2023-25 biennium based on the most recent 12-month average of licenses and certifications. However, this revenue will not be sufficient to operate the

program and the Department will need to return to the Legislature in 2024 with further increases for the Private Security Professionals Program in addition to the fee establishment for Private Security Entities authorized in HB 2527 (2021) to adequately fund this program.

Recommended Changes
