BACKGROUND:

A fundamental tenet of American society is that the success and vitality of democratic government is directly dependent on the full and active participation of its citizens. Civic education encompasses knowledge and understanding of basic principles of Oregon and U.S. government, community process, and active participation in the life of the community through voting, volunteerism, and awareness of current community issues.

Each new generation must learn and experience what it means to live in a constitutional democracy, and Oregon’s classrooms play a crucial role in preparing students for active civic participation in government. The Legislative Assembly has previously recognized the critical importance of civic education through the establishment of Oregon Civics Day for Teachers and the passage of the Civics Education Act.

The Classroom Law Project provides engaging, standards-based, and interactive civic education programs for students throughout the State of Oregon, including: We the People Constitution Team classroom content and annual competitions; Mock Trial classroom programs and annual competitions; Courthouse Experience Tours, which provide direct access to the judicial process; Weekly Current Events, highlighting crucial issues of the day and tools for teaching them; Community Action Projects that allow students to consider issues in their communities and engage with stakeholders on possible solutions; and numerous other classroom and field opportunities for students to learn about their roles, opportunities, and responsibilities as active members of their communities.

The Classroom Law Project provides quality professional development for teachers through the annual Oregon Civics Conference for Teachers in collaboration with the Legislative Assembly and the state Department of Education, the annual Summer Institute, and ongoing workshops, seminars, classroom visits, and one-on-one

consultations. The Classroom Law Project reaches thousands of students and teachers in every part of Oregon each year, including 1,192 teachers and 119,987 students in the 2021-2022 school year.

It is a recognized and trusted partner for the state Department of Education as well as schools, school districts, education service districts, and graduate programs of education throughout this state.
