Summary of Revenue Changes

House Bill 2294 appropriates \$5.0 million General Fund to the Bureau of Labor and Industries (BOLI) to develop and administer a grant program for up to 10 pilot projects for firefighter apprenticeship programs.

Summary of Transportation and Economic Development Subcommittee Action

House Bill 2294 directs BOLI to develop and administer a grant program for up to 10 pilot projects for firefighter apprenticeship programs. The projects must provide on-the-job training and education and also collaborate with associations representing fire service professionals. The bill requires BOLI to submit a report to the Legislative Assembly no later than December 31, 2026. House Bill 2294 sunsets on January 1, 2027.

The Subcommittee recommended a \$5.0 million General Fund appropriation and the establishment of one limited duration Grants and Loans Program Manager position (0.88 FTE) for the program.
