**Summary of Revenue Change**

House Bill 3001 provides \$25,000 Other Funds expenditure limitation to the Oregon Department of Transportation (ODOT) to cover the costs of Fallen Hero roadside memorial signs and veterans’ recognition registration plates.

**Summary of Transportation and Economic Development Subcommittee Action**

House Bill 3001 directs ODOT to waive fees for a Fallen Hero roadside memorial highway sign if the applicant is Gold Star Family member.

The bill will provide \$25,000 Other Funds expenditure limitation to the Oregon Department of Transportation (ODOT) to cover the cost of Fallen Hero roadside memorial signs and veterans’ recognition registration plates. These funds would cover the costs of placing the signs for Gold Star Family Members only and cover the surcharge for Gold Star Family members’ recognition plates. Of the funding, \$20,000 Other Funds is designated for sign placement expenses and \$5,000 Other Funds is designated to cover the registration plate surcharge. ODOT anticipates the funds would cover the placement of 20 signs and any placements over that number may require additional funding. The Transportation Operating Fund will fund this ongoing directive since the State Highway Fund cannot be utilized for these services.
