SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes Oregon Housing Needs Analysis in Oregon Department of Administrative Services. Requires cities outside Metro to plan for housing needs as allocated by analysis. Requires Metro to adopt similar methodology to allocate housing needs to cities within Metro. Requires Housing and Community Services Department to develop housing production dashboard and housing equity indicators.

Allows Department of Land Conservation and Development to audit, and to enter into housing acceleration agreement with, certain cities that are not adopting or implementing housing production strategies or that are lowest performing as measured by dashboard and indicators. Allows department to seek, and Land Conservation and Development Commission to issue, specific enforcement orders for certain continued noncompliance by cities in addressing housing. Amends land use requirements for local governments related to urbanization, including by requiring cities to measure and plan for development-ready lands, requiring Metro to adopt housing coordination strategy and allowing cities outside of Metro to adopt rural reserves. Requires commission to adopt or amend implementing rules.

Modifies emergency housing assistance program and state homeless assistance program to provide services and assistance to school-aged children experiencing or at risk of experiencing homelessness. Modifies eligibility requirements for applicants for grants from homeless youth services enhancement program and host home project program. Makes programs permanent.

Requires Housing and Community Services Department to provide grants or loans for modular housing and components. Sunsets January 2, 2026.

Requires Oregon Facilities Authority to provide financing for infrastructure and predevelopment costs for moderate income housing. Sunsets January 2, 2026.

Requires residential landlords to extend notice periods for terminations of tenancy based on nonpayment of rent and to include additional notices. Requires landlords and clerk to also include notice with summons for nonpayment of rent. Postpones dates for first appearance and trial for evictions based on such termination notices. Requires landlord to attest to belief that tenant who is absent at first appearance remains in possession of premises before default eviction judgment.

Requires public bodies and grantees to inform tenants and landlords regarding rental assistance applications.

Requires courts to annually set aside and seal certain inoperative residential eviction judgments.

Requires State Department of Agriculture to provide grants to improve certain existing agriculture workforce housing. Sunsets January 2, 2026.

Allows certain moneys appropriated to Housing and Community Services Department for use in Oregon Balance of State Continuum of Care to be spent under emergency procurement authority.

Appropriates moneys from General Fund to Housing and Community Services Department, Oregon Department of Administrative Services, Land Conservation and Development Commission, Oregon Facilities Authority and State Department of Agriculture for purposes of Act.

Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

7 **OREGON HOUSING NEEDS ANALYSIS**

8
9 **SECTION 1.** (1) **There is established within the Oregon Department of Administrative**
10 **Services the Oregon Housing Needs Analysis. The purposes of the Oregon Housing Needs**
11 **Analysis are to further the:**

12 (a) **Production of housing to meet the need of Oregonians at all levels of affordability;**
13 **and**

14 (b) **Production of housing in a way that creates more housing choice by affirmatively**
15 **furthering fair housing, as defined in ORS 197.290.**

16 (2) **The Oregon Housing Needs Analysis consists of three components as follows:**

17 (a) **The annual statewide housing analysis under section 2 (1) of this 2023 Act;**

18 (b) **The allocated housing need under section 2 (2) of this 2023 Act; and**

19 (c) **The housing production targets under section 3 of this 2023 Act.**

20 (3) **Actions taken by the department under sections 1 to 3 of this 2023 Act are not subject**
21 **to ORS 197.180 and are not land use decisions.**

22 (4) **The Department of Land Conservation and Development and the Housing and Com-**
23 **munity Services Department:**

24 (a) **Shall assist the Oregon Department of Administrative Services with its duties under**
25 **sections 1 to 3 of this 2023 Act.**

26 (b) **May study and recommend methodological changes to the Oregon Department of**
27 **Administrative Services to improve the Oregon Housing Needs Analysis' functions and suit-**
28 **ability for its purposes under subsection (1) of this section. The departments may solicit**
29 **written and oral public testimony to inform their recommendations.**

30 **SECTION 2.** (1) **On an annual basis the Oregon Department of Administrative Services**
31 **shall conduct a statewide housing analysis. The analysis must be conducted statewide and**
32 **segmented into regions as determined by the department. The analysis shall estimate factors**
33 **including, but not limited to:**

34 (a) **Projected needed housing units over the next 20 years;**

35 (b) **Current housing underproduction;**

36 (c) **Housing units needed for people experiencing homelessness; and**

37 (d) **Housing units projected to be converted into vacation homes or second homes during**
38 **the next 20 years.**

39 (2) **At the time the department performs the housing analysis under subsection (1) of this**
40 **section, the department shall allocate a housing need for each city.**

41 (3) **In making an allocation under subsection (2) of this section, the department shall**
42 **consider:**

43 (a) **The forecasted population growth under ORS 195.033 or 195.036;**

44 (b) **The forecasted regional job growth;**

45 (c) **An equitable statewide distribution of housing for income levels described in sub-**

1 section (4) of this section;

2 (d) The estimates made under subsection (1) of this section; and

3 (e) The purpose of the Oregon Housing Needs Analysis under section 1 (1) of this 2023
4 Act.

5 (4) In estimating and allocating housing need under this section, the department shall
6 segment need by the following income levels:

7 (a) Housing affordable to households making less than 30 percent of median family in-
8 come;

9 (b) Housing affordable to households making 30 percent or more and less than 60 percent
10 of median family income;

11 (c) Housing affordable to households making 60 percent or more and less than 80 percent
12 of median family income;

13 (d) Housing affordable to households making 80 percent or more and less than 120 per-
14 cent of median family income; and

15 (e) Housing affordable to households making 120 percent or more of median family in-
16 come.

17 **SECTION 3.** (1) The Oregon Department of Administrative Services shall allocate housing
18 production targets to each city with a population of 10,000 or greater and to each
19 unincorporated urbanized area within the Metro urban growth boundary. Housing production
20 targets shall describe the proportion of the allocated housing need that the department de-
21 termines should be produced in each city within six years for a city or urbanized area inside
22 Metro and within eight years for a city or urbanized area outside Metro.

23 (2) The housing production targets must be separated into:

24 (a) A total target; and

25 (b) A target for publicly supported housing affordable to households making less than 80
26 percent of the median family income.

27 (3) In establishing housing production targets under this section, the department:

28 (a) May include a greater proportion of the allocated housing need to accommodate peo-
29 ple experiencing homelessness and housing underproduction within a city;

30 (b) Is not required to consider allocation of needed housing by Metro under ORS 197.296
31 or 197.303; and

32 (c) Shall coordinate the allocation of the targets with a schedule developed by the De-
33 partment of Land Conservation and Development for requiring housing production strategies
34 under ORS 197.290.

35 **SECTION 4.** (1) The Housing and Community Services Department may adopt rules to
36 implement this section and section 5 of this 2023 Act.

37 (2) On an annual basis the Housing and Community Services Department shall update a
38 publicly available statewide housing production dashboard.

39 (3) The dashboard shall include, for each city with a population of 10,000 or greater:

40 (a) Progress toward housing production by affordability levels, as described in section 2
41 (4) of this 2023 Act and total housing targets; and

42 (b) A comparative analysis of progress in comparison to the region and other local gov-
43 ernments with similar market types.

44 (4) Information in the dashboard must be based on:

45 (a) Inventory of publicly supported housing, as defined in ORS 456.250, that is maintained

1 by the department; and

2 (b) Information submitted to the department under section 37 (3) of this 2023 Act.

3 **SECTION 5.** (1) On an annual basis the Housing and Community Services Department
4 shall update publicly available statewide housing equity indicators.

5 (2) The indicators shall include, for each city, quantifiable data, to the extent that the
6 department can determine, define or estimate it, displaying:

7 (a) Housing outcomes, such as cost burden and availability of housing units to own or to
8 rent, and housing condition for various demographics, including race or ethnicity, disability
9 status, English proficiency and age;

10 (b) Housing types produced and overall land efficiency of housing production;

11 (c) New housing units built to standards, as defined by the Department of Consumer and
12 Business Services by rule, relating to accessibility and visitability;

13 (d) Risk of gentrification and displacement;

14 (e) Housing segregation by race and income;

15 (f) Environmentally just housing outcomes, informed by the environmental justice map-
16 ping tool, developed by the Environmental Justice Council under section 12, chapter 58,
17 Oregon Laws 2022;

18 (g) Residential tenants who spend more than 50 percent of their household income on
19 gross rent for housing; and

20 (h) Other measurable factors or indicators identified by the department.

21 **SECTION 6.** (1) No later than March 1, 2024, the Department of Land Conservation and
22 Development shall adopt a housing production target schedule under section 3 (3)(c) of this
23 2023 Act.

24 (2) No later than January 1, 2025, the Oregon Department of Administrative Services
25 shall:

26 (a) Conduct the initial statewide housing analysis and the initial estimate and allocation
27 of housing need under section 2 of this 2023 Act.

28 (b) Establish the initial housing production targets under section 3 of this 2023 Act.

29 (3) No later than January 1, 2025, the Housing and Community Services Department
30 shall:

31 (a) Publish the statewide housing production dashboard under section 4 of this 2023 Act;
32 and

33 (b) Publish statewide housing equity indicators under section 5 of this 2023 Act.

34 (4) The schedule adopted by the Department of Land Conservation and Development un-
35 der subsection (1) of this section is not a land use decisions and is not subject to appeal.

36 **SECTION 7.** In addition to and not in lieu of any other appropriation, there is appropri-
37 ated to the Housing and Community Services Department, for the biennium beginning July
38 1, 2023, out of the General Fund, the amount of \$1,202,432, to perform the duties of the de-
39 partment under sections 1 to 5 of this 2023 Act.

40 **SECTION 7a.** Notwithstanding any other law limiting expenditures, the amount of
41 \$143,969 is established for the biennium beginning July 1, 2023, as the maximum limit for
42 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts
43 and federal funds received from charges, but excluding lottery funds and federal funds not
44 described in this section, collected or received by the Oregon Department of Administrative
45 Services, for the Chief Operating Office, to perform the duties of the department under

1 sections 1 to 5 of this 2023 Act.

3 **URBANIZATION GENERALLY**
4

5 **SECTION 8.** (1) In adopting rules under ORS 197.286 to 197.314 and statewide planning
6 goals relating to housing or urbanization, or administering the rules or statutes, the Land
7 Conservation and Development Commission and Department of Land Conservation and De-
8 velopment shall be guided by the following principles:

9 (a) Housing that is safe, accessible and affordable in the community of their choice
10 should be available to every Oregonian.

11 (b) Building enough equitable housing must be a top priority.

12 (c) The development and implementation of the housing production strategy should be
13 the focal point by which the department collaborates with local governments to address and
14 eliminate local barriers to housing production.

15 (d) Expertise, technical assistance, model ordinances and other tools and resources to
16 address housing production should be provided to local governments, using cooperative
17 planning tools embodied in ORS 197.291 and 197.293, but not to the exclusion of the expedient
18 use of enforcement authority, including compliance orders under ORS 197.319 to 197.335.

19 (e) Housing production should support fair and equitable housing outcomes, environ-
20 mental justice, climate resilience and access to opportunity.

21 (f) Housing production should not be undermined by litigation, regulatory uncertainty or
22 repetitive or unnecessary procedures.

23 (g) Local governments, to the greatest extent possible, should take actions within their
24 control to facilitate the production of housing to meet housing production targets under
25 section 3 of this 2023 Act.

26 (2) Each public body, as defined in ORS 174.109, shall use its authority to remove barriers
27 to, and to create pathways for, the development of needed housing and shall collaborate with
28 the department and local governments to identify and implement strategies to support
29 housing production where there is insufficient housing production and choice.

30 (3) In adopting rules implementing ORS 197.286 to 197.314 and statewide land use goals
31 relating to housing and urbanization, the commission may approve a range of methodologies,
32 policy options or assumptions that a local government may adopt in determining:

33 (a) Needed housing;

34 (b) Housing production strategies or housing coordination strategies;

35 (c) Buildable lands or housing capacity;

36 (d) Amendments to urban growth boundaries, including under ORS 197.296 (6)(a), 197.299,
37 197.764 and 197A.300 to 197A.325 and section 22 (5)(a) of this 2023 Act; or

38 (e) Adoption or amendments to urban reserves or rural reserves under ORS 195.137 to
39 195.145.

40 **SECTION 9.** (1) The Land Conservation and Development Commission shall adopt rules
41 and amendments to rules related to urbanization as follows:

42 (a) On or before January 1, 2025, to implement ORS 197.290, 197.291, 197.293, 197.319 (4),
43 197.320 (13) and 197.335 (6); and

44 (b) On or before January 1, 2026, to implement ORS 197.286 to 197.314, except as provided
45 in paragraph (a) of this subsection.

1 (2) In adopting rules under this section, the commission shall prioritize:

2 (a) Facilitating and encouraging housing production, affordability and housing choice on
3 buildable lands within an urban growth boundary;

4 (b) Providing greater clarity and certainty in the adoption and acknowledgement of
5 housing capacity analyses, urban growth boundary amendments, urban growth boundary ex-
6 changes or urban reserves to accommodate an identified housing need;

7 (c) Reducing analytical burden, minimizing procedural redundancy and increasing legal
8 certainty for local governments pursuing urban growth boundary amendments, urban growth
9 boundary exchanges or urban reserves where a housing need is identified, especially for
10 smaller cities, consistent with the appropriate protection of resource lands; and

11 (d) Supporting coordinated public facilities planning, annexation, and comprehensive plan
12 amendments to facilitate the development of lands brought into an urban growth boundary.

13 (3) In adopting rules under subsection (1)(a) of this section, the commission shall:

14 (a) Consult with the Housing and Community Services Department, Department of
15 Transportation, Department of Environmental Quality, Department of State Lands, Oregon
16 Business Development Department and Department of Consumer and Business Services;

17 (b) Provide clear parameters on the types and extent of actions needed or allowed under
18 ORS 197.290 (3) that are consistent with the technical and resource capacities of varying
19 sizes of local governments; and

20 (c) Recognize actions already taken by local governments.

21 (4) To avoid interference with current planning activities or to avoid unjust or surprising
22 results, the Land Conservation and Development Commission may postpone, for cities spec-
23 ified by the commission, the applicability of sections 13, 21, 22 or 23 of this 2023 Act and the
24 amendments to ORS 197.286, 197.290, 197.296, 197.297 and 197.303, by sections 12 and 25 to 28
25 of this 2023 Act, until a date that is not later than January 1, 2026.

26 SECTION 10. The Department of Land Conservation and Development may provide
27 technical assistance and award grants to local governments to enable them to implement the
28 provisions of ORS 197.286 to 197.314 and to take other actions to incentivize the production
29 of needed housing within the jurisdiction of the local government.

30 SECTION 11. In addition to and not in lieu of any other appropriation, there is appro-
31 priated to the Department of Land Conservation and Development, for the biennium begin-
32 ning July 1, 2023, out of the General Fund, the amount of \$3,500,000, to provide technical
33 assistance and award grants under section 10 of this 2023 Act.

34 SECTION 11a. Notwithstanding any other provision of law, the General Fund appropri-
35 ation made to the Department of Land Conservation and Development by section 1 (1),
36 chapter 438, Oregon Laws 2021, for the biennium ending June 30, 2023, for the planning pro-
37 gram, is increased by \$100,560 to adopt rules and to work on housing production strategies
38 and targets as provided in this 2023 Act.

39 SECTION 11b. In addition to and not in lieu of any other appropriation, there is appro-
40 priated to the Department of Land Conservation and Development, for the biennium begin-
41 ning July 1, 2023, out of the General Fund, the amount of \$2,675,884, to adopt rules and to
42 work on housing production strategies and targets as provided in this 2023 Act.

43 SECTION 12. ORS 197.286, as amended by section 5, chapter 54, Oregon Laws 2022, is amended
44 to read:

45 197.286. As used in ORS 197.286 to 197.314 and 197.475 to 197.490:

1 (1) **“Allocated housing need” means:**

2 (a) **For a city outside Metro, the housing need allocated to a city under section 2 (2) of**
3 **this 2023 Act as segmented by income level under section 2 (4) of this 2023 Act; or**

4 (b) **For a city within Metro, the housing need allocated to the city by Metro under ORS**
5 **197.303 (3).**

6 [(1)] (2) **“Buildable lands” means lands in urban and urbanizable areas that are suitable, avail-**
7 **able and necessary for [residential uses. “Buildable lands” includes] the development of needed**
8 **housing over a 20-year planning period, including both vacant land and developed land likely to**
9 **be redeveloped.**

10 [(2)] (3) **“Government assisted housing” means housing that is financed in whole or part by ei-**
11 **ther a federal or state housing agency or a housing authority as defined in ORS 456.005, or housing**
12 **that is occupied by a tenant or tenants who benefit from rent supplements or housing vouchers**
13 **provided by either a federal or state housing agency or a local housing authority.**

14 (4) **“Housing capacity” means the number of needed housing units that can be developed**
15 **on buildable lands within the 20-year planning period based on the land’s comprehensive plan**
16 **designation and capacity for housing development and redevelopment.**

17 (5) **“Housing production strategy” means a strategy adopted by a local government to**
18 **promote housing production under ORS 197.290.**

19 [(3)] (6) **“Manufactured dwelling,” “manufactured dwelling park,” “manufactured home” and**
20 **“mobile home park” have the meanings given those terms in ORS 446.003.**

21 [(4)] (7) **“Periodic review” means the process and procedures as set forth in ORS 197.628 to**
22 **197.651.**

23 [(5)] (8) **“Prefabricated structure” means a prefabricated structure, as defined in ORS 455.010,**
24 **that is relocatable, more than eight and one-half feet wide and designed for use as a single-family**
25 **dwelling.**

26 [(6)] **“Urban growth boundary” means an urban growth boundary included or referenced in a**
27 **comprehensive plan.]**

28 **SECTION 13. (1) At the time that a city is required to inventory its buildable lands under**
29 **ORS 197.297 (1) or section 21 or 22 of this 2023 Act, the local government shall determine the**
30 **amount of buildable lands that are likely to support the production of housing during the**
31 **period of their housing production target under section 3 (1) of this section, because the**
32 **lands are:**

33 (a) **Currently annexed and zoned to allow housing through clear and objective standards**
34 **and procedures;**

35 (b) **Readily served through adjacent public facilities or identified for the near-term pro-**
36 **vision of public facilities through an adopted capital improvement plan; and**

37 (c) **Not encumbered by any applicable local, state or federal protective regulations or**
38 **have appropriate entitlements to prepare the land for development.**

39 (2) **If the total housing production target is greater than the housing capacity of**
40 **development-ready lands, the local government shall take any actions in ORS 197.290 (3) that**
41 **demonstrably prepare lands for development or redevelopment or increase the housing ca-**
42 **capacity of existing development-ready lands.**

44 **HOUSING PRODUCTION ACCOUNTABILITY**

1 **SECTION 14.** ORS 197.293 is amended to read:

2 197.293. *[(1) The Land Conservation and Development Commission, in consultation with the Housing and Community Services Department, shall adopt criteria for reviewing and identifying cities with a population greater than 10,000 that have not sufficiently:]*

3 *[(a) Achieved production of needed housing within their jurisdiction; or]*

4 *[(b) Implemented a housing production strategy adopted under ORS 197.290.]*

5 *[(2) The criteria adopted by the commission under subsection (1) of this section may include the city's:]*

6 *[(a) Unmet housing need as described in ORS 197.296 (6);]*

7 *[(b) Unmet housing need in proportion to the city's population;]*

8 *[(c) Percentage of households identified as severely rent burdened as described in ORS 456.586;]*

9 *[(d) Recent housing development;]*

10 *[(e) Recent adoption of a housing production strategy under ORS 197.290 or adoption of actions pursuant to a housing production strategy;]*

11 *[(f) Recent or frequent previous identification by the Department of Land Conservation and Development under this section; or]*

12 *[(g) Other attributes that the commission considers relevant.]*

13 *[(3) The Department of Land Conservation and Development may review cities under the criteria adopted under subsection (2) of this section for the purposes of prioritizing actions by the department, including:]*

14 *[(a) Awarding available technical or financial resources;]*

15 *[(b) Providing enhanced review and oversight of the city's housing production strategy;]*

16 *[(c) Requiring a report and explanation if a city does not implement an action within the approximate time frame scheduled within a housing production strategy;]*

17 *[(d) Entering into agreements with the city relating to the city's modification or implementation of its housing production strategy; or]*

18 *[(e) Petitioning the commission to act under ORS 197.319 to 197.335 to require the city to comply with ORS 197.286 to 197.314 or statewide land use planning goals related to housing or urbanization.]*

19 **(1) In developing and implementing this section and performing its duties under ORS 197.319 (4), the Department of Land Conservation and Development shall be guided by section 8 (1) of this 2023 Act and the following principles:**

20 **(a) Increasing housing production;**

21 **(b) Developing affordable and equitable housing;**

22 **(c) Forming partnerships with cities and with other public bodies;**

23 **(d) Responding proportionately to housing underproduction;**

24 **(e) Escalating enforcement to address persistent, repeated or deliberate noncompliance with housing production targets; and**

25 **(f) Considering the availability of state resources to support housing production.**

26 **(2)(a) In determining whether a city should be referred under subsection (3) of this section, the department may base its evaluation on the relative performance of a city based on any one of, or any combination of, the following:**

27 **(A) A city's progress proportionate to its population size, as demonstrated by the statewide housing production dashboard under section 4 of this 2023 Act.**

28 **(B) The city's performance as demonstrated by a statewide housing equity indicator un-**

1 **der section 5 of this 2023 Act.**

2 **(b) The department may not base a determination made under this subsection solely on**
3 **a city's performance on any single equity indicator.**

4 **(3) Each year, the department shall refer into its housing acceleration program, under**
5 **subsection (4) of this section:**

6 **(a) For each region, as established in the Oregon Housing Needs Analysis under section**
7 **1 (1) of this 2023 Act, of those cities that adopted a housing production strategy more than**
8 **three but less than four years ago, including as required by subsection (7)(a) of this section,**
9 **the lowest performing cities, if any exist, as determined under subsection (2) of this section;**

10 **(b) Each city that has failed to adopt a housing production strategy by the deadline under**
11 **ORS 197.290 (1);**

12 **(c) Each city that has failed to undertake actions in its housing production strategy by**
13 **the deadline under ORS 197.290 (4); and**

14 **(d) Cities referred under ORS 197.319 (4).**

15 **(4) For each city referred to the housing acceleration program, within six months, the**
16 **department shall, in cooperation with the city, complete an audit of specific housing barriers,**
17 **that must include an analysis of the following factors affecting housing production,**
18 **affordability and choice:**

19 **(a) The existing housing production strategy and the documents and record supporting**
20 **the strategy;**

21 **(b) Public written comments and invited stakeholder feedback received by a date specified**
22 **by the department;**

23 **(c) Land use planning regulations, including zoning and development code;**

24 **(d) Permitting and approval processes relating to development of housing and**
25 **infrastructure supporting housing;**

26 **(e) Required fees, exactions and improvements;**

27 **(f) Actions and inactions that can impact fair and equitable housing outcomes, environ-**
28 **mental justice, climate resilience and location choice;**

29 **(g) Local resource deficiencies, including staffing, public facilities, capital improvements**
30 **to infrastructure, availability of buildable lands and actions or investments to prepare land**
31 **for development;**

32 **(h) Specific additional state resources that could support housing production;**

33 **(i) Changes to state laws or rules or the regulations, policies, actions or inactions of any**
34 **public body, as defined in ORS 174.109, as that could impact housing production; and**

35 **(j) Other factors limiting housing that are not within the city's control.**

36 **(5) In performing an audit under subsection (4) of this section, the department:**

37 **(a) May request concurrent review of the city's affordability policies under ORS 197.637;**
38 **and**

39 **(b) Shall notify any public body identified under subsection (4)(j) of this section.**

40 **(6) Within six months following an audit under subsection (4) of this section, the city and**
41 **the department must enter into a housing acceleration agreement that is based on and**
42 **proportionate to the city's basis for referral under subsection (3) of this section and informed**
43 **by the audit under subsection (4) of this section.**

44 **(7) Under the housing acceleration agreement, the department shall agree to provide:**

45 **(a) Specified technical assistance, regulatory support and other assistance, to assist the**

1 city in performing its agreement under subsection (8) of this section;

2 (b) Specific funding under the department's control; and

3 (c) Specified assistance in pursuing other state or public funds.

4 (8) Under the housing acceleration agreement, the city shall agree to:

5 (a) If the department determines that the factors affecting housing production,
6 affordability and choice are a consequence of policies and practices that are directly within
7 the city's control, adopt an amended housing production strategy within six months that
8 includes:

9 (A) A timeline for performance under ORS 197.290 (4) of no less than one year; and

10 (B) Specified actions which may include, but are not limited to:

11 (i) Actions under ORS 197.290 (3);

12 (ii) Dedicating funds for increased local capacity to facilitate housing production,
13 affordability and choice;

14 (iii) Dedicating funds for public facilities and infrastructure necessary to support housing
15 production;

16 (iv) Taking measures that increase the availability of development-ready land as de-
17 scribed in section 13 of this 2023 Act;

18 (v) Amending the development code, approval criteria or procedures to reduce cost or
19 delay to housing production; and

20 (vi) Taking emergency temporary measures to support housing production; and

21 (b) Join any department initiated interagency mediation to identify policies and resources
22 that would support housing production in the city.

23 (9) The department may require that a city that is not required to adopt an amendment
24 to its housing production strategy under subsection (8)(a) of this section include findings at
25 the time that the city is next required to adopt a housing production strategy under ORS
26 197.290 (1) that describe how the city has addressed the audit's findings and any suggested
27 actions.

28 (10) The department may grant limited extensions to deadlines under subsections (3)(b)
29 and (c) and (8)(a) of this section for emergencies, good cause or other factors outside of the
30 city's control.

31 (11) The actions by a city or department under this section are not land use decisions
32 and are not subject to appeal or review.

33 (12) All public bodies, as defined in ORS 174.109, are directed to assist cities and the de-
34 partment in the performance of their duties under this section and to take timely action to
35 ensure that the agency's rules or policies do not unduly delay implementation of a housing
36 acceleration agreement under this section.

37 **SECTION 15.** ORS 197.319 is amended to read:

38 197.319. (1) Before a person may request adoption of an enforcement order under ORS 197.320,
39 the person shall:

40 (a) Present the reasons, in writing, for such an order to the affected local government; and

41 (b) Request:

42 (A) Revisions to the local comprehensive plan, land use regulations, special district cooperative
43 or urban service agreement or decision-making process which is the basis for the order; or

44 (B) That an action be taken regarding the local comprehensive plan, land use regulations, spe-
45 cial district agreement, housing production strategy or decision-making process that is the basis for

1 the order.

2 (2)(a) The local government or special district shall issue a written response to the request
3 within 60 days of the date the request is mailed to the local government or special district.

15 **enforcement order under ORS 197.320 (13) without first complying with subsections (1) and**
16 **(2) of this section. Notwithstanding ORS 183.635 (2) and 197.328 (1), the request under this**
17 **subsection must be assigned to an administrative law judge appointed under ORS 183.635**
18 **unless the commission has previously appointed a hearing officer or a pool of hearing officers**
19 **to review petitions filed under this section. Before the entry of a final order under ORS**
20 **197.319 to 197.335, the department, in its discretion, may dismiss a petition filed by the de-**
21 **partment under this section and refer a city to the housing acceleration program under ORS**
22 **197.293.**

23 **SECTION 16.** ORS 197.320 is amended to read:

24 197.320. The Land Conservation and Development Commission shall issue an order requiring a
25 local government, state agency or special district to take action necessary to bring its compre-
26 hensive plan, land use regulation, limited land use decisions or other land use decisions or actions into
27 compliance with the goals, acknowledged comprehensive plan provisions, land use regulations, [or]
28 housing production strategy **or housing acceleration agreements** if the commission has good cause
29 to believe:

30 (1) A comprehensive plan or land use regulation adopted by a local government not on a com-
31 pliance schedule is not in compliance with the goals by the date set in ORS 197.245 or 197.250 for
32 such compliance[;].

33 (2) A plan, program, rule or regulation affecting land use adopted by a state agency or special
34 district is not in compliance with the goals by the date set in ORS 197.245 or 197.250 for such
35 compliance[;].

36 (3) A local government is not making satisfactory progress toward performance of its compliance
37 schedule[;].

38 (4) A state agency is not making satisfactory progress in carrying out its coordination agree-
39 ment or the requirements of ORS 197.180[;].

40 (5) A local government has no comprehensive plan or land use regulation and is not on a com-
41 pliance schedule directed to developing the plan or regulation[;].

42 (6) A local government has engaged in a pattern or practice of decision making that violates
43 an acknowledged comprehensive plan or land use regulation. In making its determination under this
44 subsection, the commission shall determine whether there is evidence in the record to support the
45 decisions made. The commission shall not judge the issue solely upon adequacy of the findings in

1 support of the decisions[;].

2 (7) A local government has failed to comply with a commission order entered under ORS
3 197.644[;].

4 (8) A special district has engaged in a pattern or practice of decision-making that violates an
5 acknowledged comprehensive plan or cooperative agreement adopted pursuant to ORS 197.020[;].

6 (9) A special district is not making satisfactory progress toward performance of its obligations
7 under ORS chapters 195 and 197[;].

8 (10) A local government's approval standards, special conditions on approval of specific devel-
9 opment proposals or procedures for approval do not comply with ORS 197.307 (4) or (6)[;].

10 (11) A local government is not making satisfactory progress toward meeting its obligations un-
11 der ORS 195.065[;].

12 (12) A local government within the jurisdiction of a metropolitan service district has failed to
13 make changes to the comprehensive plan or land use regulations to comply with the regional
14 framework plan of the district or has engaged in a pattern or practice of decision-making that vio-
15 lates a requirement of the regional framework plan[; *or*].

16 (13) A city [*is not making satisfactory progress in taking actions listed in its housing production*
17 *strategy under ORS 197.290.*] **with a population of 10,000 or greater that:**

18 **(a) Has a pattern or practice of violating housing-related statutes or implementing poli-**
19 **cies that create additional, unnecessary cost or delay to affordable or market-rate housing**
20 **production;**

21 **(b) Has a pattern or practice of creating adverse disparate impacts to state or federal**
22 **protected classes or inhibiting equitable access to housing choice, as described in ORS 197.290**
23 **(2)(b) to (d);**

24 **(c) Has failed to enter into a housing acceleration agreement as required under ORS**
25 **197.293 (6); or**

26 **(d) Has materially breached a term of a housing acceleration agreement under ORS**
27 **197.293 (8), including a failure to meet the timeline for performance under ORS 197.293**
28 **(8)(a)(A).**

29 **SECTION 17.** ORS 197.335 is amended to read:

30 197.335. (1) An order issued under ORS 197.328 and the copy of the order mailed to the local
31 government, state agency or special district [*shall*] **must** set forth:

32 (a) The nature of the noncompliance, including, but not limited to, the contents of the compre-
33 hensive plan or land use regulation, if any, of a local government that do not comply with the goals
34 or the contents of a plan, program or regulation affecting land use adopted by a state agency or
35 special district that do not comply with the goals. In the case of a pattern or practice of decision-
36 making [*which violates the goals, comprehensive plan or land use regulations, the order shall*], **the**
37 **order must** specify the decision-making [*which*] **that** constitutes the pattern or practice, including
38 specific provisions the Land Conservation and Development Commission believes are being
39 misapplied[;].

40 (b) The specific lands, if any, within a local government for which the existing plan or land use
41 regulation, if any, does not comply with the goals[; *and*].

42 (c) The corrective action decided upon by the commission, including the specific requirements,

44 pattern or practice of decision-making [*that violates an acknowledged comprehensive plan or land use*
45 *regulation*], the commission may require revisions to the comprehensive plan, land use regulations

1 or local procedures which the commission believes are necessary to correct the pattern or practice.
2 Notwithstanding the provisions of this section, except as provided in subsection (3)(c) of this section,
3 an enforcement order does not affect:

4 (A) Land use applications filed with a local government prior to the date of adoption of the
5 enforcement order unless specifically identified by the order;

6 (B) Land use approvals issued by a local government prior to the date of adoption of the
7 enforcement order; or

8 (C) The time limit for exercising land use approvals issued by a local government prior to the
9 date of adoption of the enforcement order.

10 (2) Judicial review of a final order of the commission [*shall be*] **is** governed by the provisions

29 conservation or sound development of land to allow the continuation of some or all categories of
30 land use decisions or limited land use decisions, it shall, as part of its order, limit, prohibit or re-
31 quire the approval by the local government of applications for subdivisions, partitions, building
32 permits, limited land use decisions or land use decisions until the plan, land use regulation or sub-
33 sequent land use decisions and limited land use decisions are brought into compliance. The com-

34 [(6)] (7) The commission may institute actions or proceedings for legal or equitable remedies in
35 the Circuit Court for Marion County or in the circuit court for the county to which the
36 commission's order is directed or within which all or a portion of the applicable city is located to
37 enforce compliance with the provisions of any order issued under this section or to restrain vio-
38 lations thereof. Such actions or proceedings may be instituted without the necessity of prior agency
39 notice, hearing and order on an alleged violation.

5
6 **SECTION 20.** Sections 8, 13 and 21 to 23 of this 2023 Act are added to and made a part
7 of ORS 197.286 to 197.314.

8 **SECTION 21.** (1) This section applies only to cities that are not within Metro or described
9 in section 22 (1) of this 2023 Act.

10 (2) The actions required under subsection (3) of this section must be undertaken:

11 (a) At periodic review pursuant to ORS 197.628 to 197.651;

12 (b) On a schedule established by the Land Conservation and Development Commission for
13 cities with a population of 10,000 or greater, not to exceed once each eight years;

14 (c) At any other legislative review of the comprehensive plan that requires the applica-
15 tion of a statewide planning goal related to buildable lands for residential use; or

16 (d) At the election of a city with a population of less than 10,000.

17 (3) A city shall, according to rules of the commission:

18 (a) Determine its needed housing under section 23 of this 2023 Act;

19 (b) Inventory the supply of buildable lands available within the urban growth boundary
20 to accommodate needed housing; and

21 (c) Take any necessary actions described in ORS 197.290 (3), whether or not the actions
22 are described within the city's housing production strategy, to accommodate needed housing.

23 **SECTION 22.** (1) This section applies only to local governments with jurisdiction over
24 lands inside the urban growth boundary of:

25 (a) Cities located outside Metro with a population of 25,000 or greater; and

26 (b) Cities that meet factors established by Land Conservation and Development Com-
27 mission in consideration of the city's size, rate of population growth or proximity to another
28 city with a population of 25,000 or greater or to Metro.

29 (2) A local government shall determine its needed housing under section 23 of this 2023
30 Act and inventory its buildable lands and determine the lands' housing capacity under this
31 section:

32 (a) At periodic review under ORS 197.628 to 197.651;

33 (b) As scheduled by the commission at least once each eight years; or

34 (c) At any other legislative review of the comprehensive plan that concerns the urban
35 growth boundary and requires the application of a statewide planning goal related to
36 buildable lands for residential use.

37 (3) For the purpose of determining housing capacity and inventory of buildable lands
38 under subsection (2) of this section:

39 (a) "Buildable lands" includes:

40 (A) Vacant lands planned or zoned for residential use;

41 (B) Partially vacant lands planned or zoned for residential use;

42 (C) Lands that may be used for a mix of residential and employment uses under the ex-
43 isting planning or zoning; and

44 (D) Lands that may be used for residential infill or redevelopment.

45 (b) The local government shall consider:

1 (A) The extent that residential development is prohibited or restricted by local regulation
2 and ordinance, state law and rule or federal statute and regulation;

3 (B) A written long term contract or easement for radio, telecommunications or electrical
4 facilities, if the written contract or easement is provided to the local government; and

5 (C) The presence of a single family dwelling or other structure on a lot or parcel.

6 (c) Except for land that may be used for residential infill or redevelopment, the local
7 government shall create a map or document that may be used to verify and identify specific
8 lots or parcels that have been determined to be buildable lands.

9 (4)(a) Except as provided in paragraphs (b) and (c) of this subsection, the determination
10 of housing capacity must be based on data related to land within the urban growth boundary
11 that has been collected since the last review under subsection (2)(b) of this section. The data
12 must include:

13 (A) The number, density and average mix of housing types of urban residential develop-
14 ment that have actually been developed;

15 (B) Trends in density and average mix of housing types of urban residential development;

16 (C) Market factors that may substantially impact future urban residential development;

17 (D) The number, density and average mix of housing types that have been developed on
18 buildable lands;

19 (E) Consideration of the effects of the adopted housing production strategy and measures
20 taken and reasonably anticipated to be taken to implement the strategy; and

21 (F) Consideration of factors that influence available housing supply, including short-term
22 rentals, second homes and vacation homes.

23 (b) A local government shall make the determination described in paragraph (a) of this
24 subsection using data from a shorter time period than the time period described in paragraph
25 (a) of this subsection if the local government finds that the shorter time period will provide
26 more accurate and reliable data related to housing capacity. The shorter time period may
27 not be less than three years.

28 (c) A local government shall use data from a wider geographic area or use a time period
29 longer than the time period described in paragraph (a) of this subsection if the analysis of a
30 wider geographic area or the use of data from a longer time period will provide more accu-
31 rate, complete and reliable data related to trends affecting housing need than an analysis
32 performed pursuant to paragraph (a) of this subsection. The local government must clearly
33 describe the geographic area, time frame and source of data used in a determination per-
34 formed under this paragraph.

35 (5) If the needed housing is greater than the housing capacity, the local government shall
36 take one or both of the following actions to accommodate allocated housing need for the next
37 20 years:

38 (a) Amend its urban growth boundary to include sufficient buildable lands to accommo-
39 date allocated housing need for the next 20 years consistent with the requirements of ORS
40 197A.320 and statewide planning goals. As part of this process, the local government shall
41 consider the effects of actions taken pursuant to paragraph (b) of this subsection. The
42 amendment must include sufficient land reasonably necessary to accommodate the siting of
43 new public school facilities. The need and inclusion of lands for new public school facilities
44 must be a coordinated process between the affected public school districts and the local
45 government that has the authority to approve the urban growth boundary.

1 (b) Take any action under ORS 197.290 (3), whether or not the action was described in
2 an approved housing production strategy, that demonstrably increases housing capacity or
3 produces additional needed housing. Actions under this paragraph may include amending a
4 comprehensive plan or land use regulations to include new measures that demonstrably in-
5 crease the likelihood that residential development will occur at densities sufficient to ac-
6 commodate needed housing for the next 20 years without expansion of the urban growth
7 boundary.

8 (6) A local government that takes any actions under subsection (5) of this section shall:

9 (a) Demonstrate that the comprehensive plan and land use regulations comply with goals
10 and rules adopted by the commission.

11 (b) Adopt findings regarding the changes in housing capacity assumed to result from
12 actions adopted based on data collected under subsection (4)(a) of this section. The density
13 expectations may not project an increase in residential capacity above achieved density by
14 more than three percent without quantifiable validation of such departures. A quantifiable
15 validation must demonstrate that the assumed housing capacity has been achieved in areas
16 that are zoned to allow no greater than the same authorized density level, as defined in ORS
17 227.175, within the local government’s jurisdiction or a jurisdiction in the same region.

18 (c) In establishing that actions adopted under subsection (5) of this section demonstrably
19 increase housing capacity, ensure that buildable lands are in locations appropriate for needed
20 housing, are zoned at density ranges that are likely to be achieved by the housing market
21 and are in areas where sufficient urban services are planned to enable the higher density
22 development to occur over the 20-year period.

23 **SECTION 23.** (1) As used in ORS 197.286 to 197.314, and except as provided in subsection
24 (2) of this section:

25 (a) “Needed housing” means housing by affordability level, as described in section 2 (4)
26 of this 2023 Act, type, characteristics and location that is necessary to accommodate the
27 city’s allocated housing need over the 20-year planning period in effect when the city’s
28 housing capacity is determined.

29 (b) “Needed housing” includes the following housing types:

30 (A) Detached single-family housing, middle housing types as described in ORS 197.758 and
31 multifamily housing that is owned or rented;

32 (B) Government assisted housing;

33 (C) Mobile home or manufactured dwelling parks as provided in ORS 197.475 to 197.490;

34 (D) Manufactured homes on individual lots planned and zoned for single-family residential
35 use that are in addition to lots within designated manufactured dwelling subdivisions;

36 (E) Housing for agricultural workers;

37 (F) Housing for individuals with a variety of disabilities, related to mobility or commu-
38 nications that require accessibility features;

39 (G) Housing for older persons, as defined in ORS 659A.421; and

40 (H) Housing for college or university students, if relevant to the region.

41 (2) Subsection (1)(b)(A) and (D) of this section does not apply to:

42 (a) A city with a population of less than 2,500.

43 (b) A county with a population of less than 15,000.

44 (3) At the time that a city is required to inventory its buildable lands under ORS 197.297
45 (1) or section 21 or 22 of this 2023 Act, the city shall determine its needed housing under this

1 **section.**

2 **(4) In determining needed housing the city must demonstrate that the projected housing**
3 **types, characteristics and locations are:**

4 **(a) Attainable for the allocated housing need by income, including consideration of pub-**
5 **licly supported housing;**

6 **(b) Appropriately responsive to current and projected market trends; and**

7 **(c) Responsive to the factors in ORS 197.290 (2)(b) to (d).**

8 **SECTION 24.** ORS 197A.320 is amended to read:

9 197A.320. (1) *[Notwithstanding the priority in ORS 197.298 for inclusion of land within an urban*
10 *growth boundary,]* A city outside *[of]* Metro shall comply with this section when determining which
11 lands to include within the urban growth boundary of the city, **including when amending an urban**
12 **growth boundary under ORS** *[pursuant to ORS 197.286 to 197.314,]* 197A.310 or 197A.312 **or sec-**
13 **tion 22 (5)(a) of this 2023 Act.**

14 (2) The Land Conservation and Development Commission shall provide, by rule, that:

15 (a) When evaluating lands for inclusion within the urban growth boundary, the city shall es-
16 tablish a study area that includes all land that is contiguous to the urban growth boundary and
17 within a distance specified by commission.

18 (b) The city shall evaluate all land in the study area for inclusion in the urban growth boundary
19 as provided in subsection (4) of this section, except for land excluded from the study area because:

20 (A) It is impracticable, as provided in subsection (3) of this section, to provide necessary public
21 facilities or services to the land.

22 (B) The land is subject to significant development hazards, including a risk of land slides, a risk
23 of flooding because the land is within the 100-year floodplain or is subject to inundation during
24 storm surges or tsunamis, and other risks determined by the commission.

25 (C) The long-term preservation of significant scenic, natural, cultural or recreational resources
26 requires limiting or prohibiting urban development of the land that contains the resources.

27 (D) The land is owned by the federal government and managed primarily for rural uses.

28 **(E) The land is designated as rural reserve under ORS 195.137 to 195.145.**

29 (c) When evaluating the priority of land for inclusion under paragraph (b) of this subsection:

30 (A) The city shall evaluate the land within the study area that is designated as an urban reserve
31 under ORS 195.145 in an acknowledged comprehensive plan[.].

32 **(B) If the amount of land appropriate for selection under subparagraph (A) of this para-**
33 **graph is not sufficient to satisfy the need for the land, the city shall evaluate the** land that
34 is subject to an acknowledged exception under ORS 197.732 or land that is nonresource land and
35 select as much of the land as necessary to satisfy the need for land using criteria established by the
36 commission and criteria in an acknowledged comprehensive plan and land use regulations.

37 *[(B)]* (C) If the amount of land appropriate for selection under *[subparagraph (A)]* **subpara-**
38 **graphs (A) and (B)** of this paragraph is not sufficient to satisfy the need for land, the city shall
39 evaluate the land within the study area that is designated as marginal land under ORS 197.247 (1991
40 Edition) in the acknowledged comprehensive plan and select as much of the land as necessary to
41 satisfy the need for land using criteria established by the commission and criteria in an acknowl-
42 edged comprehensive plan and land use regulations.

43 *[(C)]* (D) If the amount of land appropriate for selection under subparagraphs (A) *[and (B)]* **to**
44 (C) of this paragraph is not sufficient to satisfy the amount of land needed, the city shall evaluate
45 land within the study area that is designated for agriculture or forest uses in the acknowledged

1 comprehensive plan that is not predominantly high-value farmland, as defined in ORS 195.300, or
2 does not consist predominantly of prime or unique soils, as determined by the United States De-
3 partment of Agriculture Natural Resources Conservation Service, and select as much of that land
4 as necessary to satisfy the need for land:

5 (i) Using criteria established by the commission and criteria in an acknowledged comprehensive
6 plan and land use regulations; and

7 (ii) Using the predominant capability classification system or the predominant cubic site class,
8 as appropriate for the acknowledged comprehensive plan designation, to select lower capability or
9 cubic site class lands first.

10 [(D)] (E) If the amount of land appropriate for selection under subparagraphs (A) to [(C)] (D)
11 of this paragraph is not sufficient to satisfy the need for land, the city shall evaluate land within
12 the study area that is designated as agricultural land in an acknowledged comprehensive plan and
13 is predominantly high value farmland and select as much of that land as necessary to satisfy the
14 need for land. A local government may not select land that is predominantly made up of prime or
15 unique farm soils, as defined by the United States Department of Agriculture Natural Resources
16 Conservation Service, unless there is an insufficient amount of other land to satisfy its land need.

17 (3) For purposes of subsection (2)(b)(A) of this section, the commission shall determine
18 impracticability by rule, considering the likely amount of development that could occur on the lands
19 within the planning period, the likely cost of facilities and services, physical, topographical or other
20 impediments to service provision and whether urban development has occurred on similarly situated
21 lands such that it is likely that the lands will be developed at an urban level during the planning
22 period. When impracticability is primarily a result of existing development patterns, the rules of the
23 commission shall require that the lands be included within the study area, but may allow the de-
24 velopment capacity forecast for the lands to be specified at a lower level over the planning period.
25 The rules of the commission must be based on an evaluation of how similarly situated lands have,
26 or have not, developed over time.

27 (4) For purposes of subsection (2)(b)(C) of this section, the commission by rule shall determine
28 the circumstances in which and the resources to which this exclusion will apply.

29 (5) Notwithstanding subsection [(2)(c)(D)] (2)(c)(E) of this section, the rules must allow land that
30 would otherwise be excluded from an urban growth boundary to be included if:

31 (a) The land contains a small amount of resource land that is not important to the commercial
32 agricultural enterprise in the area and the land must be included to connect a nearby and signif-
33 icantly larger area of land of higher priority for inclusion within the urban growth boundary; or

34 (b) The land contains a small amount of resource land that is not predominantly high-value
35 farmland or predominantly made up of prime or unique farm soils and the land is completely sur-
36 rounded by land of higher priority for inclusion into the urban growth boundary.

37 (6) When the primary purpose for expansion of the urban growth boundary is to accommodate
38 a particular industry use that requires specific site characteristics, or to accommodate a public fa-
39 cility that requires specific site characteristics and the site characteristics may be found in only a
40 small number of locations, the city may limit the study area to land that has, or could be improved
41 to provide, the required site characteristics. Lands included within an urban growth boundary for
42 a particular industrial use, or a particular public facility, must remain planned and zoned for the
43 intended use:

44 (a) Except as allowed by rule of the commission that is based on a significant change in cir-
45 cumstance or the passage of time; or

1 (b) Unless the city removes the land from within the urban growth boundary.

2 (7) Notwithstanding any other provision of this section, the commission may adopt rules that
3 specify circumstances under which a city may exchange land within the urban growth boundary of
4 the city for land that is outside of the urban growth boundary and that is designed to avoid adverse
5 effects of an exchange on agricultural or forest operations in the surrounding area.

8
9 **SECTION 25.** ORS 197.296 is amended to read:

10 197.296. (1) **This section applies only to Metro.**

11 [(1)(a) *The provisions of subsections (2) to (9) of this section apply to metropolitan service district*
12 *regional framework plans and local government comprehensive plans for lands within the urban growth*
13 *boundary of a city that is located outside of a metropolitan service district and has a population of*
14 *25,000 or more.*]

15 [(b) *The Land Conservation and Development Commission may establish a set of factors under*
16 *which additional cities are subject to the provisions of this section. In establishing the set of factors*
17 *required under this paragraph, the commission shall consider the size of the city, the rate of population*
18 *growth of the city or the proximity of the city to another city with a population of 25,000 or more or*
19 *to a metropolitan service district.*]

20 (2)(a) [A *local government*] **Metro** shall demonstrate that its [*comprehensive plan or*] regional
21 framework plan provides sufficient buildable lands within the urban growth boundary established
22 pursuant to statewide planning goals to accommodate estimated housing needs for 20 years:

23 (A) At periodic review under ORS 197.628 to 197.651;

24 (B) As scheduled by the **Land Conservation and Development Commission**[:]

25 [*i*] *at least once each eight years for local governments that are not within a metropolitan service*
26 *district; or*

27 [*ii*] *at least once each six years [for a metropolitan service district]; or*

28 (C) At any other legislative review of the [*comprehensive plan or*] regional framework plan that
29 concerns the urban growth boundary and requires the application of a statewide planning goal re-
30 lating to buildable lands for residential use.

31 (b) The 20-year period shall commence on the date initially scheduled for completion of the re-
32 view under paragraph (a) of this subsection.

33 (3) In performing the duties under subsection (2) of this section, [*a local government*] **Metro**
34 shall:

35 (a) Inventory the supply of buildable lands within the urban growth boundary and determine the
36 housing capacity of the buildable lands; and

37 (b) Conduct an analysis of existing and projected housing need by type and density range, in
38 accordance with all factors under ORS 197.303 and statewide planning goals and rules relating to
39 housing, to determine the number of units and amount of land needed for each needed housing type
40 for the next 20 years.

41 (4)(a) For the purpose of the inventory described in subsection (3)(a) of this section, “buildable
42 lands” includes:

43 (A) Vacant lands planned or zoned for residential use;

44 (B) Partially vacant lands planned or zoned for residential use;

45 (C) Lands that may be used for a mix of residential and employment uses under the existing

1 planning or zoning; and

2 (D) Lands that may be used for residential infill or redevelopment.

3 (b) For the purpose of the inventory and determination of housing capacity described in sub-
4 section (3)(a) of this section, [*the local government*] **Metro** must demonstrate consideration of:

5 (A) The extent that residential development is prohibited or restricted by local regulation and
6 ordinance, state law and rule or federal statute and regulation;

7 (B) A written long term contract or easement for radio, telecommunications or electrical facili-
8 ties, if the written contract or easement is provided to [*the local government; and*] **Metro**;

9 (C) The presence of a single family dwelling or other structure on a lot or parcel[.]; **and**

10 **(D) Factors that influence available housing supply, including short-term rentals, second**
11 **homes and vacation homes.**

12 (c) Except for land that may be used for residential infill or redevelopment, [*a local*
13 *government*] **Metro** shall create a map or document that may be used to verify and identify specific
14 lots or parcels that have been determined to be buildable lands.

15 (5)(a) Except as provided in paragraphs (b) and (c) of this subsection, the determination of
16 housing capacity pursuant to subsection (3)(a) of this section must be based on data relating to land
17 within the urban growth boundary that has been collected since the last review under subsection
18 (2)(a)(B) of this section. The data shall include:

19 (A) The number, density and average mix of housing types of urban residential development that
20 have actually occurred;

21 (B) Trends in density and average mix of housing types of urban residential development;

22 (C) Market factors that may substantially impact future urban residential development; and

23 (D) The number, density and average mix of housing types that have occurred on the buildable
24 lands described in subsection (4)(a) of this section.

25 (b) [*A local government*] **Metro** shall make the determination described in paragraph (a) of this
26 subsection using a shorter time period than the time period described in paragraph (a) of this sub-
27 section if [*the local government*] **Metro** finds that the shorter time period will provide more accurate
28 and reliable data related to housing capacity. The shorter time period may not be less than three
29 years.

30 (c) [*A local government*] **Metro** shall use data from a wider geographic area or use a time period
31 longer than the time period described in paragraph (a) of this subsection if the analysis of a wider
32 geographic area or the use of a longer time period will provide more accurate, complete and reliable
33 data relating to trends affecting housing need than an analysis performed pursuant to paragraph (a)
34 of this subsection. [*The local government*] **Metro** must clearly describe the geographic area, time
35 frame and source of data used in a determination performed under this paragraph.

36 (6) If the housing need determined pursuant to subsection (3)(b) of this section is greater than
37 the housing capacity determined pursuant to subsection (3)(a) of this section, [*the local government*]
38 **Metro** shall take one or both of the following actions to accommodate the additional housing need:

39 (a) Amend its urban growth boundary to include sufficient buildable lands to accommodate
40 housing needs for the next 20 years. As part of this process, [*the local government*] **Metro** shall
41 consider the effects of measures taken pursuant to paragraph (b) of this subsection. The amendment
42 shall include sufficient land reasonably necessary to accommodate the siting of new public school
43 facilities. The need and inclusion of lands for new public school facilities shall be a coordinated
44 process between the affected public school districts and [*the local government*] **Metro** that has the
45 authority to approve the urban growth boundary.

1 (b) Amend its [*comprehensive plan,*] regional framework plan, functional plan or land use regu-
 2 lations to include new measures that demonstrably increase the likelihood that residential develop-
 3 ment will occur at densities sufficient to accommodate housing needs for the next 20 years without
 4 expansion of the urban growth boundary. [*A local government or metropolitan service district that*]
 5 **If Metro** takes this action, **Metro** shall adopt findings regarding the density expectations assumed
 6 to result from measures adopted under this paragraph based upon the factors listed in ORS 197.303
 7 (2) and data in subsection (5)(a) of this section. The density expectations may not project an increase
 8 in residential capacity above achieved density by more than three percent without quantifiable val-
 9 idation of such departures. [*For a local government located outside of a metropolitan service district,*
 10 *a quantifiable validation must demonstrate that the assumed housing capacity has been achieved in*
 11 *areas that are zoned to allow no greater than the same authorized density level within the local juris-*
 12 *isdiction or a jurisdiction in the same region. For a metropolitan service district,] A quantifiable vali-*
 13 *validation must demonstrate that the assumed housing capacity has been achieved in areas* **within**
 14 **Metro** that are zoned to allow no greater than the same authorized density level, **as defined in**
 15 **ORS 227.175** [*within the metropolitan service district*].

16 [(c) As used in this subsection, “authorized density level” has the meaning given that term in ORS
 17 227.175.]

18 (7) Using the housing need analysis conducted under subsection (3)(b) of this section, [*the local*
 19 *government*] **Metro** shall determine the overall average density and overall mix of housing types at
 20 which residential development of needed housing types must occur in order to meet housing needs
 21 over the next 20 years. If that density is greater than the actual density of development determined
 22 under subsection (5)(a)(A) of this section, or if that mix is different from the actual mix of housing
 23 types determined under subsection (5)(a)(A) of this section, [*the local government*] **Metro**, as part of
 24 its periodic review, shall adopt measures that demonstrably increase the likelihood that residential
 25 development will occur at the housing types and density and at the mix of housing types required
 26 to meet housing needs over the next 20 years.

27 (8)(a) [*A local government outside a metropolitan service district that*] **If Metro** takes any actions
 28 under subsection (6) or (7) of this section, **Metro** shall demonstrate that the comprehensive plan and
 29 land use regulations comply with goals and rules adopted by the commission and implement ORS
 30 197.286 to 197.314.

31 (b) [*A local government*] **Metro** shall determine the density and mix of housing types anticipated
 32 as a result of actions taken under subsections (6) and (7) of this section and monitor and record the
 33 actual density and mix of housing types achieved following the adoption of these actions. [*The local*
 34 *government*] **Metro** shall compare actual and anticipated density and mix. [*The local government*]
 35 **Metro** shall submit its comparison to the commission at the next review of its urban growth
 36 boundary under subsection (2)(a) of this section.

37 (9) In establishing that actions and measures adopted under subsections (6) and (7) of this sec-
 38 tion demonstrably increase the likelihood of higher density residential development, [*the local gov-*
 39 *ernment*] **Metro** shall at a minimum ensure that land zoned for needed housing is in locations
 40 appropriate for the housing types identified under subsection (3) of this section, is zoned at density
 41 ranges that are likely to be achieved by the housing market using the analysis in subsection (3) of
 42 this section and is in areas where sufficient urban services are planned to enable the higher density
 43 development to occur over the 20-year period. Actions or measures, or both, may include [*but are*
 44 *not limited to:*] **those actions listed in ORS 197.290 (3).**

45 [(a) Increases in the permitted density on existing residential land;]

1 [(b) Financial incentives for higher density housing;]

2 [(c) Provisions permitting additional density beyond that generally allowed in the zoning district
3 in exchange for amenities and features provided by the developer;]

4 [(d) Removal or easing of approval standards or procedures;]

5 [(e) Minimum density ranges;]

6 [(f) Redevelopment and infill strategies;]

7 [(g) Authorization of housing types not previously allowed by the plan or regulations;]

8 [(h) Adoption of an average residential density standard; and]

9 [(i) Rezoning or redesignation of nonresidential land.]

10 [(10)(a) The provisions of this subsection apply to local government comprehensive plans for lands
11 within the urban growth boundary of a city that is located outside of a metropolitan service district
12 and has a population of less than 25,000.]

13 [(b) As required under paragraph (c) of this subsection, a city shall, according to rules of the
14 commission:]

15 [(A) Determine the estimated housing needs within the jurisdiction for the next 20 years;]

16 [(B) Inventory the supply of buildable lands available within the urban growth boundary to ac-
17 commodate the estimated housing needs determined under this subsection; and]

18 [(C) Adopt measures necessary to accommodate the estimated housing needs determined under this
19 subsection.]

20 [(c) The actions required under paragraph (b) of this subsection shall be undertaken:]

21 [(A) At periodic review pursuant to ORS 197.628 to 197.651;]

22 [(B) On a schedule established by the commission for cities with a population greater than 10,000,
23 not to exceed once each eight years; or]

24 [(C) At any other legislative review of the comprehensive plan that requires the application of a
25 statewide planning goal relating to buildable lands for residential use.]

26 [(d) For the purpose of the inventory described in this subsection, “buildable lands” includes those
27 lands described in subsection (4)(a) of this section.]

28 [(11) If a city with a population of 10,000 or less conducts an inventory of the supply of buildable
29 lands or an estimate of housing need, it must satisfy the requirements of subsection (10) of this
30 section.]

31 **SECTION 26.** ORS 197.297 is amended to read:

32 197.297. (1) At least once every six years, by a date scheduled by the Land Conservation and
33 Development Commission, a city that is within [a metropolitan service district] **Metro** and has a
34 population of **10,000 or greater** [than 10,000] shall:

35 (a) Inventory the supply of buildable lands within the city and determine the housing capacity
36 of the buildable lands; and

37 (b) Conduct an analysis of the city’s existing and projected needed housing under statewide
38 planning goals and rules related to housing by type, mix, affordability and density range to deter-
39 mine the number of units and amount of land needed for each needed housing type **under section**
40 **23 of this 2023 Act** for the next 20 years.

41 (2) The housing capacity **determination** and **the** needed housing analysis conducted under this
42 section must be adopted as part of the city’s comprehensive plan no later than one year after com-
43 pletion of the needed housing analysis.

44 (3) If the housing capacity and needed housing analysis conducted under this section demon-
45 strates a housing need, the city shall amend its comprehensive plan or land use regulations **or take**

1 **actions to update or implement its housing production strategy** to include new measures that
2 demonstrably increase the likelihood that development of needed housing will occur for the type,
3 mix, affordability and densities sufficient to accommodate needed housing for the next 20 years.

4 **SECTION 27.** ORS 197.303 is amended to read:

5 197.303. (1) As used in ORS [197.286 to 197.314] **197.296 and this section**, “needed housing”
6 means all housing on land zoned for residential use or mixed residential and commercial use that
7 is determined to meet the need shown for housing within an urban growth boundary at price ranges
8 and rent levels that are affordable to households within the county with a variety of incomes, in-
9 cluding but not limited to households with low incomes, very low incomes and extremely low in-
10 comes, as those terms are defined by the United States Department of Housing and Urban

19 (f) **Housing for individuals with a variety of disabilities related to mobility or communi-**
20 **cations that require accessibility features;**

21 (g) **Housing for older persons, as defined in ORS 659A.421; and**

22 (h) **Housing for college or university students, if relevant to the region.**

23 (2) For the purpose of estimating housing needs, as described in ORS 197.296 (3)(b), [a local
24 government shall use the population projections prescribed by ORS 195.033 or 195.036 and shall con-
25 sider and adopt findings related to changes in] **Metro shall adopt findings and perform an analysis**
26 **that estimates** each of the following factors [since the last review under ORS 197.296 (2)(a)(B) and
27 the projected future changes in these factors over a 20-year planning period]:

28 [(a) Household sizes;]

29 [(b) Household demographics;]

30 [(c) Household incomes;]

31 [(d) Vacancy rates; and]

32 [(e) Housing costs.]

33 (a) **Projected needed housing units over the next 20 years;**

34 (b) **Current housing underproduction;**

35 (c) **Housing units needed for people experiencing homelessness; and**

36 (d) **Housing units projected to be converted into vacation homes or second homes during**
37 **the next 20 years.**

38 (3) **At the time Metro performs the analysis under subsection (2) of this section, Metro**
39 **shall allocate a housing need for each city within Metro.**

40 (4) **In making an allocation under subsection (3) of this section, Metro shall consider:**

41 (a) **The forecasted population growth under ORS 195.033 or 195.036;**

42 (b) **The forecasted regional job growth;**

43 (c) **An equitable statewide distribution of housing for income levels described in section**
44 **2 (4) of this 2023 Act.**

45 (d) **The estimates made under subsection (2) of this section; and**

1 (e) **The purpose of the Oregon Housing Needs Analysis under section 1 (1) of this 2023**
2 **Act.**

3 [(3)] (5) [A local government] **Metro** shall make the estimate described in subsection (2) of this
4 section using a shorter time period than since the last review under ORS 197.296 (2)(a)(B) if [the
5 local government] **Metro** finds that the shorter time period will provide more accurate and reliable
6 data related to housing need. The shorter time period may not be less than three years.

7 [(4)] (6) [A local government] **Metro** shall use data from a wider geographic area or use a time
8 period longer than the time period described in subsection (2) of this section if the analysis of a
9 wider geographic area or the use of a longer time period will provide more accurate, complete and
10 reliable data relating to trends affecting housing need than an analysis performed pursuant to sub-
11 section (2) of this section. [The local government] **Metro** must clearly describe the geographic area,
12 time frame and source of data used in an estimate performed under this subsection.

13 [(5)] (7) Subsection (1)(a) and (d) of this section does not apply to[:]

14 [(a)] a city with a population of less than 2,500.

15 [(b)] A county with a population of less than 15,000.]

16 [(6)] (8) [A local government] **Metro** may take an exception under ORS 197.732 to the definition
17 of “needed housing” in subsection (1) of this section in the same manner that an exception may be
18 taken under the goals.

30 (2) A housing production strategy must include a list of specific actions, including the adoption

33 **(a) The development of needed housing;**

34 **(b) The development and maintenance of housing that is of diverse housing types, high-**
35 **quality, affordable and accessible;**

36 **(c) Housing with access to economic opportunities, services and amenities; and**

37 **(d) Affirmatively furthering fair housing.**

38 **(3) Actions [under this subsection may] that may be included in a housing production strat-**
39 **egy** include:

40 (a) The reduction of financial and regulatory impediments to developing needed housing, in-
41 cluding removing or easing approval standards or procedures for needed housing at higher densities
42 or that is affordable;

43 (b) The creation of financial and regulatory incentives for development of needed housing, in-
44 cluding creating incentives for needed housing at higher densities or that is affordable; [and]

45 (c) The development of a plan to access resources available at local, regional, state and national

1 levels to increase the availability and affordability of needed housing[.];

2 **(d) Target development on lands identified under section 13 (1) of this 2023 Act;**

3 **(e) Actions that affirmatively further fair housing;**

4 **(f) Actions that:**

5 **(A) Increase housing diversity, efficiency and affordability, including new construction**
6 **and the preservation of naturally occurring affordable housing;**

7 **(B) Allow greater housing choice for households and greater flexibility in location, type**
8 **and density;**

9 **(C) Reduce cost or delay and increase procedural certainty for the production of housing;**
10 **or**

11 **(D) Prepare land for development or redevelopment, including:**

12 **(i) Public facilities planning and other investment strategies that increase the readiness**
13 **of land for development for housing production;**

14 **(ii) Site preparation, financial incentives or other incentive-based measures that increase**
15 **the likelihood of development or redevelopment of land; or**

16 **(iii) The redevelopment of underutilized commercial and employment lands for housing**
17 **or a mix of housing and commercial uses; or**

18 **(g) Any other actions identified by rule of the Land Conservation and Development**
19 **Commission intended to promote housing production, affordability and choice.**

20 **(4) Actions proposed in a city's housing production strategy shall include clear deadlines**
21 **by which the city expects to undertake the action.**

22 [(3)] **(5) In creating a housing production strategy, a city shall review and consider:**

36 **subject to appeal or review except as provided in ORS 197.291.**

37 [(6)] **(8) A city with a population of less than 10,000 [or less] may develop a housing production**
38 **strategy as provided in this section.**

39 **(9) As used in this section, "affirmatively furthering fair housing" means meaningful**
40 **actions that, when taken together, address significant disparities in housing needs and access**
41 **to opportunity and replace segregated living patterns with truly integrated and balanced liv-**
42 **ing patterns to transform racially and ethnically concentrated areas of poverty into areas**
43 **of opportunity and foster and maintain compliance with civil rights and fair housing laws.**

(3) On the same day the city submits notice of the housing production strategy or amended strategy, the city shall provide a notice to persons that participated in the proceedings that led to the adoption of the strategy and requested notice in writing.

(4) Within 10 days of receipt of the submission under subsection (1) of this section, the department shall provide notice to persons described under ORS 197.615 (3).

(5) The notices given under subsections (3) and (4) of this section must state:

(a) How and where materials described in subsection (2) of this section may be freely obtained;

(b) That comments on the strategy may be submitted to the department within 45 days after the department has received the submission; and

(c) That there is no further right of appeal.

[(c) The Department of Land Conservation and Development shall provide the governing body of the city with the survey form developed pursuant to paragraph (b) of this subsection.]

[(d) The governing body of the city shall return the completed survey form to the Department of Land Conservation and Development at least 24 months prior to a deadline for completing a housing production strategy under ORS 197.290.]

[(3)(a)] In any year in which [the governing body of a city is informed under this section that at] **a housing indicator demonstrates that** least 25 percent of the renter households in [the] **a city** are severely rent burdened **under section 5 (2)(g) of this 2023 Act**, the governing body **of the city** shall hold at least one public meeting to discuss the causes and consequences of severe rent burdens within the city, the barriers to reducing rent burdens and possible solutions.

[(b)] The Housing and Community Services Department may adopt rules governing the conduct of the public meeting [required under this subsection].

[(4) No later than February 1 of each year, the governing body of each city in this state with a population greater than 10,000 shall submit to the Department of Land Conservation and Development a report for the immediately preceding calendar year setting forth separately for each of the following categories the total number of units that were permitted and the total number that were produced:]

[(a) Residential units.]

[(b) Regulated affordable residential units.]

[(c) Multifamily residential units.]

[(d) Regulated affordable multifamily residential units.]

[(e) Single-family homes.]

[(f) Regulated affordable single-family homes.]

[(g) Accessory dwelling units.]

[(h) Regulated affordable accessory dwelling units.]

[(i) Units of middle housing, as defined in ORS 197.758.]

[(j) Regulated affordable units of middle housing.]

1 **SECTION 36.** Sections 37 and 38 of this 2023 Act are added to and made a part of ORS
2 197.286 to 197.314.

3 **SECTION 37.** (1) No later than February 1 of each year, each city with a population of

42 center is preparing a population forecast; and

- 1 (a) Each county except Multnomah, Clackamas and Washington Counties;

4 (c) The area within each urban growth boundary other than the urban growth boundary of
5 Metro.
- 6 (3) A local government with land use jurisdiction over land for which the center issues popu-
7 lation forecasts under subsection (2) of this section shall apply the current final population forecast
8 when changing the comprehensive plan or a land use regulation of the local government.
- 9 (4) The center shall issue population forecasts for each area described in subsection (2) of this
10 section not less than once every four years on a schedule established by standards adopted by
11 Portland State University in consultation with the Department of Land Conservation and Develop-
12 ment.
- 13 (5) When issuing a population forecast, the center shall:

20 Housing Account to assist homeless individuals and individuals who are at risk of becoming
21 homeless, through means including the emergency housing assistance program and the state
22 homeless assistance program. Notwithstanding subsection (3)(a) of this section, the state homeless
23 assistance program shall serve individuals experiencing homelessness, especially unsheltered
24 homelessness, without respect to income.

25 (2) The Oregon Housing Stability Council shall develop a policy for the use of program funds
26 with the advice of:

- 27 (a) Persons who have experienced housing instability;
28 (b) Tribes;
29 (c) The Community Action Partnership of Oregon;
30 (d) Continuums of care, as defined in 24 C.F.R. part 578;
31 (e) Local governments;
32 (f) Nonprofit organizations;
33 (g) Homeless services providers;
34 (h) Culturally specific organizations;
35 (i) Housing providers;
36 (j) Veterans' services organizations; and
37 (k) Other entities identified by the department by rule.

38 (3) The policy under subsection (2) of this section shall direct that program funds shall be used:

39 (a) To provide to low and very low income individuals, including but not limited to individuals
40 more than 65 years of age, persons with disabilities, agricultural workers and Native Americans:

41 (A) Emergency shelters and attendant services;

42 (B) Transitional housing services designed to assist individuals to make the transition from
43 homelessness to permanent housing and economic independence;

44 (C) Supportive housing services to enable individuals to continue living in their own homes or
45 to provide in-home services for such individuals for whom suitable programs do not exist in their

2 (D) Programs that provide emergency payment of home payments, rents or utilities; or

3 (E) Some or all of the *[needs]* **services or assistance** described in subparagraphs (A) to (D) of

5 **(b) To provide the services and assistance described in paragraph (a) of this subsection**
6 **to school-aged children enrolled in kindergarten through grade 12, or to their families, who**
7 **are homeless or at risk of becoming homeless.**

8 *[(b)]* (c) To align with federal strategies and resources that are available to prevent and end
9 homelessness, including the requirement of providing culturally responsive services and using
10 evidence-based and emerging practices effective in ending homelessness, including practices unique
11 to rural communities.

12 (4)(a) The council shall require as a condition of awarding a grant that the organization dem-
13 onstrate to the satisfaction of the council that the organization:

14 (A) Has the capacity to deliver any service proposed by the organization;

15 (B) Is a culturally responsive organization or is engaged in a process to become a culturally
16 responsive organization;

17 (C) Engages with culturally specific organizations; and

18 (D) Supports local homelessness system planning efforts.

19 (b) Any funds granted under this section may not be used to replace existing funds. Funds
20 granted under this section may be used to supplement existing funds. An organization may use funds
21 to support existing programs or to establish new programs.

22 (5) The department may expend funds from the account for:

23 (a) The administration of the account as provided for in the legislatively approved budget, as
24 that term is defined in ORS 291.002, for the department in support of directing a statewide policy
25 on homelessness that ensures use of evidence-based and emerging practices, service equity in fund-
26 ing and local planning processes.

27 (b) The development of technical assistance and training resources for organizations developing
28 and operating emergency shelters as defined in ORS 197.782 and transitional housing accommo-
29 dations as described in ORS 197.746.

30 (6) The department shall utilize outcome-oriented contracting processes and evidence-based and
31 emerging practices for account program funds, including evidence-based and emerging practices for
32 serving rural communities.

33 (7) Twenty-five percent of moneys deposited in the account pursuant to ORS 294.187 are dedi-
34 cated to the emergency housing assistance program for assistance to veterans who are homeless or
35 at risk of becoming homeless.

23 landlord or service processor, including a summons delivered under ORS 105.135 (3)(b).

25 on a termination notice for nonpayment if the court determines that:

26 (a) The landlord failed to deliver the notice as required under subsection (2) of this sec-

29 landlord's failure to reasonably participate with a rental assistance program; or

30 (c) The tenant has tendered or caused to be tendered rental assistance or any other

37 105.130, if the complaint for possession is dismissed under subsection (3)(c) of this section.
38 Payment of the fees is not a prerequisite for dismissal under subsection (3)(c) of this section.

The landlord shall give this notice no sooner than on the fifth day of the rental period, including the first day the rent is due.

(3) The notice described in this section must also specify the amount of rent that must be paid and the date and time by which the tenant must pay the rent to cure the nonpayment of rent.

(4) Payment by a tenant who has received a notice under this section is timely if mailed to the landlord within the period of the notice unless:

(a) The notice is served on the tenant:

(A) By personal delivery as provided in ORS 90.155 (1)(a); or

(B) By first class mail and attachment as provided in ORS 90.155 (1)(c);

(b) A written rental agreement and the notice expressly state that payment is to be made at a specified location that is either on the premises or at a place where the tenant has made all previous rent payments in person; and

(c) The place so specified is available to the tenant for payment throughout the period of the notice.

1 (A) The first day of the first tax year after the grant was received; or

2 (B) The date the housing is first occupied;

3 (d) May not be housing that is required to be provided as part of a labor contract made

15 (3) "Carport" means a stationary structure consisting of a roof with its supports and not more
16 than one wall, or storage cabinet substituting for a wall, and used for sheltering a motor vehicle.

17 (4) "Commission" means the Land Conservation and Development Commission.

18 (5) "Comprehensive plan" means a generalized, coordinated land use map and policy statement
19 of the governing body of a local government that interrelates all functional and natural systems and
20 activities relating to the use of lands, including but not limited to sewer and water systems, trans-
21 portation systems, educational facilities, recreational facilities, and natural resources and air and
22 water quality management programs. "Comprehensive" means all-inclusive, both in terms of the
23 geographic area covered and functional and natural activities and systems occurring in the area
24 covered by the plan. "General nature" means a summary of policies and proposals in broad catego-
25 ries and does not necessarily indicate specific locations of any area, activity or use. A plan is "co-
26 ordinated" when the needs of all levels of governments, semipublic and private agencies and the
27 citizens of Oregon have been considered and accommodated as much as possible. "Land" includes
28 water, both surface and subsurface, and the air.

29 (6) "Department" means the Department of Land Conservation and Development.

30 (7) "Director" means the Director of the Department of Land Conservation and Development.

31 (8) "Goals" means the mandatory statewide land use planning standards adopted by the com-
32 mission pursuant to ORS chapters 195, 196 and 197.

33 (9) "Guidelines" means suggested approaches designed to aid cities and counties in preparation,
34 adoption and implementation of comprehensive plans in compliance with goals and to aid state
35 agencies and special districts in the preparation, adoption and implementation of plans, programs
36 and regulations in compliance with goals. Guidelines [*shall be advisory and shall*] **are advisory and**
37 **do** not limit state agencies, cities, counties and special districts to a single approach.

38 (10) "Land use decision":

39 (a) Includes:

40 (A) A final decision or determination made by a local government or special district that con-
41 cerns the adoption, amendment or application of:

42 (i) The goals;

43 (ii) A comprehensive plan provision;

44 (iii) A land use regulation; or

45 (iv) A new land use regulation;

- 1 (B) A final decision or determination of a state agency other than the commission with respect
2 to which the agency is required to apply the goals; or
- 3 (C) A decision of a county planning commission made under ORS 433.763;
- 4 (b) Does not include a decision of a local government:
- 5 (A) That is made under land use standards that do not require interpretation or the exercise
6 of policy or legal judgment;
- 7 (B) That approves or denies a building permit issued under clear and objective land use stan-
8 dards;
- 9 (C) That is a limited land use decision;
- 10 (D) That determines final engineering design, construction, operation, maintenance, repair or
11 preservation of a transportation facility that is otherwise authorized by and consistent with the
12 comprehensive plan and land use regulations;
- 13 (E) That is an expedited land division as described in ORS 197.360;
- 14 (F) That approves, pursuant to ORS 480.450 (7), the siting, installation, maintenance or removal
15 of a liquefied petroleum gas container or receptacle regulated exclusively by the State Fire Marshal
16 under ORS 480.410 to 480.460;
- 17 (G) That approves or denies approval of a final subdivision or partition plat or that determines
18 whether a final subdivision or partition plat substantially conforms to the tentative subdivision or
19 partition plan; or
- 20 (H) That a proposed state agency action subject to ORS 197.180 (1) is compatible with the ac-
21 knowledged comprehensive plan and land use regulations implementing the plan, if:
- 22 (i) The local government has already made a land use decision authorizing a use or activity that
23 encompasses the proposed state agency action;
- 24 (ii) The use or activity that would be authorized, funded or undertaken by the proposed state
25 agency action is allowed without review under the acknowledged comprehensive plan and land use
26 regulations implementing the plan; or
- 27 (iii) The use or activity that would be authorized, funded or undertaken by the proposed state
28 agency action requires a future land use review under the acknowledged comprehensive plan and
29 land use regulations implementing the plan;
- 30 (c) Does not include a decision by a school district to close a school;
- 31 (d) Does not include, except as provided in ORS 215.213 (13)(c) or 215.283 (6)(c), authorization
32 of an outdoor mass gathering as defined in ORS 433.735, or other gathering of fewer than 3,000
33 persons that is not anticipated to continue for more than 120 hours in any three-month period; and
- 34 (e) Does not include:
- 35 (A) A writ of mandamus issued by a circuit court in accordance with ORS 215.429 or 227.179;
- 36 (B) Any local decision or action taken on an application subject to ORS 215.427 or 227.178 after
37 a petition for a writ of mandamus has been filed under ORS 215.429 or 227.179; or
- 38 (C) A state agency action subject to ORS 197.180 (1), if:
- 39 (i) The local government with land use jurisdiction over a use or activity that would be au-
40 thorized, funded or undertaken by the state agency as a result of the state agency action has already
41 made a land use decision approving the use or activity; or
- 42 (ii) A use or activity that would be authorized, funded or undertaken by the state agency as a
43 result of the state agency action is allowed without review under the acknowledged comprehensive
44 plan and land use regulations implementing the plan.
- 45 (11) "Land use regulation" means any local government zoning ordinance, land division ordi-

1 nance adopted under ORS 92.044 or 92.046 or similar general ordinance establishing standards for
2 implementing a comprehensive plan.

3 (12) "Limited land use decision":

4 (a) Means a final decision or determination made by a local government pertaining to a site
5 within an urban growth boundary that concerns:

6 (A) The approval or denial of a tentative subdivision or partition plan, as described in ORS
7 92.040 (1).

8 (B) The approval or denial of an application based on discretionary standards designed to reg-
9 ulate the physical characteristics of a use permitted outright, including but not limited to site re-
10 view and design review.

11 (b) Does not mean a final decision made by a local government pertaining to a site within an
12 urban growth boundary that concerns approval or denial of a final subdivision or partition plat or
13 that determines whether a final subdivision or partition plat substantially conforms to the tentative
14 subdivision or partition plan.

15 (13) "Local government" means any city, county or [*metropolitan service district formed under*
16 *ORS chapter 268*] **Metro** or an association of local governments performing land use planning func-
17 tions under ORS 195.025.

18 (14) "Metro" means a metropolitan service district organized under ORS chapter 268.

19 (15) "Metro planning goals and objectives" means the land use goals and objectives that [*a*
20 *metropolitan service district*] **Metro** may adopt under ORS 268.380 (1)(a). The goals and objectives
21 do not constitute a comprehensive plan.

22 (16) "Metro regional framework plan" means the regional framework plan required by the 1992
23 Metro Charter or its separate components. Neither the regional framework plan nor its individual
24 components constitute a comprehensive plan.

25 (17) "New land use regulation" means a land use regulation other than an amendment to an
26 acknowledged land use regulation adopted by a local government that already has a comprehensive
27 plan and land regulations acknowledged under ORS 197.251.

28 (18) "Person" means any individual, partnership, corporation, association, governmental subdivi-
29 sion or agency or public or private organization of any kind. The Land Conservation and Devel-
30 opment Commission or its designee is considered a person for purposes of appeal under ORS
31 chapters 195 and 197.

32 (19) "Special district" means any unit of local government, other than a city, county, [*metropol-*
33 *itan service district formed under ORS chapter 268*] **Metro** or an association of local governments
34 performing land use planning functions under ORS 195.025, authorized and regulated by statute and
35 includes but is not limited to water control districts, domestic water associations and water coop-
36 eratives, irrigation districts, port districts, regional air quality control authorities, fire districts,
37 school districts, hospital districts, mass transit districts and sanitary districts.

38 **(20) "Urban growth boundary" means an acknowledged urban growth boundary contained**
39 **in a city or county comprehensive plan or adopted by Metro under ORS 268.390 (3).**

40 [(20)] **(21)** "Urban unincorporated community" means an area designated in a county's ac-
41 knowledged comprehensive plan as an urban unincorporated community after December 5, 1994.

42 [(21)] **(22)** "Voluntary association of local governments" means a regional planning agency in
43 this state officially designated by the Governor pursuant to the federal Office of Management and
44 Budget Circular A-95 as a regional clearinghouse.

45 [(22)] **(23)** "Wetlands" means those areas that are inundated or saturated by surface or ground

1 water at a frequency and duration that are sufficient to support, and that under normal circum-
2 stances do support, a prevalence of vegetation typically adapted for life in saturated soil conditions.

24 growth boundary if land of higher priority is found to be inadequate to accommodate the amount

6 (5) The proposed hazardous waste or PCB treatment or disposal facility has no major adverse
7 effect on either:

8 (a) Public health and safety; or

9 (b) Environment of adjacent lands.

10 **SECTION 102.** ORS 527.755 is amended to read:

11 527.755. (1) The following highways are hereby designated as scenic highways for purposes of
12 the Oregon Forest Practices Act:

13 (a) Interstate Highways 5, 84, 205, 405; and

14 (b) State Highways 6, 7, 20, 18/22, 26, 27, 30, 31, 34, 35, 36, 38, 42, 58, 62, 66, 82, 97, 101, 126, 138,
15 140, 199, 230, 234 and 395.

16 (2) The purpose of designating scenic highways is to provide a limited mechanism that maintains
17 roadside trees for the enjoyment of the motoring public while traveling through forestland, consist-
18 ent with ORS 527.630, safety and other practical considerations.

19 (3) The State Board of Forestry, in consultation with the Department of Transportation, shall
20 establish procedures and regulations as necessary to implement the requirements of subsections (4),
21 (5) and (6) of this section, consistent with subsection (2) of this section, including provisions for al-
22 ternate plans. Alternate plans that modify or waive the requirements of subsection (4), (5) or (6) of
23 this section may be approved when, in the judgment of the State Forester, circumstances exist such
24 as:

25 (a) Modification or waiver is necessary to maintain motorist safety, protect improvements such
26 as dwellings and bridges, or protect forest health;

27 (b) Modification or waiver will provide additional scenic benefits to the motoring public, such
28 as exposure of distant scenic vistas;

29 (c) Trees that are otherwise required to be retained will not be visible to motorists;

30 (d) The operation involves a change of land use that is inconsistent with maintaining a visually
31 sensitive corridor; or

32 (e) The retention of timber in a visually sensitive corridor will result in severe economic hard-
33 ship for the owner because all or nearly all of the owner's property is within the visually sensitive
34 corridor.

35 (4)(a) For harvest operations within a visually sensitive corridor, at least 50 healthy trees of at
36 least 11 inches DBH, or that measure at least 40 square feet in basal area, shall be temporarily left
37 on each acre.

38 (b) Overstory trees initially required to be left under paragraph (a) of this subsection may be
39 removed when the reproduction understory reaches an average height of at least 10 feet and has
40 at least the minimum number of stems per acre of free to grow seedlings or saplings required by the
41 board for reforestation, by rule.

42 (c) Alternatively, when the adjacent stand, extending from 150 feet from the outermost edge of
43 the roadway to 300 feet from the outermost edge of the roadway, has attained an average height
44 of at least 10 feet and has at least the minimum number of stems per acre of free to grow seedlings
45 or saplings required by the board for reforestation, by rule, or at least 40 square feet of basal area

1 per acre, no trees are required to be left in the visually sensitive corridor, or trees initially required
2 to be left under paragraph (a) of this subsection may be removed. When harvests within the visually
3 sensitive corridor are carried out under this paragraph, the adjacent stand, extending from 150 feet
4 from the outermost edge of the roadway to 300 feet from the outermost edge of the roadway, shall
5 not be reduced below the minimum number of stems per acre of free to grow seedlings or saplings
6 at least 10 feet tall required by the board for reforestation, by rule, or below 40 square feet of basal
7 area per acre until the adjacent visually sensitive corridor has been reforested as required under
8 subsection (6) of this section and the stand has attained an average height of at least 10 feet and
9 has at least the minimum number of stems per acre.

10 (5) Harvest areas within a visually sensitive corridor shall be cleared of major harvest debris
11 within 30 days of the completion of the harvest, or within 60 days of the cessation of active har-
12 vesting activity on the site, regardless of whether the harvest operation is complete.

13 (6) Notwithstanding the time limits established in ORS 527.745 (1)(a), when harvesting within a
14 visually sensitive corridor results in a harvest type 1 or harvest type 3, reforestation shall be com-
15 pleted by the end of the first planting season after the completion of the harvest. All other pro-
16 visions of ORS 527.745 shall also apply to harvest type 1 or harvest type 3 within visually sensitive
17 corridors.

18 (7) Landowners and operators shall not be liable for injury or damage caused by trees left within
19 the visually sensitive corridor for purposes of fulfilling the requirements of this section, when car-
20 ried out in compliance with the provisions of the Oregon Forest Practices Act.

21 (8) The following are exempt from this section:

22 (a) Harvest on single ownerships less than five acres in size;

23 (b) Harvest within an urban growth boundary, as defined in ORS [195.060] **197.015**; and

24 (c) Harvest within zones designated for rural residential development pursuant to an exception
25 adopted to the statewide land use planning goals under ORS 197.732.

26 **SECTION 103.** Section 6, chapter 552, Oregon Laws 2021, is amended to read:

27 **Sec. 6.** (1) Notwithstanding ORS 197.286 to 197.314, 197.626 or 197A.320 or any statewide land
28 use planning goal related to housing or urbanization, the Department of Land Conservation and
29 Development shall approve an expansion of the urban growth boundary submitted by the city and
30 approved by the city by ordinance, if the department determines that:

31 (a) The department has received the letters required by section 4, **chapter 552, Oregon Laws**
32 **2021** [of this 2021 Act];

33 (b) The department has approved the city's conceptual plan under section 5, **chapter 552,**
34 **Oregon Laws 2021** [of this 2021 Act]; and

35 (c) The proposed urban growth boundary expansion adds all of the Stevens Road tract and no
36 other lands to the area within the city's urban growth boundary.

37 (2) The city shall include the lands brought within the city's urban growth boundary under this
38 section in the city's inventory of buildable lands under [ORS 197.296 (3)(a)] **section 22 of this 2023**
39 **Act.**

40 **SECTION 104.** Section 9, chapter 552, Oregon Laws 2021, is amended to read:

41 **Sec. 9.** (1) Notwithstanding ORS 197.250 or 197.612 or any statewide land use planning goal, the
42 Department of Land Conservation and Development shall approve Stevens Road planning amend-
43 ments provided the department determines, in its discretion, that the Stevens Road planning
44 amendments, with respect to the Stevens Road tract, include:

45 (a) An inventory of significant historical artifacts, cultural sites and natural resources.

1 (b) Areas designated for recreational and open space.

2 (c) Land use regulations for the protection and preservation of significant resources and desig-
3 nated areas identified in paragraphs (a) and (b) of this subsection.

4 (d) Land use regulations that comply with applicable wildfire planning and development re-
5 quirements, including requirements in regulations adopted to implement a statewide planning goal
6 relating to natural disasters and hazards.

7 (e) Areas designated for adequate employment lands that account for the city's most recent
8 economic opportunity analysis, including consideration of subsequent economic development activ-
9 ities and trends.

10 (f) Within areas zoned for residential purposes, without counting the lands designated under
11 subsection (2) of this section, land use regulations for housing that:

12 (A) Ensure adequate opportunities for the development of all needed housing types, sizes and
13 densities of market-rate housing, including middle housing as defined in ORS 197.758;

14 (B) Exceed the proportions of single-family attached and multifamily housing called for in the
15 city's most recently adopted housing needs analysis under ORS 197.296 (3) **(2021 Edition)**;

16 (C) Exceed a minimum density standard of nine residential units per gross residential acre; and

17 (D) On the date the Stevens Road planning amendments are approved, comply with land use
18 regulations adopted by the city, or any minimum applicable rules adopted by the department, to
19 implement ORS 197.758 and the amendments to ORS 197.312 by section 7, chapter 639, Oregon Laws
20 2019.

21 (g) Sufficient areas designated for mixed use development to support and integrate viable com-
22 mercial and residential uses along with transportation options, including walking, bicycling and
23 transit use.

24 (h) Land use regulations ensuring that:

25 (A) Adequate capacity is available, or feasible with development, for water, sewer and storm
26 water services; and

27 (B) Adequate consideration is given to the financing, scheduling and development of urban ser-
28 vices, as defined in ORS 195.065.

29 (i) Land use regulations for transportation that:

30 (A) Ensure the development of adequate infrastructure to support walking, bicycling, public
31 transit and motor vehicle movement; and

32 (B) Give adequate consideration to transportation networks that connect the Stevens Road tract
33 to other areas within the urban growth boundary of the city.

34 (j) The adequate consideration of the recommendations and comments received under section 8
35 (3) to (5), **chapter 552, Oregon Laws 2021** [*of this 2021 Act*].

36 (2) The department may not approve the planning amendments under subsection (1) of this sec-
37 tion unless the planning amendments designate at least 20 net acres of land to be:

38 (a) Restricted so the area may be zoned, planned, sited or developed only for residential housing
39 units at a minimum density of nine residential units per gross acre;

40 (b) Conveyed to the city at a price per acre established under section 4 (2)(b), **chapter 552,**
41 **Oregon Laws 2021** [*of this 2021 Act*]; and

42 (c) Notwithstanding ORS 91.225 or 197.309, preserved for a period of no less than 50 years as
43 affordable to own or rent as follows:

44 (A) At least 12 net acres made affordable to:

45 (i) Households with incomes of 60 percent or less of the area median income, as defined in ORS

1 456.270; or

2 (ii) If part of an income-averaging program approved by the Housing and Community Services
3 Department, households whose incomes average 60 percent or less of the area median income.

4 (B) At least six net acres:

5 (i) Made affordable to households with incomes of 80 percent or less of the area median income;
6 and

7 (ii) Made available, to the extent permitted by law, in a manner that gives a priority to house-
8 holds in which at least one individual is employed by an education provider over other members of
9 the public.

10 (C) At least two net acres in which at least 80 percent of the units in each contiguous devel-
11 opment tract are made affordable to households with 80 percent or less of the area median income,
12 of which at least one net acre is made available, to the extent permitted by law, in a manner that
13 gives a priority to households in which at least one individual is employed by an education provider
14 over other members of the public.

15 (3) Upon a partition or subdivision of the Stevens Road tract following the approval of the
16 planning amendments under subsection (1) of this section establishing one or more lots or parcels
17 described in subsection (2) of this section, the owner shall transfer those lots or parcels to the city.
18 For a period of 99 years after the purchase of property under this section, if the city resells any lot
19 or parcel, the city may recover only the city's costs of the purchase and resale of the property.

20 (4) Neither the city nor the Department of Land Conservation and Development is obligated to
21 adopt any specific findings or evaluate any specific criteria in exercising its discretion with respect
22 to any Stevens Road planning amendments under this section and may receive, solicit or consider
23 information from any source.

24 (5) As used in this section, "education provider" means a school district as defined in ORS
25 332.002, an educational program under the Youth Corrections Education Program or Juvenile De-
26 tention Education Program as both are defined in ORS 326.695, or an education service district as
27 defined in ORS 334.003.
