

HOUSE AMENDMENTS TO HOUSE BILL 2010

By JOINT COMMITTEE ON WAYS AND MEANS

June 13

1 In line 2 of the printed bill, after “water” insert “; creating new provisions; amending ORS
2 536.220, 537.767, 537.797, 537.798 and 541.669; and declaring an emergency”.

3 Delete lines 4 through 8 and insert:

4 **“SECTION 1. (1) As used in this section, ‘water supplier’ and ‘water system’ have the
5 meanings given those terms in ORS 448.115.**

6 **“(2) The Oregon Watershed Enhancement Board shall establish a program to provide
7 grants to water suppliers to protect, restore or enhance sources of drinking water.**

8 **“(3) Grants awarded under this section shall be used by a grant recipient for:**

9 **“(a) Acquiring lands from willing sellers where the protection, restoration or enhance-
10 ment of those lands will benefit a source of drinking water used by the water supplier;**

11 **“(b) Entering into covenants, easements or similar agreements to protect, restore or
12 enhance lands described in paragraph (a) of this subsection; or**

13 **“(c) Repaying a loan used to finance a project to protect, restore or enhance lands con-
14 sistent with paragraph (a) or (b) of this subsection.**

15 **“(4)(a) Grants awarded under this section may not exceed \$3,000,000.**

16 **“(b) The board shall award grants under this section on a rolling basis.**

17 **“(5) For purposes of obtaining a grant under this section, a water supplier may form a
18 partnership with a holder, as defined in ORS 271.715, other than a state agency. The board
19 may establish by rule requirements for partnerships formed pursuant to this subsection.**

20 **“(6) Applications for a grant under this section shall be made in the form and manner
21 prescribed by the board. An application must demonstrate that the project will protect, re-
22 store or enhance a source of drinking water, and must be supported by evidence. The board
23 shall review completed grant applications, rank grant applications based on criteria estab-
24 lished by the board by rule under subsection (7) of this section and approve or deny the ap-
25 plications. If the board denies a grant application, the board shall notify the applicant in
26 writing of the reason or reasons that the grant application was denied.**

27 **“(7) The board shall adopt rules for the administration of the grant program established
28 under this section. Rules adopted under this subsection may include, but need not be limited
29 to:**

30 **“(a) Eligibility criteria for water suppliers, including but not limited to:**

31 **“(A) Eligible water system types; and**

32 **“(B) Requirements that eligible water suppliers serve rural communities, communities
33 experiencing lower incomes or communities that are at or below a specified population level;**

34 **“(b) Requirements for grant applications and the grant application process;**

35 **“(c) Criteria for ranking grant applications;**

1 “(d) Requirements setting forth the amount of matching funds a grant applicant must
2 provide to be eligible to receive a grant;

3 “(e) A schedule for when grant applications are due and grants will be awarded; or

4 “(f) Provisions setting forth how the board will verify that grant funds have been used
5 for the purposes for which the grant was awarded, including but not limited to:

6 “(A) Provisions requiring status reports or other verification measures that ensure that
7 the terms and conditions of any agreement between the board and the grant recipient are
8 being performed;

9 “(B) Provisions describing methods of protecting, enhancing or restoring sources of
10 drinking water; and

11 “(C) Provisions requiring the development of a long-term management plan for acquired
12 lands.

13 “(8)(a) A grant recipient is responsible for fulfilling the terms and conditions of any
14 agreement:

15 “(A) Between the grant recipient and the board; and

16 “(B) Between the grant recipient and a landowner, or other person, necessary for the
17 grant recipient to carry out the project for which a grant has been awarded.

18 “(b) The board is not liable to any person for the failure of a grant recipient to fulfill the
19 terms or conditions of any agreement between the person and the grant recipient.

20 “SECTION 2. No later than April 1 of each even-numbered year, the Oregon Watershed
21 Enhancement Board shall submit a report, in the manner provided by ORS 192.254, to the
22 interim committees of the Legislative Assembly related to water. The report shall describe
23 the performance of the grant program established under section 1 of this 2023 Act. The re-
24 port must include, but need not be limited to:

25 “(1) Each grant awarded under the program since the last report;

26 “(2) The types and amounts of resources leveraged by grant moneys;

27 “(3) A description of projects currently in development;

28 “(4) An estimate of future project demand; and

29 “(5) Recommendations, if any, for changes to the design, scope or administration of the
30 program to better fulfill the purposes of section 1 of this 2023 Act.

31 “SECTION 3. Notwithstanding section 2 of this 2023 Act, the Oregon Watershed En-
32 hancement Board shall first submit a report under section 2 of this 2023 Act no later than
33 April 1, 2025.

34 “SECTION 4. The Community Drinking Water Enhancement and Protection Fund is es-
35 tablished in the State Treasury, separate and distinct from the General Fund. Interest
36 earned by the Community Drinking Water Enhancement and Protection Fund shall be cred-
37 ited to the fund. The fund shall consist of all moneys credited to the fund, including moneys
38 appropriated or transferred to the fund by the Legislative Assembly. Moneys in the fund are
39 continuously appropriated to the Oregon Watershed Enhancement Board for the purpose of
40 carrying out section 1 of this 2023 Act.

41 “SECTION 5. ORS 537.767 is amended to read:

42 “537.767. (1) As used in this section, ‘repair’ may include, but is not limited to, a well deepening.

43 “(2) Moneys in the Water Well Abandonment, Repair and Replacement Fund may be disbursed
44 under authority of the Water Resources Director for the purposes described in this section. The
45 Water Resources Department may disburse moneys from the fund to provide financial assistance:

1 “(a) To a person, as defined in ORS 536.007, or member of a federally recognized Indian tribe
2 in Oregon to permanently abandon a water well or to repair or replace a water well that is used
3 for household purposes;

4 “(b) To nonprofit, governmental or other institutions that meet qualifications established by
5 Water Resources Commission rules, for programs to permanently abandon water wells and to repair
6 or replace water wells used for household purposes;

7 “(c) As cost-sharing with other programs to permanently abandon water wells and to repair or
8 replace water wells used for household purposes; or

9 “(d) To pay the cost of direct services of a water well constructor licensed under ORS 537.747
10 to purchase necessary materials and perform the work needed for abandoning, repairing or replacing
11 water wells that are eligible under this section.

12 “(3) Except as provided in subsection (4) of this section, financial assistance provided under
13 subsection (2) of this section may not exceed:

14 “(a) 75 percent of the cost to permanently abandon a water well;

15 “(b) 75 percent of the cost to repair or to replace a water well used for household purposes; or

16 “(c) 50 percent of the cost of developing a program to permanently abandon, repair or replace
17 water wells, when paid to an institution described in subsection (2)(b) of this section.

18 “(4) Notwithstanding subsection (3) of this section, financial assistance provided under sub-
19 section (2) of this section to an individual with lower income, as defined by the department, may
20 cover the full cost of the materials or work described in subsection (2) of this section.

21 “(5) An expenditure from the fund is subject to at least one of the following purposes:

22 “(a) The permanent abandonment, repair or replacement of water wells in which deficiencies in
23 the well construction might:

24 “(A) Result in waste, loss of artesian pressure or ground water declines;

25 “(B) Serve as a conduit for contamination; or

26 “(C) Otherwise be a detriment to public health or safety.

27 “(b) The repair or replacement of water wells used for household purposes by persons of lower
28 or moderate income.

29 “(c) The replacement of water wells used for household purposes in areas of declining ground
30 water levels where other sources of water for household purposes are not feasible.

31 “(d) The abandonment, repair or replacement of water wells consistent with water resources
32 management purposes specified by rule by the commission.

33 “(e) The abandonment, repair or replacement of water wells damaged due to natural disasters.

34 “(f) **The abandonment, repair or replacement of water wells used for household purposes**
35 **in areas of ground water contamination, if contaminant levels in the water from the water**
36 **wells exceed levels permitted under drinking water standards.**

37 “(6) If the department provides funding to an institution under subsection (2)(b) of this section,
38 the department shall require that the institution:

39 “(a) Use accounting, auditing and fiscal procedures that conform with generally accepted gov-
40 ernment accounting standards;

41 “(b) Give preference to persons of lower or moderate income and to small businesses that do
42 not qualify for other financing;

43 “(c) Demonstrate past success in offering, underwriting, servicing and managing loans or grants
44 to:

45 “(A) Persons of lower or moderate income; or

1 “(B) Persons representing a wide range of qualifications for credit; and
2 “(d) Have a plan for engaging other stakeholders in outreach and marketing efforts for a loan
3 or grant program.
4 “(7) The department:
5 **“(a) Shall consult with the Department of Environmental Quality and the Oregon Health
6 Authority to establish criteria related to identifying areas of ground water contamination
7 and assessing contaminant levels when evaluating applications under subsection (5)(f) of this
8 section.**
9 **“(b) May deny applications for financial assistance under this section that are not likely
10 to result in the improvement of ground water quality or the meeting of drinking water
11 standards.**
12 “(c) May enter into contracts, intergovernmental agreements or other arrangements with public
13 or private entities for any purposes consistent with this section.
14 “(8) The commission may adopt rules to implement this section, including rules that:
15 “(a) Prioritize the issuance of the funding for a purpose described in subsection (5) of this sec-
16 tion.
17 “(b) Establish a preference for providing the funding to individuals of moderate or lower income.
18 “(c) Establish that the funding may only be provided to individuals of moderate or lower income.
19 **“SECTION 6. (1) On or before January 15, 2024, the Legislative Policy and Research Di-
20 rector, or a designee of the director, shall prepare and submit a report to a committee or
21 interim committee of the Legislative Assembly related to water on:**
22 **“(a) Processes and outcomes in Oregon related to recent federal funding opportunities
23 to assist low-income drinking water, wastewater and stormwater ratepayers.**
24 **“(b) Approaches and funding sources for an ongoing statewide assistance program for
25 low-income drinking water, wastewater and stormwater ratepayers.**
26 **“(c) Approaches and funding sources to help low-income individuals and households fi-
27 nance the replacement or repair of private residential drinking water and sewer
28 infrastructure.**
29 **“(d) Opportunities to leverage federal funds for the purposes described in paragraphs (b)
30 and (c) of this subsection.**
31 **“(2) In preparing the report, the director, or the designee of the director, shall consult
32 with individuals and entities with relevant knowledge from diverse geographies and perspec-
33 tives, such as:**
34 **“(a) Municipally and privately owned or operated drinking water and wastewater utility
35 providers of various sizes.**
36 **“(b) Organizations with experience in providing technical assistance to water and
37 wastewater utilities.**
38 **“(c) Organizations with experience in rate assistance or support for low-income drinking
39 water, wastewater or stormwater ratepayers.**
40 **“(d) Organizations representing cities, counties and special districts.**
41 **“(3) All state agencies shall assist and advise as requested by the director, or the
42 designee of the director, in order to undertake the duties described in subsections (1) and (2)
43 of this section.**
44 **“SECTION 7. On or before October 1, 2024, the Water Resources Department shall de-
45 velop, and provide to a committee or interim committee of the Legislative Assembly related**

1 to water, an updated scope and estimated cost and timeline for implementing the 1998
2 Stewardship and Supply Initiative and a proposed approach to sequencing development of
3 river basin assessment reports.

4 **“SECTION 8. (1) Oregon Consensus at Portland State University and Oregon State Uni-**
5 **versity shall establish a collaborative process for:**

6 **“(a) Developing a shared understanding of water management in the Chewaucan River**
7 **watershed; and**

8 **“(b) Identifying broadly supported actions related to the Chewaucan River watershed that**
9 **will strive to:**

10 **“(A) Meet water needs, including needs for agricultural operations, communities, Lake**
11 **Abert, wet meadows and fish and wildlife;**

12 **“(B) Address the ecological health of Lake Abert and the entire Chewaucan River**
13 **watershed; and**

14 **“(C) Consider social, economic and environmental benefits and impacts.**

15 **“(2) The process must be guided by a governance agreement that describes conditions for**
16 **participation, the scope of the collaborative process, how decisions will be made and how the**
17 **process will:**

18 **“(a) Be developed by a collaborative group that represents a balance of interests, in-**
19 **cluding but not limited to interests in in-stream and out-of-stream water;**

20 **“(b) Address current and future in-stream and out-of-stream water needs;**

21 **“(c) Promote contemplation of actions that are consistent with the state water resources**
22 **policy as defined in ORS 536.007 and water-related state laws that are in effect on the effec-**
23 **tive date of this 2023 Act;**

24 **“(d) Be developed through an open and transparent process that fosters public partic-**
25 **ipation; and**

26 **“(e) Be developed in consultation with the Department of Environmental Quality, the**
27 **State Department of Fish and Wildlife, the Water Resources Department and affected**
28 **federally recognized Indian tribes.**

29 **“(3) The process may not delay or preclude the activities of agencies, including activities**
30 **such as applying for in-stream water rights, regulating water use, managing water rights,**
31 **collecting water-related data and performing technical analyses.**

32 **“(4) The process may not interfere with water appropriations granted on or before the**
33 **effective date of this 2023 Act for privately held surface and ground water rights to use water**
34 **from the Chewaucan River watershed and the tributaries of the watershed.**

35 **“(5) The process may not delay or preclude the activities of private landowners, including**
36 **activities such as applying for new water rights, for water right transfer, for changes in**
37 **points of diversion or appropriation or for irrigation uses, or any other activities allowed**
38 **under water-related state laws.**

39 **“SECTION 9. Section 8 of this 2023 Act is repealed on June 30, 2025.**

40 **“SECTION 10. ORS 536.220 is amended to read:**

41 **“536.220. (1) The Legislative Assembly recognizes and declares that:**

42 **“(a) The maintenance of the present level of the economic and general welfare of the people of**
43 **this state and the future growth and development of this state for the increased economic and gen-**
44 **eral welfare of the people thereof are in large part dependent upon a proper utilization and control**
45 **of the water resources of this state, and such use and control is therefore a matter of greatest**

1 concern and highest priority.

2 “(b) A proper utilization and control of the water resources of this state can be achieved only
3 through a coordinated, integrated state water resources policy, through plans and programs for the
4 development of such water resources and through other activities designed to encourage, promote
5 and secure the maximum beneficial use and control of such water resources, all carried out by a
6 single state agency.

7 “(c) The economic and general welfare of the people of this state have been seriously impaired
8 and are in danger of further impairment by the exercise of some single-purpose power or influence
9 over the water resources of this state or portions thereof by each of a large number of public au-
10 thorities, and by an equally large number of legislative declarations by statute of single-purpose
11 policies with regard to such water resources, resulting in friction and duplication of activity among
12 such public authorities, in confusion as to what is primary and what is secondary beneficial use or
13 control of such water resources and in a consequent failure to utilize and control such water re-
14 sources for multiple purposes for the maximum beneficial use and control possible and necessary.

15 “(2) The Legislative Assembly, therefore, finds that:

16 “(a) It is in the interest of the public welfare that a coordinated, integrated state water re-
17 sources policy be formulated and means provided for its enforcement, that plans and programs for
18 the development and enlargement of the water resources of this state be devised and promoted and
19 that other activities designed to encourage, promote and secure the maximum beneficial use and
20 control of such water resources and the development of additional water supplies be carried out by
21 a single state agency that, in carrying out its functions, shall give proper and adequate consider-
22 ation to the multiple aspects of the beneficial use and control of such water resources with an im-
23 partiality of interest except that designed to best protect and promote the public welfare generally.

24 “(b) The state water resources policy shall be consistent with the goal set forth in ORS
25 468B.155.

26 “(3)[(a)] The Water Resources Department shall develop an integrated state water resources
27 strategy to implement the state water resources policy specified in subsection (2) of this section.
28 The department shall design the strategy to meet Oregon’s in-stream and out-of-stream water needs.

29 “[b)] (4) The Water Resources Department shall work in close cooperation with the Department
30 of Environmental Quality, **the Oregon Watershed Enhancement Board, the State Department**
31 **of Agriculture** and the State Department of Fish and Wildlife to develop the integrated state water
32 resources strategy, in consultation with other state, local and federal agencies, with other states,
33 with Indian tribes, with stakeholders and with the public.

34 “[c)] (5) The Water Resources Department, in close cooperation with the Department of Envi-
35 ronmental Quality, **the State Department of Agriculture** and the State Department of Fish and
36 Wildlife, shall develop data on an ongoing basis to forecast Oregon’s in-stream and out-of-stream
37 water needs, including but not limited to in-stream, [underground] **ground** water, human consump-
38 tion, **irrigated agriculture** and water supply needs, for the purpose of developing and updating the
39 integrated state water resources strategy.

40 “[d)] (6) The integrated state water resources strategy shall describe [the following]:

41 “[A)] (a) Oregon’s in-stream and out-of-stream water needs, including but not limited to
42 ecosystem services, water quality and water supply needs.

43 “(b) **Critical water issues at the state level and within water basins across this state.**

44 “[B)] (c) Objectives of the strategy.

45 “[C)] (d) Actions that are designed to achieve the objectives of the strategy.

1 “[D)] (e) Plans *[related to]* **and actions concerning water-related natural hazards and** the
2 challenges presented by climate change.

3 “[E)] (f) Provisions to ensure communication *[and partnership]* **and engagement with the**
4 **public.**

5 “(g) **Provisions to promote meaningful engagement with environmental justice commu-**
6 **nities, as defined in ORS 182.535, consistent with the requirements of ORS 182.545.**

7 “(h) **Provisions to promote partnerships with Indian tribes, public bodies, as defined in**
8 **ORS 174.109, and key stakeholders to implement recommended actions, as appropriate.**

9 “(i) **How the integrated state water resources strategy will be implemented at multiple**
10 **scales in a balanced, equitable and integrated manner.**

11 “(j) **How to support implementation of priority actions recommended in other relevant**
12 **state-developed or state-recognized plans or strategies.**

13 “[F)] (k) Specific functions and roles to be played by state agencies, including but not limited
14 **to the Department of Environmental Quality, the State Department of Fish and Wildlife,** the
15 State Department of Agriculture, the State Forestry Department, the Department of Human Ser-
16 vices, the Oregon Business Development Department, the Department of Land Conservation and
17 Development, the Oregon Watershed Enhancement Board, the State Parks and Recreation Depart-
18 ment, **the Oregon Health Authority,** the Department of State Lands and other relevant state
19 agencies, **along with provisions to achieve interagency coordination.**

20 “(L) **Provisions to achieve coordination with federal agencies and states that neighbor**
21 **Oregon.**

22 “[G)] (m) Public policy options and recommendations.

23 “[H)] (n) Relevant strategy factors, including but not limited to population growth and land use
24 change.

25 “[I)] (o) Recommendations *[of the Water Resources Department]* regarding the continuous moni-
26 toring of climate change effects on Oregon’s water supply and regarding water user actions that are
27 necessary to address climate change.

28 “(p) **Processes by which a biennial work plan will be developed and by which implemen-**
29 **tation of the work plan will be coordinated.**

30 “[e)](A) (7) **Before adopting or revising the integrated state water resources strategy,** the
31 Water Resources Commission shall give **notice to** the Environmental Quality Commission, **the**
32 **Oregon Watershed Enhancement Board,** the State *[Department]* **Board of Agriculture,** *[and]* the
33 State *[Department of]* **Fish and Wildlife Commission and any other agency referenced in the**
34 **strategy** *[notice of the integrated state water resources strategy prior to adoption of the strategy].* The
35 strategy, **and any revisions to the strategy,** shall take effect upon adoption by the Water Re-
36 sources Commission.

37 “[B)] (8) The Water Resources Commission shall review and update the integrated state water
38 resources strategy **at least** every *[five]* **eight** years. *[The Water Resources Commission shall give*
39 *notice to the Environmental Quality Commission, the State Department of Agriculture and the State*
40 *Department of Fish and Wildlife prior to adopting any revisions of the strategy. Revisions of the*
41 *strategy shall take effect upon the Water Resources Commission’s adoption of the revised strategy by*
42 *reference in rule.]*

43 “(9) **All agencies of state government, as defined in ORS 174.111, shall:**

44 “(a) **Assist the Water Resources Department, as requested, in performing the duties de-**
45 **scribed in this section; and**

1 “(b) Furnish information as necessary to develop, update and implement the integrated
2 state water resources strategy.

3 “[(4)] (10) This section does not limit the authority granted the Environmental Quality Com-
4 mission or the Department of Environmental Quality under ORS chapter 468B.

5 “**SECTION 11.** The amendments to ORS 536.220 by section 10 of this 2023 Act become
6 operative on the first date after the effective date of this 2023 Act on which the Water Re-
7 sources Commission adopts updates to the integrated state water resources strategy de-
8 scribed in ORS 536.220.

9 “**SECTION 12.** The Oregon State University Extension Service and the Oregon State
10 University Agricultural Experiment Station shall jointly establish an agricultural water
11 management technical assistance program. The technical assistance program shall be a vol-
12 untary, nonregulatory and incentive-based program that may include the following elements:

13 “(1) Staffing of agricultural water management specialists based in different regions of
14 this state who will be responsible for:

15 “(a) Building collaborative relationships with water and land managers; and

16 “(b) Developing research-based water management programs that utilize data collected
17 under subsection (6) of this section to provide publicly available statewide and regional tools
18 for water and land managers that foster regionally specific knowledge and expertise.

19 “(2) Connecting agricultural producers to information, resources, tools, programs, part-
20 ners, funding opportunities and other incentives to improve on-farm water management
21 practices and outcomes for the producers’ operations and water resources.

22 “(3) Creating a voluntary demonstration network of willing agricultural producers to de-
23 velop on-farm demonstration projects featuring water-related management practices that
24 yield quantifiable water quality and quantity benefits for the producers’ operations and water
25 resources and to promote the uptake of effective practices, including, but not limited to:

26 “(a) Modification of irrigation equipment;

27 “(b) Measurement and monitoring of water diversions and water use;

28 “(c) Use of data in decision-making;

29 “(d) Irrigation management practices;

30 “(e) Soil management practices;

31 “(f) Dryland farming practices;

32 “(g) Crop rotations and rotational grazing practices;

33 “(h) Temporary or permanent voluntary in-stream flow restoration, such as in-stream
34 leasing and split-season leasing, as described in ORS 537.348;

35 “(i) Use of the program for the allocation of conserved water established under ORS
36 537.455 to 537.500;

37 “(j) Novel water sharing agreements or arrangements that benefit other in-stream and
38 out-of-stream water uses;

39 “(k) Water reuse;

40 “(L) Effective use of state and federal programs;

41 “(m) Practices that restore and protect fish and wildlife habitat;

42 “(n) Practices that reduce energy use and costs;

43 “(o) Fish screening and fish passage; and

44 “(p) Experimentation with alternative crops and drought-resistant crops.

45 “(4) Identifying, studying and mitigating the effects of projects and practices imple-

1 mented under subsection (3) of this section on in-stream and out-of-stream water users and
2 uses, and conducting related outreach.

3 “(5) Organizing workshops and tours to promote innovative agricultural water manage-
4 ment practices.

5 “(6) Establishing and maintaining or supporting publicly available weather and irrigation
6 information systems designed to collect, process and make publicly available climate and
7 weather-related data and provide to agricultural producers tools that support increased
8 production, increased resilience to drought and flood events and the efficient management
9 of water resources.

10 “(7) In consultation with the Water Resources Department, contracting with an organ-
11 ization that provides publicly accessible, reproducible, satellite-based evapotranspiration data
12 using open science methods, open data services and an ensemble of well-established
13 evapotranspiration models to:

14 “(a) Support ongoing and reliable evapotranspiration data production and platform
15 maintenance for public use across this state;

16 “(b) Support data collection and technical analyses to improve the accuracy of the data
17 for different regions in Oregon; and

18 “(c) Conduct outreach to agricultural producers and other subject matter experts to
19 verify accuracy and increase usability of the data.

20 “(8) Partnering with agricultural producers and other subject matter experts to check
21 the accuracy of data, develop new tools, adapt available tools, experiment with new technol-
22 ogies and approaches and identify best management practices.

23 “(9) Performing and publishing research related to agricultural water management.

24 “(10) Developing and updating Oregon-specific guides, manuals and other resources, with
25 a focus on resources that will increase the likelihood of securing federal funding and assist-
26 ance for agricultural water management and increase the effective delivery of desired out-
27 comes.

28 “(11) Providing technical assistance to small farmers or ranchers in accessing state and
29 federal assistance programs, including but not limited to disaster assistance programs.

30 “**SECTION 13.** (1) To carry out the technical assistance program described in section 12
31 of this 2023 Act, the Oregon State University Extension Service and the Oregon State Uni-
32 versity Agricultural Experiment Station may:

33 “(a) Support the acquisition and maintenance of equipment necessary for the collection
34 of weather data, climate data and data related to agricultural water use and management,
35 including equipment that measures or monitors water supply, water diversions, water use
36 and evapotranspiration. Equipment may include, but need not be limited to:

37 “(A) AgriMet weather stations;

38 “(B) Other weather stations;

44 “(b) Form partnerships with agricultural producers to site data collection equipment and
45 use the data collected in on-farm management practices, with preference given to producers

1 that agree to develop on-farm demonstration projects, as described in section 12 (3) of this
2 2023 Act.

3 “(c) Form partnerships and enter into cost-sharing agreements with institutions capable
4 of maintaining data collection equipment and processing data, including, but not limited to,
5 the United States Geological Survey, the United States Bureau of Reclamation, the Natural
6 Resources Conservation Service of the United States Department of Agriculture, the Na-
7 tional Weather Service of the National Oceanic and Atmospheric Administration, the State
8 Department of Agriculture, the Water Resources Department, the State Department of Fish
9 and Wildlife, the Department of Environmental Quality, the Oregon Watershed Enhancement
10 Board, the Oregon Climate Service and soil and water conservation districts.

11 “(d) Convene statewide or region-specific advisory groups or working groups to advise
12 on any aspect of the program.

13 “(2) All data collected under subsection (1) of this section using public funds must be
14 made publicly available.

15 “(3) In establishing and maintaining the voluntary demonstration network described in
16 section 12 (3) of this 2023 Act, the Oregon State University Extension Service and the Oregon
17 State University Agricultural Experiment Station:

18 “(a) May receive and expend funds from any source to:

19 “(A) Design and implement demonstration projects under section 12 (3) of this 2023 Act;
20 or

21 “(B) Provide stipends to agricultural producers participating in the voluntary demon-
22 stration network described in section 12 (3) of this 2023 Act for time, equipment and related
23 expenses.

24 “(b) Shall prioritize projects that have the potential to increase drought resiliency and
25 provide quantifiable water quantity and quality benefits to other in-stream and out-of-stream
26 water users or uses.

23 “(H) Assesses actions that are compatible with local comprehensive plans;
24 “(I) Strives to integrate solutions to cost-effectively achieve multiple benefits;
25 “(J) Is consistent with the guiding principles of the integrated state water resources
26 strategy; and
27 “(K) Complies with the rules of the Water Resources Commission, including any rules
28 regarding the development of place-based integrated water resources plans.
29 “(f) ‘Place-based integrated water resources planning’ means a collaborative and inclusive
30 process that is designed to:
31 “(A) Gather information to develop a shared understanding of water resources and iden-
32 tify critical issues and knowledge gaps;
33 “(B) Examine the existing and future in-stream and out-of-stream water needs for peo-
34 ple, the economy and the environment;

32 **“SECTION 28. (1) The Oregon Business Development Department shall establish and ad-**
33 **minister the Aquifer Recharge Due Diligence Grant Program under which the Oregon**
34 **Infrastructure Finance Authority established under ORS 285A.096 may award due diligence**
35 **grants, in accordance with this section and section 29 of this 2023 Act, to public bodies listed**
36 **in subsection (2) of this section in order to fund activities set forth in subsection (3) of this**
37 **section.**

38 **“(2) Any of the following public bodies may apply for a due diligence grant under the**
39 **program in the manner prescribed under section 29 of this 2023 Act:**

40 **“(a) A municipal subdivision of this state.**

41 **“(b) A port organized under ORS chapter 777 or 778.**

42 **“(c) A district as defined in ORS 198.010.**

43 **“(d) An Oregon Indian tribe as defined in ORS 294.805.**

44 **“(e) A county.**

45 **“(3) The authority may award grants to fund any of the following due diligence activities**

1 related to aquifer recharge and aquifer storage and recovery:

2 “(a) Test pit construction.

3 “(b) Borings and soil sampling necessary to design recharge basin or aquifer storage and
4 recovery well size and location.

5 “(c) Aquifer modeling necessary to meet the standards for a request to the Water Re-
6 sources Department for a limited license under ORS 537.143 and 537.144 or to test aquifer
7 storage and recovery in accordance with testing criteria under ORS 537.505 to 537.534.

8 “(d) Design and engineering necessary to reach the final 50 percent of design and engi-
9 neering necessary to result in a biddable project for aquifer recharge basins, aquifer storage
10 and recovery wells and works, aquifer storage and recovery treatment systems and
11 conveyance works from water source to recharge site.

12 “(e) Sampling required by the Department of Environmental Quality to establish param-
13 eters for monitoring and sampling source water quality and aquifer water quality.

14 “(f) Monitoring and sampling plan development associated with limited license require-
15 ments of the Water Resources Department and the Department of Environmental Quality.

16 “(g) Applying for a limited license and public coordination.

17 “(4) All or a portion of the basin or aquifer to which a grant application relates must
18 have been:

19 “(a) Restrictively classified under ORS 536.340;

20 “(b) Withdrawn by the Water Resources Department from further groundwater appro-
21 priation under ORS 536.410; or

22 “(c) Designated as critical under statute or rule or order of the Water Resources Com-
23 mission or the Water Resources Department.

24 “(5) The Oregon Business Development Department may adopt any rules the department
25 considers necessary or convenient for the administration of this section and section 29 of
26 this 2023 Act.

27 “SECTION 29. (1) The governing body of a public body listed in section 28 of this 2023 Act
28 seeking a due diligence grant under this section and section 28 of this 2023 Act must submit
29 to the Oregon Business Development Department an application in the form and manner
30 prescribed by the department.

31 “(2) To qualify for a due diligence grant, an application must be accompanied by doc-
32 umentation satisfactory to the department that the following items have been completed or
33 are available for inspection:

34 “(a)(A) A United States Geological Survey ground water characterization model for the
35 targeted aquifer establishing a baseline of aquifer properties;

36 “(B) A peer-reviewed academic model for the targeted aquifer establishing a baseline of
37 aquifer properties; or

38 “(C) Documentation of agency-developed or publicly-developed reports determining that
39 the targeted aquifer is a potential candidate for recharge testing in order to prove that
40 baseline data exists to warrant additional due diligence for recharging the aquifer;

41 “(b) Documentation establishing that source water is available to conduct aquifer re-
42 charge testing at the targeted volume and rate of the test;

43 “(c) Documentation establishing that ground water use in the targeted aquifer has been
44 monitored and metered for at least five years immediately prior to the date on which the
45 application is submitted; and

1 “(d) Documentation showing that the basin or aquifer to which the application relates is
2 eligible under section 28 (4) of this 2023 Act.

3 “(3)(a) Once the department has determined that an application is complete, the depart-
4 ment shall approve or reject the application.

5 “(b) Rejection of an application does not preclude the governing body from reapplying at
6 any time with respect to the same or another basin or aquifer.

7 “(c) If the department approves an application, the Oregon Infrastructure Finance Au-
8 thority shall determine the amount of the grant award in accordance with subsection (4) of
9 this section and the department shall disburse the moneys to the applicant.

10 “(d) Rejection of an application and the amount of a grant award may not be appealed.

11 “(4) The authority may award grants in any amount that does not exceed the eligible due
12 diligence costs substantiated in the application.

13 “SECTION 30. (1) The Oregon Business Development Department shall establish and ad-
14 minister the Aquifer Recharge Testing Forgivable Loan Program under which the Oregon
15 Infrastructure Finance Authority may make forgivable loans, in accordance with this section
16 and section 31 of this 2023 Act, to public bodies listed in subsection (2) of this section in order
17 to fund the costs set forth in subsection (3) of this section.

18 “(2) Any of the following public bodies may apply for a forgivable loan under the program
19 in the manner prescribed under section 31 of this 2023 Act:

20 “(a) A municipal subdivision of this state.

21 “(b) A port organized under ORS chapter 777 or 778.

22 “(c) A district as defined in ORS 198.010.

23 “(d) An Oregon Indian tribe as defined in ORS 294.805.

24 “(e) A county.

25 “(3) The authority may make forgivable loans for any of the following costs related to
26 aquifer recharge and aquifer storage and recovery testing:

27 “(a) Energy costs.

28 “(b) Operation and maintenance costs associated with the treatment and delivery of
29 source water for the purposes of testing aquifer recharge or aquifer storage and recovery.

30 “(c) Monitoring and reporting costs required by the monitoring plan of a limited license.

31 “(4) All or a portion of the basin or aquifer to which a loan application relates must have
32 been:

33 “(a) Restrictively classified under ORS 536.340;

34 “(b) Withdrawn by the Water Resources Department from further groundwater appro-
35 priation under ORS 536.410; or

36 “(c) Designated as critical under statute or rule or order of the Water Resources Com-
37 mission or the Water Resources Department.

38 “(5) Forgivable loans shall be made under this section and section 31 of this 2023 Act in
39 a principal amount that does not exceed the costs set forth in the application over the period,
40 not to exceed five years, of the limited license issued by the Water Resources Department
41 under ORS 537.143 and 537.144 or 537.505 to 537.534 that is associated with the application
42 submitted under section 31 of this 2023 Act.

43 “(6) The Oregon Business Development Department may adopt any rules the department
44 considers necessary or convenient for the administration of this section and section 31 of
45 this 2023 Act.

1 **“SECTION 31. (1)(a) The governing body of a public body listed in section 30 of this 2023**
2 **Act seeking a forgivable loan under this section and section 30 of this 2023 Act must submit**
3 **to the Oregon Business Development Department an application in the form and manner**
4 **prescribed by the department.**

5 **“(b) To qualify for a forgivable loan, an application must be accompanied by documenta-**
6 **tion:**

7 **“(A) Of a valid limited license to conduct aquifer recharge testing or aquifer storage and**
8 **recovery testing at the site to which the application relates; and**

9 **“(B) That shows the basin or aquifer to which the application relates is eligible under**
10 **section 30 (4) of this 2023 Act.**

11 **“(2)(a) Once the department has determined that an application is complete, the depart-**
12 **ment shall approve or reject the application.**

13 **“(b) Rejection of an application does not preclude the governing body from reapplying at**
14 **any time with respect to the same or another basin or aquifer.**

15 **“(c) If the department approves an application, the Oregon Infrastructure Finance Au-**
16 **thority shall determine the amount of the forgivable loan in accordance with section 30 (5)**
17 **of this 2023 Act and the department shall duly negotiate a loan agreement with the applicant.**

18 **“(d) Rejection of an application and the amount of a forgivable loan may not be appealed.**

19 **“(3)(a) Upon completion of the activities for which the forgivable loan was made, the**
20 **governing body that received the loan must submit documentation satisfactory to the de-**
21 **partment that 100 percent of the water placed into the recharge went into the waters of this**
22 **state and was not recovered under a secondary use limited license or secondary use permit**
23 **obtained under ORS 537.534.**

24 **“(b) If the department is satisfied with the documentation, 100 percent of the amount of**
25 **the loan shall be forgiven.**

26 **“(c) If the department determines that water was used impermissibly within the terms**
27 **of paragraph (a) of this subsection, the department may require repayment of the loan in**
28 **an amount proportional to the percentage of the water that was used impermissibly, with**
29 **interest at a rate not to exceed five percent.**

30 **“(d) Loan amounts and interest repaid under paragraph (c) of this subsection shall be**
31 **credited to the Aquifer Recharge Fund established under section 33 of this 2023 Act.**

32 **“SECTION 32. Not later than September 15 of each year, the Oregon Business Develop-**
33 **ment Department and recipients of funding under sections 28 to 33 of this 2023 Act shall**
34 **prepare and submit a report, in the manner required under ORS 192.245, to the interim**
35 **committees of the Legislative Assembly related to water, detailing the use of the funding and**
36 **the results of the recharge testing so funded.**

37 **“SECTION 33. (1) The Aquifer Recharge Fund is established in the State Treasury, sep-**
38 **arate and distinct from the General Fund. Interest earned by the Aquifer Recharge Fund**
39 **shall be credited to the fund. All moneys in the fund are continuously appropriated to the**
40 **Oregon Business Development Department for the use of the Oregon Infrastructure Finance**
41 **Authority established under ORS 285A.096 to fulfill the purposes set forth in sections 28 to**
42 **33 of this 2023 Act.**

43 **“(2) The fund shall consist of all moneys credited to the fund, including but not limited**
44 **to:**

45 **“(a) Moneys appropriated, allocated, transferred or otherwise credited to the fund by the**

1 Legislative Assembly, the department or the authority;

2 “(b) Earnings received on moneys in the fund;

3 “(c) Repayment of financial assistance provided under sections 28 to 33 of this 2023 Act,
4 including interest;

5 “(d) Moneys transferred to the fund from the federal government, state agencies or local
6 governments; and

7 “(e) Moneys deposited in the fund from any other source, including, but not limited to,
8 grants and gifts.

9 “(3) The authority may directly or indirectly grant, expend or lend moneys in the fund
10 for the purposes set forth in sections 28 to 33 of this 2023 Act.

11 “(4)(a) The authority shall administer the fund.

12 “(b) The Oregon Business Development Department may adopt rules and policies for the
13 administration of the fund.

14 “SECTION 34. (1) Sections 28 to 33 of this 2023 Act are repealed on January 2, 2032.

15 “(2) Any moneys remaining in the Aquifer Recharge Fund established under section 33
16 of this 2023 Act on the date specified in subsection (1) of this section that are unexpended,
17 unobligated and not subject to any conditions shall be transferred to the Administrative
18 Services Economic Development Fund.

19 “SECTION 35. (1) As used in this section, ‘local workforce development board’ and
20 ‘workforce program’ have the meanings given those terms in ORS 660.300.

21 “(2) The Oregon Department of Administrative Services shall provide grants to soil and
22 water conservation districts organized under ORS 568.210 to 568.808 and 568.900 to 568.933 and
23 to counties for the treatment of western juniper to minimize the negative impacts of western
24 juniper on water resources and ecological health.

25 “(3) Grant recipients shall use grant funds only to:

26 “(a) Consistent with the requirements of this section, treat western juniper in areas
27 where treatment will provide the greatest benefit to water resources and ecological health;

28 “(b) Consistent with the requirements of this section, remove western juniper at times,
29 and using methods, that will reduce the risk of repropagation after removal; and

30 “(c) Cover the administrative expenses of the grant recipient related to the grant pro-
31 gram, except that no more than eight percent of grant funds may be used to cover admin-
32 istrative expenses.

33 “(4) In determining areas to conduct western juniper treatment, grant recipients shall
34 incorporate criteria from the western juniper management field guide developed by the
35 Oregon Watershed Enhancement Board, including:

36 “(a) Conifer encroachment prioritization;

37 “(b) Hydrological prioritization, including a consideration of the location of the proposed
38 project site in relation to surface waters;

39 “(c) Biological prioritization, including resilience to disturbance and resistance to exotic
40 annual grasses; and

41 “(d) Canopy interspaces, including bunchgrass age classes and exotic annual grasses or
42 noxious weeds present at intermediate levels in interspaces.

43 “(5) In selecting treatment project sites and conducting treatment, grant recipients shall
44 seek to retain old growth juniper trees, as determined by tree characteristics that include:

45 “(a) Flattened, rounded or uneven tops;

1 “(b) A spreading crown;
2 “(c) Large branches near the base of the tree;
3 “(d) Large, dead branches, missing bark and abundant light green lichen;
4 “(e) Thick fibrous bark with well-developed vertical furrows; and
5 “(f) Leader growth in the upper quarter of the tree that is less than one inch per year.
6 “(6) Treatment sites must be no less than 100 acres.
7 “(7) Pretreatment analysis of treatment sites must include:
8 “(a) Risk assessments for annual grass weeds; and
9 “(b) An analysis of existing perennial understory to determine if reseeding is required.
10 “(8) Fuel loads associated with western juniper treatment shall be removed from the
11 treatment site.
12 “(9) Any grazing plan for a treatment site must be developed in cooperation with the
13 landowner and the applicable soil and water conservation district.
14 “(10) A grant recipient shall develop a post-treatment maintenance plan for the treat-
15 ment site prior to beginning treatment.
16 “(11) Grant applicants may consult with Oregon State University, local governments, as
17 defined in ORS 174.116, conservation organizations or other organizations or experts to
18 identify areas that meet the criteria described in subsection (3)(a) of this section.
19 “(12) A grant recipient shall:
20 “(a) Work with Oregon State University to track and monitor the effects of the program
21 on water resources, ecological health and economic and workforce development and to pro-
22 vide quarterly and annual reports to the department;
23 “(b) Work with a local workforce development board or other organizations to create or
24 expand an existing workforce program that provides services to individuals performing
25 western juniper treatment or to allow individuals performing western juniper treatment to
26 participate in an existing workforce program; and
27 “(c)(A) Prepare reports describing any proposed, ongoing or completed western juniper
28 treatment project including:
29 “(i) Site conditions before treatment;
30 “(ii) Project methodologies and implementation;
31 “(iii) Site conditions and maintenance efforts after treatment; and
32 “(iv) An assessment of the effectiveness of the treatment.
33 “(B) A grant recipient shall submit the reports required under this paragraph to Oregon
34 State University no later than two and five years, respectively, after receiving a grant under
35 this section and shall make the reports publicly available.
36 “SECTION 36. (1) Oregon State University shall consult with recipients of grants under
37 section 35 of this 2023 Act to assist the recipients with establishing monitoring areas in
38 central Oregon, Harney County and Klamath County.
39 “(2) Monitoring must be conducted for a period of at least five years and must include:
40 “(a) Overstory and understory vegetation surveys to assess soil, water and vegetation
41 relationships; and
42 “(b) Monitoring of soil moisture, springflow, streamflow and weather.
43 “(3) Monitoring may include technological platforms or other systems to monitor
44 vegetative cover, perennial grass cover, annual grass cover or tree and shrub cover.
45 “SECTION 37. (1) The Oregon Department of Administrative Services shall provide a

1 grant to an organization formed pursuant to an intergovernmental agreement under ORS
2 chapter 190 that operates in at least three of the following counties:

3 “(a) Crook County;

4 “(b) Jefferson County;

5 “(c) Klamath County;

6 “(d) Deschutes County;

7 “(e) Harney County; or

8 “(f) Lake County.

9 “(2) The organization shall:

10 “(a) In rural areas of this state, coordinate efforts to identify and apply for sources of
11 funding for western juniper treatment, or other water conservation projects, among cities,
12 counties or other organizations; and

13 “(b) Coordinate activities among grant recipients described in section 36 of this 2023 Act.

14 “SECTION 38. The Oregon Department of Administrative Services shall provide the
15 grants described in section 35 of this 2023 Act no later than July 1, 2023, or 60 days after the
16 effective date of this 2023 Act, whichever is later.

17 “SECTION 39. Recipients of grants described in section 35 of this 2023 Act, as well as
18 organizations described in sections 37, 51 and 52 of this 2023 Act, may accept moneys from
19 state agencies, federal or private funds or grants or the Emergency Board, in addition to the
20 grants, for purposes described in sections 35 and 36 of this 2023 Act.

21 “SECTION 40. In addition to and not in lieu of any other appropriation, there is appro-
22 priated to the Oregon Watershed Enhancement Board, for the biennium beginning July 1,
23 2023, out of the General Fund, the amount of \$1,000,000, for deposit in the Community
24 Drinking Water Enhancement and Protection Fund established under section 4 of this 2023
25 Act.

26 “SECTION 41. In addition to and not in lieu of any other appropriation, there is appro-
27 priated to the Higher Education Coordinating Commission, for the biennium beginning July
28 1, 2023, out of the General Fund, the amount of \$420,000, for distribution to Oregon Consen-
29 sus at Portland State University, which must be used for the purposes described in section
30 8 of this 2023 Act and may be used for awarding grants and stipends to participants in the
31 collaborative process described in section 8 of this 2023 Act.

32 “SECTION 42. In addition to and not in lieu of any other appropriation, there is appro-
33 priated to the Higher Education Coordinating Commission, for the biennium beginning July
34 1, 2023, out of the General Fund, the amount of \$150,000, for distribution to Oregon State
35 University, which must be used for the purposes described in section 8 of this 2023 Act.

36 “SECTION 43. In addition to and not in lieu of any other appropriation, there is appro-
37 priated to the Water Resources Department, for the biennium beginning July 1, 2023, out of
38 the General Fund, the amount of \$254,870, which may be expended for:

39 “(1) Funding a staff position at the department; or

40 “(2) In consultation with Harney County Court, contracting with a qualified entity to:

41 “(a) Advise ground water users in the Greater Harney Valley Groundwater Area of Con-
42 cern, and other interested stakeholders that work on ground water management in the
43 Greater Harney Valley Groundwater Area of Concern, concerning voluntary agreements
44 among ground water users from the same ground water reservoir, as described in ORS
45 537.745;

1 “(b) Assess the opportunities and limitations of using the voluntary agreements in the
2 Greater Harney Valley Groundwater Area of Concern; and

3 “(c) Assist ground water users in the Greater Harney Valley Groundwater Area of Con-
4 cern with developing the voluntary agreements.

5 “SECTION 44. In addition to and not in lieu of any other appropriation, there is appro-
6 priated to the Water Resources Department, for the biennium beginning July 1, 2023, out of
7 the General Fund, the amount of \$2,000,000, for deposit in the Place-Based Water Planning
8 Fund established under section 15 of this 2023 Act.

9 “SECTION 45. In addition to and not in lieu of any other appropriation, there is appro-
10 priated to the Oregon Department of Administrative Services, for the biennium beginning
11 July 1, 2023, out of the General Fund, the amount of \$1,000,000, for distribution to the High
12 Desert Partnership:

13 “(1) To design and implement projects for restoring or maintaining wet meadow, wetland
14 and lake conditions for birds, farmers and ranchers on the Silvies River Floodplain, on the
15 Donner und Blitzen River Floodplain, at Malheur Lake and in the Malheur National Wildlife
16 Refuge;

17 “(2) For research and public engagement related to the projects described in subsection
18 (1) of this section; and

19 “(3) To support collaborative partnerships related to the projects described in subsection
20 (1) of this section.

21 “SECTION 46. In addition to and not in lieu of any other appropriation, there is appro-
22 priated to the Oregon Department of Administrative Services, for the biennium beginning
23 July 1, 2023, out of the General Fund, the amount of \$1,000,000, for purposes of implementing
24 section 24 of this 2023 Act.

25 “SECTION 47. In addition to and not in lieu of any other appropriation, there is appro-
26 priated to the Oregon Business Development Department, for the biennium beginning July
27 1, 2023, out of the General Fund, the amount of \$3,000,000, for deposit in the Aquifer Re-
28 charge Fund established under section 33 of this 2023 Act.

29 “SECTION 48. In addition to and not in lieu of any other appropriation, there is appro-
30 priated to the Oregon Department of Administrative Services, for the biennium beginning
31 July 1, 2023, out of the General Fund, the following amounts which may be expended for the
32 purposes of providing grants under section 35 of this 2023 Act, as follows:

33 “(1) \$850,000 for providing a grant to a soil and water conservation district located in
34 Crook County.

35 “(2) \$325,000 for providing a grant to a soil and water conservation district located in
36 Jefferson County.

37 “(3) \$125,000 for providing a grant to a soil and water conservation district located in
38 Klamath County.

39 “(4) \$125,000 for providing a grant to a soil and water conservation district located in
40 Deschutes County.

41 “(5) \$300,000 for providing a grant to soil and water conservation district located in
42 Harney County.

43 “(6) \$125,000 for providing a grant to a soil and water conservation district located in
44 Lake County.

45 “(7) \$300,000 for providing a grant to Wheeler County.

1 “SECTION 49. In addition to and not in lieu of any other appropriation, there is appro-
2 priated to the Oregon Department of Administrative Services, for the biennium beginning
3 July 1, 2023, out of the General Fund, the amount of \$85,000, which may be expended for the
4 purpose of carrying out section 37 of this 2023 Act.

5 “SECTION 50. In addition to and not in lieu of any other appropriation, there is appro-
6 priated to the Higher Education Coordinating Commission, for the biennium beginning July
7 1, 2023, out of the General Fund, the amount of \$365,000 for distribution to Oregon State
8 University for the purpose of carrying out the provisions of section 35 of this 2023 Act.

9 “SECTION 51. Notwithstanding any other law limiting expenditures, the amount of
10 \$1,000,000 is established, for the biennium beginning July 1, 2023, as the maximum limit for
11 payment of expenses by the Oregon Watershed Enhancement Board for the purpose of car-
12 rying out section 1 of this 2023 Act through use of funds from the Community Drinking
13 Water Enhancement and Protection Fund established by section 4 of this 2023 Act.

14 “SECTION 52. Notwithstanding any other provision of law, the General Fund appropri-
15 ation made to the Oregon Watershed Enhancement Board by section 1, chapter __, Oregon
16 Laws 2023 (Enrolled Senate Bill 5539), for the biennium beginning July 1, 2023, for operations,
17 is increased by \$247,049, for administering the provisions of sections 1 to 3 of this 2023 Act.

18 “SECTION 53. Notwithstanding any other provision of law, the General Fund appropri-
19 ation made to the Oregon Watershed Enhancement Board by section 1, chapter __, Oregon
20 Laws 2023 (Enrolled Senate Bill 5539), for the biennium beginning July 1, 2023, for operations,
21 is increased by \$77,940, for carrying out the provisions of section 11 of this 2023 Act and the
22 amendments to ORS 536.220 by section 10 of this 2023 Act.

23 “SECTION 54. Notwithstanding any other law limiting expenditures, the limitation on
24 expenditures established by section 4 (3), chapter __, Oregon Laws 2023 (Enrolled Senate
25 Bill 5524), for the biennium beginning July 1, 2023, as the maximum limit for payment of ex-
26 penses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding
27 lottery funds and federal funds, collected or received by the Oregon Business Development
28 Department, for infrastructure, is increased by \$3,000,000, for the purposes described in
29 sections 28 to 32 of this 2023 Act.

30 “SECTION 55. In addition to and not in lieu of any other appropriation, there is appro-
31 priated to the Oregon Business Development Department, for the biennium beginning July
32 1, 2023, out of the General Fund, the amount of \$271,188, for administering the Aquifer Re-
33 charge Testing Forgivable Loan Program established under section 30 of this 2023 Act.

34 “SECTION 56. Notwithstanding any other provision of law, the General Fund appropri-
35 ation made to the Higher Education Coordinating Commission by section 1 (10), chapter __,
36 Oregon Laws 2023 (Enrolled House Bill 5025), for the biennium beginning July 1, 2023, for
37 public university statewide public services, is increased by \$3,085,581, for distribution to
38 Oregon State University’s Southern Oregon Research and Extension Center to carry out the
39 provisions of sections 12 to 14 of this 2023 Act.

40 “SECTION 57. Notwithstanding any other provision of law, the General Fund appropri-
41 ation made to the Department of Environmental Quality by section 1 (2), chapter __, Oregon
42 Laws 2023 (Enrolled House Bill 5018), for the biennium beginning July 1, 2023, for water
43 quality, is increased by \$679,085, for carrying out the provisions of sections 16 and 22 of this
44 2023 Act.

45 “SECTION 58. Notwithstanding any other provision of law, the General Fund appropri-

1 ation made to the State Department of Agriculture by section 1 (3), chapter __, Oregon
2 Laws 2023 (Enrolled House Bill 5002), for the biennium beginning July 1, 2023, for natural
3 resources, is increased by \$269,762, for carrying out the provisions of section 16 of this 2023
4 Act.

5 “SECTION 59. Notwithstanding any other provision of law, the General Fund appropri-
6 ation made to the Water Resources Department by section 1 (5), chapter __, Oregon Laws
7 2023 (Enrolled House Bill 5043), for the biennium beginning July 1, 2023, for director’s office,
8 is increased by \$631,202, for carrying out the provisions of sections 5 to 11 and 15 to 27 of this
9 2023 Act.

10 “SECTION 60. Notwithstanding any other provision of law, the General Fund appropri-
11 ation made to the Water Resources Department by section 1 (1), chapter __, Oregon Laws
12 2023 (Enrolled House Bill 5043), for the biennium beginning July 1, 2023, for agency adminis-
13 tration, is increased by \$398,569, for carrying out the provisions of sections 6 to 9, 11, 15, 16
14 and 21 to 26 of this 2023 Act and the amendments to statutes by sections 5, 10, 17 to 20 and
15 27 of this 2023 Act.

16 “SECTION 61. Notwithstanding any other law limiting expenditures, the amount of
17 \$2,000,000 is established, for the biennium beginning July 1, 2023, as the maximum limit for
18 payment of expenses by the Water Resources Department for the purpose of carrying out
19 section 16 of this 2023 Act through use of funds from the Place-Based Water Planning Fund
20 established under section 15 of this 2023 Act.

21 “SECTION 62. This 2023 Act being necessary for the immediate preservation of the public
22 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
23 on its passage.”.
