SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Renames "board of property tax appeals" to "property value appeals board."

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 305.102 is amended to read:

9 305.102. The Department of Revenue shall adopt rules that it considers necessary to carry out
10 the provisions of chapter 459, Oregon Laws 1991, relating to Local Budget Law, appeals to [*boards*
11 *of property tax appeals*] **property value appeals boards**, administration of the property tax laws,
12 imposition and collection of taxes on property or compliance by local taxing officials with the re-
13 quirements of [*section 11b,*] Article XI, **section 11b**, of the Oregon Constitution.

14 **SECTION 2.** ORS 305.275 is amended to read:

15 305.275. (1) Any person may appeal under this subsection to the magistrate division of the
16 Oregon Tax Court as provided in ORS 305.280 and 305.560, if all of the following criteria are met:

17 (a) The person must be aggrieved by and affected by an act, omission, order or determination
18 of:

19 (A) The Department of Revenue in its administration of the revenue and tax laws of this state;

20 (B) A county [*board of property tax appeals*] **property value appeals board** other than an order
21 of the board;

22 (C) A county assessor or other county official, including but not limited to the denial of a claim
23 for exemption, the denial of special assessment under a special assessment statute, or the denial of
24 a claim for cancellation of assessment; or

25 (D) A tax collector.

26 (b) The act, omission, order or determination must affect the property of the person making the
27 appeal or property for which the person making the appeal holds an interest that obligates the
28 person to pay taxes imposed on the property. As used in this paragraph, an interest that obligates

1 the person to pay taxes includes a contract, lease or other intervening instrumentality.

2 (c) There is no other statutory right of appeal for the grievance.

3 (2) Except as otherwise provided by law, any person having a statutory right of appeal under
4 the revenue and tax laws of the state may appeal to the tax court as provided in ORS 305.404 to
5 305.560.

6 (3) If a taxpayer may appeal to the [*board of property tax appeals*] **property value appeals**
7 **board** under ORS 309.100, then no appeal may be allowed under this section. The appeal under this
8 section is from an order of the board as a result of the appeal filed under ORS 309.100 or from an
9 order of the board that certain corrections, additions to or changes in the roll be made.

10 (4) A county assessor who is aggrieved by an order of the county [*board of property tax*
11 *appeals*] **property value appeals board** may appeal from the order as provided in this section, ORS
12 305.280 and 305.560.

13 **SECTION 3.** ORS 305.280 is amended to read:

14 305.280. (1) Except as otherwise provided in this section, an appeal under ORS 305.275 (1) or (2)
15 shall be filed within 90 days after the act, omission, order or determination becomes actually known
16 to the person, but in no event later than one year after the act or omission has occurred, or the
17 order or determination has been made. An appeal under ORS 308.505 to 308.674 shall be filed within
18 90 days after the date the order is issued under ORS 308.584 (3). An appeal from a supervisory order
19 or other order or determination of the Department of Revenue shall be filed within 90 days after the
20 date a copy of the order or determination or notice of the order or determination has been served
21 upon the appealing party by mail as provided in ORS 306.805.

22 (2) An appeal under ORS 323.416 or 323.623 or from any notice of assessment or refund denial
23 issued by the Department of Revenue with respect to a tax imposed under ORS chapter 118, 308,
24 308A, 310, 314, 316, 317, 318, 321 or this chapter, or collected pursuant to ORS 305.620, shall be filed
25 within 90 days after the date of the notice. An appeal from a proposed adjustment under ORS
26 305.270 shall be filed within 90 days after the date the notice of adjustment is final.

27 (3) Notwithstanding subsection (2) of this section, an appeal from a notice of assessment of taxes
28 imposed under ORS chapter 314, 316, 317 or 318 may be filed within two years after the date the
29 amount of tax, as shown on the notice and including appropriate penalties and interest, is paid.

30 (4) Except as provided in subsection (2) of this section or as specifically provided in ORS chapter
31 321, an appeal to the tax court under ORS chapter 321 or from an order of a county [*board of*
32 *property tax appeals*] **property value appeals board** shall be filed within 30 days after the date of
33 the notice of the determination made by the department or date of mailing of the order, date of
34 publication of notice of the order, date the order is personally delivered to the taxpayer or date of
35 mailing of the notice of the order to the taxpayer, whichever is applicable.

36 (5) If the tax court denies an appeal made pursuant to this section on the grounds that it does
37 not meet the requirements of this section or ORS 305.275 or 305.560, the tax court shall issue a
38 written decision rejecting the petition and shall set forth in the decision the reasons the tax court
39 considered the appeal to be defective.

40 **SECTION 4.** ORS 305.425 is amended to read:

41 305.425. (1) All proceedings before the judge of the tax court shall be original, independent
42 proceedings and shall be tried without a jury and de novo.

43 (2) If a statute provides for an appeal to or a review by the court of an order, act, omission or
44 determination of the Department of Revenue, a [*board of property tax appeals*] **property value ap-**
45 **peals board** or of any other administrative agency, the proceeding shall be an original proceeding

1 in the nature of a suit in equity to set aside such order or determination or correct the act or
2 omission. The time within which the statute provides that the proceeding shall be brought is a pe-
3 riod of limitations and is not jurisdictional.

4 (3) All hearings and proceedings before the tax court judge shall be in accordance with the rules
5 of practice and procedure promulgated by the court, which shall conform, as far as practical to the
6 rules of equity practice and procedure in this state.

7 **SECTION 5.** ORS 305.525 is amended to read:

8 305.525. At the same time that a notice of assessment, letter of refund denial or determination
9 or an order of the [*board of property tax appeals*] **property value appeals board** is given to any
10 taxpayer, the Department of Revenue or [*board of property tax appeals*] **property value appeals**
11 **board**, as the case may be, shall in writing also notify the taxpayer of the right of the taxpayer to
12 appeal to the tax court under ORS 305.404 to 305.560.

13 **SECTION 6.** ORS 305.560 is amended to read:

14 305.560. (1)(a) Except for an order, or portion thereof, denying the discretionary waiver of pen-
15 alty or interest by the Department of Revenue, an appeal under ORS 305.275 may be taken by filing
16 a complaint with the clerk of the Oregon Tax Court at its principal office at Salem, Oregon, within
17 the time required under ORS 305.280.

18 (b) The clerk of the tax court shall serve copies of all complaints and petitions on the Depart-
19 ment of Revenue. Service upon the department shall be accomplished by the clerk of the tax court
20 filing the copy of the complaint with the Director of the Department of Revenue. Except as other-
21 wise provided by law, other service shall be accomplished as provided in the rules of practice and
22 procedure promulgated by the tax court.

23 (c)(A) The complaint shall be entitled in the name of the person filing the same as plaintiff and
24 the Department of Revenue, county, taxpayer or other person or entity as defendant. If the com-
25 plaint relates to value of property for ad valorem property tax purposes and the county has made
26 the appraisal, the complaint shall be entitled in the name of the person filing the same as plaintiff
27 and the county assessor as defendant.

28 (B) If any, a copy of the order of the department or [*board of property tax appeals*] **property**
29 **value appeals board** shall be attached to the complaint.

30 (2) The complaint shall state the nature of the plaintiff's interest, the facts showing how the
31 plaintiff is aggrieved and directly affected by the order, act, omission or determination and the
32 grounds upon which the plaintiff contends the order, act, omission or determination should be re-
33 versed or modified. A responsive pleading shall be required of the defendant.

34 (3) In any case in which the taxpayer is not the appealing party, a copy of the complaint shall
35 be served upon the taxpayer by the appealing party by certified mail within the period for filing an
36 appeal, and an affidavit showing such service shall be filed with the clerk of the tax court. A copy
37 of the order of the department, if any, shall be attached to the complaint. The taxpayer shall have
38 the right to appear and be heard.

39 (4)(a) At any time in the course of any appeal before the tax court, the department may inter-
40 vene as a matter of right. A copy of any order or judgment issued by the tax court in any case in
41 which the department is an intervenor shall be served upon the department in the manner provided
42 in subsection (1)(b) of this section.

43 (b) The tax court, in its discretion, may permit other interested persons to intervene by filing
44 a complaint in such manner and under such conditions as the court may deem appropriate.

45 **SECTION 7.** ORS 305.565 is amended to read:

1 305.565. (1) Except as provided in subsection (2) of this section, proceedings for the collection
2 of any taxes, interest or penalties resulting from an assessment of additional taxes imposed by ORS
3 chapter 118, 310, 314, 316, 317, 318, 321 or this chapter shall be stayed by the taking or pendency
4 of any appeal to the tax court.

5 (2) Notwithstanding subsection (1) of this section, the Department of Revenue may proceed to
6 collect any taxes, interest or penalties described in subsection (1) of this section if the department
7 determines that collection will be jeopardized if collection is delayed or that the taxpayer has taken
8 a frivolous position in the appeal. For purposes of this subsection:

9 (a) Collection of taxes, interest or penalties will be jeopardized if the taxpayer designs quickly
10 to depart from the state or to remove the taxpayer's property from the state, or to do any other act
11 tending to prejudice or to render wholly or partially ineffectual proceedings to collect the tax.

12 (b) A taxpayer's position in an appeal is frivolous if that position is of the kind described in ORS
13 316.992 (5).

14 (3) No proceeding for the apportionment, levy or collection of taxes on any property shall be
15 stayed by the taking or pendency of any appeal to the tax court, or from an order of the county
16 [*board of property tax appeals*] **property value appeals board** or the Oregon Tax Court, unless the
17 assessor or tax collector either as a party to the suit or an intervenor, requests a stay and it ap-
18 pears to the satisfaction of the court that a substantial public interest requires the issuance of a
19 stay.

20 (4) The tax court may, as a condition of a stay, require the posting of a bond sufficient to
21 guarantee payment of the tax. Payment of taxes while appeal is pending shall not operate as a
22 waiver of the appeal or of a right to refund of taxes found to be excessively charged or assessed.

23 **SECTION 8.** ORS 305.820 is amended to read:

24 305.820. (1) Any writing or remittance required by law to be filed with or made to the Depart-
25 ment of Revenue, county [*board of property tax appeals*] **property value appeals board**, county
26 assessor or tax collector (designated in this section as the "addressee") which is:

27 (a) Transmitted through the United States mail or by private express carrier, shall be deemed
28 filed or received on the date shown by the cancellation mark or other record of transmittal, or on
29 the date it was mailed or deposited if proof satisfactory to the addressee establishes that the actual
30 mailing or deposit occurred on an earlier date.

31 (b) Filed electronically pursuant to a rule of the department adopted under ORS 306.265 and
32 309.104 that authorizes the electronic filing and that meets the specifications and requirements of
33 the rule, shall be deemed to be filed and received on the date actually received by the addressee,
34 or on the date stated on the electronic acknowledgment of receipt that is sent by the addressee.

35 (c) Lost in transmission through the United States mail or private express carrier, shall be
36 deemed filed and received on the date it was mailed or deposited for transmittal if the sender:

37 (A) Can establish by competent evidence satisfactory to the addressee that the writing or re-
38 mittance was deposited on or before the date due for filing in the United States mail, or with a
39 private express carrier, and addressed correctly to the addressee; and

40 (B) Files with the addressee a duplicate of the lost writing or remittance within 30 days after
41 written notification is given by the addressee of its failure to receive such writing or remittance.

42 (2) Whenever any writing or remittance is required by law to be filed or made on a day which
43 falls on a Saturday, or on a Sunday or any legal holiday, the time specified shall be extended to
44 include the next business day.

45 (3) As used in this section:

1 (a) "Private express carrier" means a carrier described under ORS 293.660.

2 (b) "Writing or remittance" includes, but is not limited to, "report," "tax return," "claim for
3 credit," "claim for refund," "statement," "notice of appeal," "petition for review," "notice of
4 election," "documentary proof," a claim for exemption, a claim for deferral, a return of property, a
5 claim for cancellation of an assessment, an application for a special assessment, and remittances.

6 **SECTION 9.** ORS 306.120 is amended to read:

7 306.120. The Department of Revenue shall:

8 (1) Issue regulations, bulletins, manuals, instructions and directions to county assessors, county
9 [*boards of property tax appeals*] **property value appeals boards** and tax collectors as to the methods
10 best calculated to secure uniformity according to law, in the system of assessment and collection
11 of taxes.

12 (2) Carry on a continuing study with the object of equalizing for the purposes of assessment and
13 taxation property values within the counties and between the counties.

14 **SECTION 10.** ORS 306.125 is amended to read:

15 306.125. (1) The Department of Revenue is authorized to institute programs for the appraisal of
16 property in counties of the state and to make appraisals for the use of county assessors and [*boards*
17 *of property tax appeals*] **property value appeals boards** in assessing property and reviewing as-
18 sessment rolls, and may install, and assist in the preparation and maintenance of, maps, plats or
19 standardized record systems, as prescribed by the department, in the offices of assessors and tax
20 collectors.

21 (2) The department and county courts are authorized to enter into agreements for the sharing
22 of the expenses of such appraisals and installations including salaries and expenses of department
23 employees engaged therein.

24 (3) Counties entering into agreements pursuant to this section may pay to the Department of
25 Revenue from time to time:

26 (a) Moneys to be disbursed by the department as part of the county's share in the expenses
27 authorized under this section and agreed to under such agreements; and

28 (b) Moneys to reimburse the department where department disbursements under such agree-
29 ments, whether from the department's appropriations from the State General Fund or from moneys
30 credited to the Assessment and Taxation County Account, have exceeded its proportionate share of
31 expenses and a rebalancing of expense-sharing accounts is deemed desirable or necessary.

32 (4)(a) All moneys received by the Department of Revenue under subsection (3) of this section
33 shall be immediately turned over to the State Treasurer, who shall deposit the moneys in the Gen-
34 eral Fund to the credit of an account to be known as the Assessment and Taxation County Account,
35 and such account hereby is continuously appropriated to the Department of Revenue for the pur-
36 poses of this section and ORS 306.117.

37 (b) The Department of Revenue may use the moneys to the credit of the Assessment and Taxa-
38 tion County Account, or any part thereof, for expenditures in connection with appraisals and in-
39 stallations contracted for, including cash advances for travel and living expenses of employees, and
40 including payments to any county made to rebalance expense-sharing accounts, from time to time,
41 where a county's disbursements under agreements entered into pursuant to this section have ex-
42 ceeded its proportionate share of expenses under such agreement. Any moneys received in re-
43 imbursement of these cash advances shall be deposited in the Assessment and Taxation County
44 Account. Refunds of unexpended receipts may be made to the counties.

45 **SECTION 11.** ORS 306.152 is amended to read:

1 306.152. Once each year the Department of Revenue shall conduct a training session of not more
2 than four days' duration dedicated to the schooling of persons whose names appear in the pools
3 described in ORS 309.067 in the functions of the [*board of property tax appeals*] **property value**
4 **appeals board**.

5 **SECTION 12.** ORS 308.242 is amended to read:

6 308.242. (1) The assessor may not make changes in the roll after September 25 of each year ex-
7 cept as provided in subsections (2) and (3) of this section or as otherwise provided by law.

8 (2) After the assessment roll has been certified and on or before December 31, the assessor may
9 make changes in valuation judgment that result in a reduction in the value of property, if so re-
10 quested by the taxpayer or upon the assessor's own initiative. Corrections under this section to ac-
11 counts appraised by the Department of Revenue pursuant to ORS 306.126 and 308.505 to 308.674 may
12 not be made without the approval of the department.

13 (3)(a) If a petition for reduction has been filed with the [*board of property tax appeals*] **property**
14 **value appeals board**, the assessor may change the roll if the assessor and the petitioner stipulate
15 to a change in valuation judgment that results in a reduction in value. The stipulation may be made
16 at any time up until the convening of the board.

17 (b) Stipulations agreed to by the assessor and the petitioner under this subsection shall be de-
18 livered to the clerk of the board prior to the convening of the board.

19 (c) As used in this subsection, "stipulation" means a written agreement signed by the petitioner
20 and the assessor that specifies a reduction in value to be made to the assessment and tax roll.

21 (4) Any change in value made under subsection (2) or (3) of this section shall be made in the
22 manner specified in ORS 311.205 and 311.216 to 311.232.

23 **SECTION 13.** ORS 308.260 is amended to read:

24 308.260. (1) Any ship, vessel or other watercraft shall be assessed and taxed in the manner
25 provided in this section if:

26 (a) On or after January 1 of any assessment year, the ship, vessel or other watercraft is docked
27 or moored in any waters subject to the jurisdiction of the State of Oregon; and

28 (b) The ship, vessel or other watercraft is employed or used as a plant for the reduction or
29 processing, but excluding canning, of deep-sea fish.

30 (2) Immediately on docking or mooring, the owner or person in charge of a ship, vessel or other
31 watercraft described in subsection (1) of this section shall notify the county assessor. The county
32 assessor shall assess it, together with all machinery and equipment thereon, at its assessed value
33 determined under ORS 308.146 and 308.232. Upon determination of value, the owner or person in
34 charge shall:

35 (a) Pay the exact amount of taxes, special assessments, fees and charges, if the assessor is able
36 to compute the exact amount; or

37 (b) If the assessor is unable to compute the exact amount at the time the property is assessed,
38 either pay to the tax collector the amount estimated by the assessor to be needed to pay the taxes,
39 special assessments, fees and other charges to become due, or deposit with the tax collector a bond
40 with a good and sufficient undertaking in the amount that the assessor considers adequate to ensure
41 payment of the taxes to become due. The bond amount may not exceed twice the amount of the
42 taxes, special assessments, fees and other charges computed by the assessor under this subsection.

43 (3) It shall be unlawful to operate a floating reduction or processing plant until the county
44 assessor has been notified and the tax paid as provided in this section. If the owner or person in
45 charge fails to notify the assessor, or proceeds to operate the plant before full payment of the tax,

1 the owner or person in charge shall forfeit to the county, for the use of the several taxing juris-
2 dictions interested, a sum equal to twice the amount of the tax. The forfeiture may be recovered by
3 the assessor in an action brought in the name of the county in any court having jurisdiction over
4 the action. In the action, the penalty shall be preferred before all other debts or claims.

5 (4) No mistake in the name of the owner of any floating reduction or processing plant shall af-
6 fect the right to collect the tax or to recover the penalty under this section.

7 (5) The county assessor is authorized to levy, collect and remit to the tax collector, or the tax
8 collector is authorized to collect, taxes under conditions described in this section. Either the
9 assessor or tax collector is authorized to allow any discount or rebate otherwise provided by law
10 for payment of taxes before the regular due date or dates. ORS 311.370 shall apply to all taxes col-
11 lected before the regular due date or dates.

12 (6) Appeals of assessments of floating reduction or processing plants shall:

13 (a) Be heard by the county [*board of property tax appeals*] **property value appeals board** in the
14 same manner as assessments of other properties are appealed; and

15 (b) Be made as provided in ORS 308.146 and 308.232.

16 **SECTION 14.** ORS 308.295 is amended to read:

17 308.295. (1) Each person, business, firm, corporation or association required by ORS 308.290 to
18 file a return, other than a return reporting only taxable personal property, that has not filed a re-
19 turn within the time fixed in ORS 308.290, is delinquent.

20 (2) A delinquent taxpayer, except a taxpayer described in subsection (3) of this section, is sub-
21 ject to a penalty of \$1 for each \$1,000 (or fraction thereof) of assessed value of the property as de-
22 termined under ORS 308.146, but the penalty may not be less than \$10 or more than \$250.

23 (3) A delinquent taxpayer required by ORS 308.290 to file a return reporting state-appraised in-
24 dustrial property, as defined in ORS 306.126, is subject to a penalty of \$10 for each \$1,000 (or frac-
25 tion thereof) of assessed value of the property as determined under ORS 308.146, but the penalty
26 may not be less than \$10 or more than \$5,000.

27 (4) If a delinquency penalty provided in this section is imposed, the tax statement for the year
28 in which the penalty is imposed shall reflect the amount of the penalty and shall constitute notice
29 to the taxpayer.

30 (5)(a) Unless the penalty is the subject of an appeal under ORS 311.223, the county [*board of*
31 *property tax appeals*] **property value appeals board**, upon application of the taxpayer, may waive
32 the liability:

33 (A) For all or a portion of the penalty upon a proper showing of good and sufficient cause; or

34 (B) For all of the penalty if the year for which the return was filed was both the first year that
35 a return was required to be filed by the taxpayer and the first year for which the taxpayer filed a
36 return.

37 (b) Unless the taxpayer files a timely application in the same manner as an appeal under ORS
38 309.100, the board may not consider an application made under this subsection.

39 (c) An appeal may not be taken from the determination of the board under this subsection.

40 (6) If the board waives all or a portion of a penalty already imposed and entered on the roll, the
41 person in charge of the roll shall cancel the waived penalty and enter the cancellation on the roll
42 as an error correction under ORS 311.205 and, if the waived penalty has been paid, it shall be re-
43 funded without interest under ORS 311.806.

44 (7)(a) Upon application of the taxpayer, the assessor may waive the liability for property tax late
45 filing penalties under this subsection if the taxpayer:

1 (A) Has never filed a personal property tax return in this state;

2 (B) Has failed to file a property tax return for one or more consecutive years;

3 (C) Has not previously received relief from property tax late filing penalties under this sub-
4 section; and

5 (D) Files an application for relief from property tax late filing penalties that satisfies the re-
6 quirements of paragraph (b) of this subsection.

7 (b) An application for relief from property tax late filing penalties shall include a statement by
8 the taxpayer setting forth the basis for relief from property tax late filing penalties and a statement
9 under oath or affirmation that the basis for relief from property tax late filing penalties as stated
10 in the application is true.

11 (c) The county assessor may allow the application for relief from property tax late filing penal-
12 ties if the assessor finds the reasons given by the taxpayer in the application are sufficient to excuse
13 the failure to file the property tax returns at issue in the application. If the assessor allows the
14 application, the assessor may deny or grant relief from property tax late filing penalties in whole
15 or in part. The determination of the assessor whether to grant the application or deny the applica-
16 tion in whole or in part and whether to permit the taxpayer to pay the owing tax penalties, if any,
17 in installments is final. The assessor shall notify the taxpayer of the decision.

18 (d) Nothing in this subsection affects the obligation of the taxpayer to file property tax returns
19 or to pay property taxes owing from the current or delinquent tax years.

20 **SECTION 15.** ORS 308.296 is amended to read:

21 308.296. (1) Each person, business, firm, corporation or association required by ORS 308.290 to
22 file a return reporting only taxable personal property, that has not filed a return within the time
23 fixed in ORS 308.290, shall be subject to a penalty as provided in this section.

24 (2) A taxpayer who files a return to which this section applies after March 15, but on or before
25 June 1, is subject to a penalty equal to five percent of the tax attributable to the taxable personal
26 property of the taxpayer.

27 (3) A taxpayer who files a return to which this section applies after June 1, but on or before
28 August 1, is subject to a penalty equal to 25 percent of the tax attributable to the taxable personal
29 property of the taxpayer.

30 (4) A taxpayer who files a return to which this section applies after August 1, or who fails to
31 file a return, shall be subject to a penalty equal to 50 percent of the tax attributable to the taxable
32 personal property of the taxpayer.

33 (5) If a delinquency penalty provided in this section is imposed, the tax statement for the year
34 in which the penalty is imposed shall reflect the amount of the penalty and shall constitute notice
35 to the taxpayer.

36 (6)(a) Unless the penalty is the subject of an appeal under ORS 311.223, the county [*board of*
37 *property tax appeals*] **property value appeals board**, upon application of the taxpayer, may waive
38 the liability:

39 (A) For all or a portion of the penalty upon a proper showing of good and sufficient cause; or

40 (B) For all of the penalty if the year for which the return was filed was both the first year that
41 a return was required to be filed by the taxpayer and the first year for which the taxpayer filed a
42 return.

43 (b) Unless the taxpayer files a timely application in the same manner as an appeal under ORS
44 309.100, the board may not consider an application made under this subsection.

45 (c) An appeal may not be taken from the determination of the board under this subsection.

1 (7) If the board waives all or a portion of a penalty already imposed and entered on the roll, the
2 person in charge of the roll shall cancel the waived penalty and enter the cancellation on the roll
3 as an error correction under ORS 311.205 and, if the waived penalty has been paid, it shall be re-
4 funded without interest under ORS 311.806.

5 (8)(a) Upon application of the taxpayer, the assessor may waive the liability for property tax late
6 filing penalties under this subsection if the taxpayer:

7 (A) Has never filed a personal property tax return in this state;

8 (B) Has failed to file a property tax return for one or more consecutive years;

9 (C) Has not previously received relief from property tax late filing penalties under this sub-

2 shall notify the owner of the plant by mail, return receipt requested, of the intention to physically
3 appraise the plant. The notice shall inform the owner of the date the appraisal is to commence. In
4 commencing the appraisal and to aid the owner in making an election under subsection (2) of this

7 **SECTION 41.** (1) **The amendments to statutes by sections 1 to 40 of this 2023 Act are**
8 **intended to change the name of the “board of property tax appeals” to the “property value**
9 **appeals board.”**

10 (2) **For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel**
11 **may substitute for words designating the “board of property tax appeals,” wherever they**
12 **occur in statutory law, other words designating the “property value appeals board.”**

13 **SECTION 42.** **Section 41 of this 2023 Act is repealed on January 2, 2034.**

14 **SECTION 43.** (1) **The amendments to statutes by sections 1 to 40 of this 2023 Act become**
15 **operative on July 1, 2024.**

16 (2) **The Department of Revenue, any board of property tax appeals or any county assessor**
17 **or other county official may take any action before the operative date specified in subsection**
18 **(1) of this section that is necessary to enable timely compliance with the amendments to**
19 **statutes by sections 1 to 40 of this 2023 Act.**
