10	(2) The amendments to ORS 308.671 by section 4, chapter 23, Oregon Laws 2015, apply to prop
11	erty tax years beginning on or after July 1, 2016.
12	(3) ORS 308.674 applies to property tax years beginning on or after July 1, 2016, and before July
13	1, [2025] <b>2032</b> .
