

House Bill 2074

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Revenue for Representative Nancy Nathanson)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law.

Takes effect on 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 178.300, as amended by section 1, chapter 83, Oregon Laws 2022, is amended
9 to read:

10 178.300. As used in ORS 178.300 to 178.360:

11 (1) "Account" means an individual account established in accordance with ORS 178.300 to
12 178.360.

13 (2) "Account owner" means the person who has the right to withdraw funds from the account.
14 The account owner may also be the designated beneficiary of the account.

15 (3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

16 (4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated
17 at the time the account is opened as having the right to receive a qualified withdrawal for the
18 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-
19 cordance with ORS 178.350, the replacement.

20 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,
21 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a
22 mutual fund, an investment firm or other similar entity authorized to do business in this state.

23 (6) "Higher education institution" means an eligible education institution as defined in section
24 529(e)(5) of the Internal Revenue Code.

25 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect
26 on December 31, [2021] **2022**.

27 (8) "Member of the family" shall have the same meaning as contained in section 529(e) of the
28 Internal Revenue Code.

29 (9) "Network" means the Oregon 529 Savings Network established under ORS 178.305.

30 (10) "Nonqualified withdrawal" means a withdrawal from an account that is not a qualified

1 withdrawal.

2 (11) “Qualified higher education expenses” means tuition and other permitted expenses as set
 3 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated
 4 beneficiary at a higher education institution, expenses associated with registered apprenticeship
 5 programs described in section 529(c)(8) of the Internal Revenue Code and amounts paid as principal
 6 or interest on a qualified education loan to the extent allowed under section 529(c)(9) of the Internal
 7 Revenue Code.

8 (12) “Qualified withdrawal” means a withdrawal made as prescribed under ORS 178.355 and
 9 made:

10 (a) From an account to pay the qualified higher education expenses of the designated benefi-
 11 ciary;

12 (b) As the result of the death or disability of the designated beneficiary;

13 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)
 14 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the
 15 extent of the amount of the scholarship, allowance or payment; or

16 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

17 **SECTION 2.** ORS 178.375, as amended by section 2, chapter 83, Oregon Laws 2022, is amended
 18 to read:

19 178.375. As used in this section and ORS 178.380 and 178.385:

20 (1) “ABLE account” means an account established by an eligible individual, owned by the eli-
 21 gible individual and maintained under the qualified ABLE program established by the Oregon 529
 22 Savings Board under ORS 178.380.

23 (2) “ABLE Act” means the Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014
 24 (Division B of P.L. 113-295).

25 (3) “Designated beneficiary” has the same meaning as contained in section 529A of the Internal
 26 Revenue Code.

27 (4) “Eligible individual” has the same meaning as contained in section 529A of the Internal Re-
 28 venue Code.

29 (5) “Internal Revenue Code” means the federal Internal Revenue Code as amended and in effect
 30 on December 31, [2021] **2022**.

31 (6) “Qualified disability expense” has the same meaning as contained in section 529A of the
 32 Internal Revenue Code.

33 **SECTION 3.** ORS 238A.005, as amended by section 3, chapter 83, Oregon Laws 2022, is amended
 34 to read:

35 238A.005. For the purposes of this chapter:

36 (1) “Active member” means a member of the pension program or the individual account program
 37 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

38 (2) “Actuarial equivalent” means a payment or series of payments having the same value as the
 39 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
 40 sumptions adopted by the board.

41 (3) “Board” means the Public Employees Retirement Board.

42 (4) “Eligible employee” means a person who performs services for a participating public em-
 43 ployer, including persons considered employees of a participating public employer under 26 U.S.C.
 44 3121(d)(2), as in effect on January 1, [2022] **2023**, and elected officials other than judges. “Eligible
 45 employee” does not include:

- 1 (a) Persons engaged as independent contractors;
 - 2 (b) Aliens working under a training or educational visa;
 - 3 (c) Persons provided sheltered employment or make-work by a public employer;
 - 4 (d) Persons categorized by a participating public employer as student employees;
 - 5 (e) Any person who is in custody in a state institution;
 - 6 (f) Employees of foreign trade offices of the Oregon Business Development Department who live
7 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);
 - 8 (g) An employee actively participating in an alternative retirement program established under
9 ORS 353.250 or an optional retirement plan established under ORS 341.551;
 - 10 (h) Employees of a public university listed in ORS 352.002 who are actively participating in an
11 optional retirement plan offered under ORS 243.815;
 - 12 (i) Persons employed in positions classified as post-doctoral scholar positions by a public uni-
13 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370;
 - 14 (j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
15 for membership in the system under the provisions of ORS chapter 238 or other law;
 - 16 (k) Any person who belongs to a class of employees who are not eligible to become members
17 of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);
 - 18 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who
19 continues to receive retirement benefits while employed; and
 - 20 (m) Judges.
- 21 (5) "Firefighter" means:
- 22 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
23 duties include the fighting of fires;
 - 24 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;
 - 25 (c) An employee of the State Fire Marshal whose primary duties include fire investigation, fire
26 prevention, fire safety, fire control or fire suppression;
 - 27 (d) An employee of the State Forestry Department who is certified by the State Forester as a
28 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
29 fires as described in ORS 477.064; and
 - 30 (e) An employee of the Oregon Military Department whose primary duties include fighting
31 structural, aircraft, wildland or other fires.
- 32 (6) "Fund" means the Public Employees Retirement Fund.
- 33 (7)(a) "Hour of service" means:
- 34 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
35 by a participating public employer for performance of duties in a qualifying position; and
 - 36 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
37 during which an employee does not perform duties but for which the employee is directly or indi-
38 rectly paid or entitled to payment by a participating public employer for services in a qualifying
39 position, as long as the hour is within the number of hours regularly scheduled for the performance
40 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
41 thorized leave.
- 42 (b) "Hour of service" does not include any hour for which payment is made or due under a plan
43 maintained solely for the purpose of complying with applicable unemployment compensation laws.
- 44 (8) "Inactive member" means a member of the pension program or the individual account pro-
45 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who

1 is not a retired member and who is not employed in a qualifying position.

2 (9) "Individual account program" means the defined contribution individual account program of
 3 the Oregon Public Service Retirement Plan established under ORS 238A.025.

4 (10) "Institution of higher education" means a public university listed in ORS 352.002, the
 5 Oregon Health and Science University or a community college, as defined in ORS 341.005.

6 (11) "Member" means an eligible employee who has established membership in the pension pro-
 7 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
 8 membership has not been terminated under ORS 238A.110 or 238A.310.

9 (12) "Participating public employer" means a public employer as defined in ORS 238.005 that
 10 provides retirement benefits for employees of the public employer under the system.

11 (13) "Pension program" means the defined benefit pension program of the Oregon Public Service
 12 Retirement Plan established under ORS 238A.025.

13 (14) "Police officer" means a police officer as described in ORS 238.005.

14 (15) "Qualifying position" means one or more jobs with one or more participating public em-
 15 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,
 16 excluding any service in a job for which benefits are not provided under the Oregon Public Service
 17 Retirement Plan pursuant to ORS 238A.070 (2).

18 (16) "Retired member" means a pension program member who is receiving a pension as provided
 19 in ORS 238A.180 to 238A.195.

20 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the
 21 participating public employer, including remuneration in the form of living quarters, board or other
 22 items of value, to the extent the remuneration is, or would be if the member were an Oregon resi-
 23 dent, includable in the employee's taxable income under Oregon law. "Salary" includes the addi-
 24 tional amounts specified in paragraph (b) of this subsection, but does not include the amounts
 25 specified in paragraph (c) of this subsection, regardless of whether those amounts are includable in
 26 taxable income.

27 (b) "Salary" includes the following amounts:

28 (A) Payments of employee and employer money into a deferred compensation plan that are made
 29 at the election of the employee.

30 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
 31 employee.

32 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
 33 plan by the employer at the election of the employee and that is not includable in the taxable in-
 34 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2021]
 35 **2022.**

36 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
 37 election of the employee and that is not included in the taxable income of the employee by reason
 38 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2021] **2022.**

39 (E) Retroactive payments described in ORS 238.008.

40 (F) The amount of an employee contribution to the individual account program that is paid by
 41 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
 42 (1) and (2)(a).

43 (G) The amount of an employee contribution to the individual account program that is not paid
 44 by the employer under ORS 238A.335.

45 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS

1 652.190.

2 (c) "Salary" does not include the following amounts:

3 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
4 employer.

5 (B) Payments made on account of an employee's death.

6 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
7 leave.

8 (D) Any severance payment, accelerated payment of an employment contract for a future period
9 or advance against future wages.

10 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

11 (F) Payment for a leave of absence after the date the employer and employee have agreed that
12 no future services in a qualifying position will be performed.

13 (G) Payments for instructional services rendered to public universities listed in ORS 352.002 or
14 the Oregon Health and Science University when those services are in excess of full-time employment
15 subject to this chapter. A person employed under a contract for less than 12 months is subject to
16 this subparagraph only for the months covered by the contract.

17 (H) The amount of an employee contribution to the individual account program that is paid by
18 the employer and is not deducted from the compensation of the employee, as provided under ORS
19 238A.335 (1) and (2)(b).

20 (I) Compensation described and authorized under ORS 341.556 that is not paid by the community
21 college employing the faculty member.

22 (J) Compensation described and authorized under ORS 352.232 that is not paid by the public
23 university employing the officer or employee.

24 (K) Compensation described and authorized under ORS 353.270 that is not paid by Oregon
25 Health and Science University.

26 (L) For years before 2020, any amount in excess of \$200,000 for a calendar year. If any period
27 over which salary is determined is less than 12 months, the \$200,000 limitation for that period shall
28 be multiplied by a fraction, the numerator of which is the number of months in the determination
29 period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit
30 to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.

31 (M) For years beginning on or after January 1, 2020, any amount in excess of \$195,000 for a
32 calendar year. If any period over which salary is determined is less than 12 months, the \$195,000
33 limitation for that period shall be multiplied by a fraction, the numerator of which is the number
34 of months in the determination period and the denominator of which is 12. On January 1 of each
35 year, the board shall adjust the dollar limit provided by this subparagraph to reflect any percentage
36 changes in the Consumer Price Index for All Urban Consumers, West Region (All Items), as pub-
37 lished by the Bureau of Labor Statistics of the United States Department of Labor.

38 (18) "System" means the Public Employees Retirement System.

39 (19) "Workers' compensation benefits" means:

40 (a) Payments made under ORS chapter 656; or

41 (b) Payments provided in lieu of workers' compensation benefits under ORS 656.027 (6).

42 **SECTION 4.** ORS 238A.125, as amended by section 4, chapter 83, Oregon Laws 2022, is amended
43 to read:

44 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
45 be paid an annual pension for the life of the member as follows:

1 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
 2 by the number of years of retirement credit attributable to service as a police officer or firefighter.

3 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
 4 multiplied by the number of years of retirement credit attributable to service as other than a police
 5 officer or firefighter.

6 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the annual benefit payable to
 7 a member under the pension program and under any other tax-qualified defined benefit plan main-
 8 tained by the participating public employer may not exceed the applicable limitations set forth in
 9 26 U.S.C. 415(b), as in effect on December 31, [2021] **2022**. The Public Employees Retirement Board
 10 shall adopt rules for the administration of this limitation, including adjustments in the annual dollar
 11 limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

12 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
 13 section by reason of the member's retirement after normal retirement age.

14 **SECTION 5.** ORS 238A.150, as amended by section 5, chapter 83, Oregon Laws 2022, is amended
 15 to read:

16 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.250, an eligible em-
 17 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
 18 vices, and who subsequently returns to employment with a participating public employer with
 19 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
 20 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
 21 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
 22 of this section.

23 (2) The board shall adopt rules establishing benefits and service credit for any period of service
 24 in the uniformed services by an employee described in subsection (1) of this section. For the purpose
 25 of adopting rules under this subsection, the board shall consider and take into account all federal
 26 law relating to benefits and service credit for any period of service in the uniformed services, in-
 27 cluding 26 U.S.C. 414(u), as in effect on December 31, [2021] **2022**. Benefits and service credit under
 28 rules adopted by the board pursuant to this subsection may not exceed benefits and service credit
 29 required under federal law for periods of service in the uniformed services.

30 **SECTION 6.** ORS 238A.170, as amended by section 6, chapter 83, Oregon Laws 2022, is amended
 31 to read:

32 238A.170. (1) An active member of the pension program who is 72 years of age or older must
 33 retire not later than April 1 of the calendar year following the calendar year in which the member
 34 terminates employment with all participating public employers. An inactive member of the pension
 35 program must retire not later than April 1 of the calendar year following the calendar year in which
 36 the member attains 72 years of age.

37 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the entire interest of a
 38 member of the pension program must be distributed over a time period commencing no later than
 39 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
 40 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
 41 lations implementing that section, as in effect on January 1, [2022] **2023**. The Public Employees Re-
 42 tirement Board shall adopt rules implementing those minimum distribution requirements.

43 **SECTION 7.** ORS 238A.230, as amended by section 7, chapter 83, Oregon Laws 2022, is amended
 44 to read:

45 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-

1 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided
2 for in this section to:

3 (a) The spouse of the member to the extent not provided to a former spouse in accordance with
4 a judgment or order under ORS 238.465;

5 (b) The former spouse of the member as provided in a judgment or order under ORS 238.465; or

6 (c) Any other person who is constitutionally required to be treated in the same manner as a
7 spouse for the purpose of retirement benefits.

8 (2) The death benefit to be paid under this subsection is for the life of the member's spouse,
9 former spouse or other person who is constitutionally required to be treated in the same manner
10 as a spouse, and is:

11 (a) If the member dies before the earliest retirement date for the member under ORS 238A.165,
12 the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the
13 deceased member, which shall be calculated as if the member became an inactive member on the
14 date of death and retired at the earliest retirement date for the member as described in ORS
15 238A.165;

16 (b) If the member dies on or after the earliest retirement date for the member under ORS
17 238A.165 and before normal retirement age under ORS 238A.160, the actuarial equivalent of the
18 pension that would otherwise have been paid to the deceased member, which shall be calculated as
19 if the member retired under ORS 238A.185 and as if the member's retirement date was the first of
20 the month following the date of death of the member; or

21 (c) If the member dies on or after reaching normal retirement age as described in ORS 238A.160,
22 the actuarial equivalent of the pension that would otherwise have been paid to the deceased mem-
23 ber, which shall be calculated under ORS 238A.125 as if the member's retirement date was the first
24 of the month following the date of death of the member.

25 (3) The death benefit provided under this section is first effective on the first day of the month
26 following the date of death of the member. The surviving spouse, former spouse or other person
27 entitled to the death benefit may elect to delay payment of the death benefit, which shall be
28 actuarially adjusted for age and interest when payments commence, but payment must commence
29 no later than December 31 of the calendar year in which the member would have reached 72 years
30 of age.

31 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.250, distributions of death
32 benefits under the pension program must comply with the minimum distribution requirements of 26
33 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on January 1, [2022]
34 **2023**. The board shall adopt rules implementing those minimum distribution requirements.

35 **SECTION 8.** ORS 238A.370, as amended by section 8, chapter 83, Oregon Laws 2022, is amended
36 to read:

37 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
38 to the employee and employer accounts of a member of the individual account program for a cal-
39 endar year, together with the annual additions to the accounts of the member under any other de-
40 fined contribution plan maintained by the participating public employer for a calendar year, may
41 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.
42 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.
43 415(c)(2), as in effect on December 31, [2021] **2022**, and "compensation" has the meaning given the
44 term "participant's compensation" in 26 U.S.C. 415(c)(3), as in effect on December 31, [2021] **2022**.
45 The Public Employees Retirement Board shall adopt rules for the administration of this limitation,

1 including adjustments in the annual dollar limitation to reflect cost-of-living adjustments authorized
2 by the Internal Revenue Service.

3 **SECTION 9.** ORS 238A.400, as amended by section 9, chapter 83, Oregon Laws 2022, is amended
4 to read:

5 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
6 238A.165, a member of the individual account program shall receive in a lump sum the amounts in
7 the member's employee account, rollover account and employer account to the extent the member
8 is vested in those accounts under ORS 238A.320.

9 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-
10 ual account program may elect to receive the amounts in the member's employee account and em-
11 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
12 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
13 equal to the anticipated life span of the member as actuarially determined by the Public Employees
14 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
15 may the period selected by the member exceed the time allowed by the minimum distribution re-
16 quirements described in subsection (5) of this section. The board shall by rule establish the manner
17 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
18 during the payout period elected by the member under this subsection. The board by rule may es-
19 tablish minimum monthly amounts payable under this subsection. The board may require that a
20 lump sum payment, or an installment schedule different than the schedules provided for in this
21 subsection, be used to pay the vested amounts in the member's accounts if those amounts are not
22 adequate to generate the minimum monthly amounts specified by the rule.

23 (3) A member of the individual account program electing to receive installments under sub-
24 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
25 before all amounts in the employee and vested employer accounts are paid, all remaining installment
26 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
27 may elect to receive a lump sum distribution of the remaining amounts.

28 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
29 vested amounts in the member's employee account, rollover account and employer account in the
30 manner provided by this section when the member retires for service under the provisions of ORS
31 chapter 238.

32 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
33 member of the individual account program must be distributed over a time period commencing no
34 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
35 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
36 plementing that section, as in effect on January 1, [2022] **2023**. The board shall adopt rules imple-
37 menting those minimum distribution requirements.

38 **SECTION 10.** ORS 238A.410, as amended by section 10, chapter 83, Oregon Laws 2022, is
39 amended to read:

40 238A.410. (1)(a) If a member of the individual account program dies before retirement, the
41 amounts in the member's employee account, rollover account and employer account, to the extent
42 the member is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the
43 beneficiary or beneficiaries designated by the member for the purposes of this section.

44 (b) If a member of the individual account program dies before retirement, the amounts in the
45 employee pension stability account established for the member under ORS 238A.353 shall be applied

1 by the Public Employees Retirement Board to pay the costs of any benefit payable under ORS
2 238.395 or 238A.230 that accrues on or after July 1, 2020. If the amounts in the employee pension
3 stability account exceed the costs of the benefit payable under ORS 238.395 or 238A.230 that accrues

3 (c) "Income" does not include the following:

4 (A) Any governmental grant that must be used by the taxpayer for rehabilitation of the home-
 5 stead of the taxpayer.

15 (10) “Taxable income or loss” means the taxable income or loss determined, or in the case of a
16 corporation for which no federal taxable income or loss is determined, as would be determined, un-

13 (g) "Preservation project" means housing that was previously developed as affordable housing
14 with a contract for rent assistance from the United States Department of Housing and Urban De-
15 velopment or the United States Department of Agriculture and that is being acquired by a spon-
16 soring entity.

17 (h) "Qualified assignee" means any investor participating in the secondary market for real es-
18 tate loans.

19 (i) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling
20 interest in the real property that is financed by a qualified loan. A controlling interest includes a
21 controlling interest in the general partner of a limited partnership that owns the real property.

22 (j) "Qualified loan" means:

23 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-
24 finance a loan that meets the criteria described in subsection (5) of this section; or

25 (B) The purchase by a lending institution of bonds, the proceeds of which are used to finance
26 or refinance a loan that meets the criteria described in subsection (5) of this section.

27 (k) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental
28 entity, local unit of government as defined in ORS 466.706, housing authority or any other person,
29 provided that the person has agreed to restrictive covenants imposed by a nonprofit corporation,
30 nonprofit cooperative, state governmental entity, local unit of government or housing authority.

6 (6) A loan made to refinance a loan that meets the criteria stated in subsection (5) of this sec-
7 tion must be treated the same as a loan that meets the criteria stated in subsection (5) of this sec-

9 (7) For a qualified loan to be eligible for the tax credit allowable under this section, the Housing
10 and Community Services Department must execute a written certification for the qualified loan that:

11 (a) States that the qualified loan is within the limitation imposed by subsection (8) of this sec-
12 tion; and

13 (b) Specifies the period, as determined by the Housing and Community Services Department,
14 during which the tax credit is allowed for the qualified loan, not to exceed:

15 (A) 30 years, for a qualified loan with a contract for rent assistance or financing resources from
16 the United States Department of Agriculture, for new housing construction, acquisition of housing
17 or a preservation project; or

18 (B) 20 years, for any other type of qualified loan.

3 (D) Receipts from hedging transactions, to the extent that the transactions are entered into
4 primarily to protect a financial position, including transactions intended to manage the risk of ex-

14 (D) of the Internal Revenue Code applies;

15 (H) Compensation, whether current or deferred, and whether in cash or in kind, received or to
16 be received by an employee, a former employee or the employee's legal successor for services ren-
17 dered to or for an employer, including reimbursements received by or for an individual for medical
18 or education expenses, health insurance premiums or employee expenses or on account of a de-
19 pendent care spending account, legal services plan, any cafeteria plan described in section 125 of
20 the Internal Revenue Code or any similar employee reimbursement;

21 (I) Proceeds received from the issuance of the taxpayer's own stock, options, warrants, puts or
22 calls, or from the sale of the taxpayer's treasury stock;

23 (J) Proceeds received on the account of payments from insurance policies, including crop in-
24 surance policies, owned by the taxpayer, except those proceeds received for the loss of commercial
25 activity;

26 (K) Gifts or charitable contributions received, membership dues received by trade, professional,
27 homeowners' or condominium associations, payments received for educational courses, meetings or
28 meals, or similar payments to a trade, professional or other similar association, and fundraising re-
29 cepts received by any person when any excess receipts are donated or used exclusively for chari-
30 table purposes;

31 (L) Damages received as the result of litigation in excess of amounts that, if received without
32 litigation, would be treated as commercial activity;

33 (M) Property, money and other amounts received or acquired by an agent on behalf of another
34 in excess of the agent's commission, fee or other remuneration;

35 (N) Tax refunds from any tax program, other tax benefit recoveries and reimbursements for the
36 tax imposed under ORS 317A.100 to 317A.158 made by entities that are part of the same unitary
37 group as provided under ORS 317A.106, and reimbursements made by entities that are not members
38 of a unitary group that are required to be made for economic parity among multiple owners of an
39 entity whose tax obligation under ORS 317A.100 to 317A.158 is required to be reported and paid
40 entirely by one owner, as provided in ORS 317A.106;

41 (O) Pension reversions;

42 (P) Contributions to capital;

43 (Q) Receipts from the sale, transfer, exchange or other disposition of motor vehicle fuel or any
44 other product used for the propulsion of motor vehicles;

45 (R) In the case of receipts from the sale of cigarettes or tobacco products by a wholesale dealer,

1 retail dealer, distributor, manufacturer or seller, an amount equal to the federal and state excise
2 taxes paid by any person on or for such cigarettes or tobacco products under subtitle E of the
3 Internal Revenue Code or ORS chapter 323;

4 (S) In the case of receipts from the sale of malt beverages or wine, as defined in ORS 471.001,
5 cider, as defined in ORS 471.023 or distilled liquor, as defined in ORS 471.001, by a person holding
6 a license issued under ORS chapter 471, an amount equal to the federal and state excise taxes paid
7 by any person on or for such malt beverages, wine or distilled liquor under subtitle E of the Internal
8 Revenue Code or ORS chapter 471 or 473, and any amount paid to the Oregon Liquor and Cannabis
9 Commission for sales of distilled spirits by an agent appointed under ORS 471.750;

10 (T) In the case of receipts from the sale of marijuana items, as defined in ORS 475C.009, by a
11 person holding a license issued under ORS 475C.005 to 475C.525, an amount equal to the federal and
12 state excise taxes paid by any person on or for such marijuana items under subtitle E of the Internal
13 Revenue Code or ORS 475C.670 to 475C.734 and any local retail taxes authorized under ORS
14 475C.453;

15 (U) Local taxes collected by a restaurant or other food establishment on sales of meals, prepared
16 food or beverages;

17 (V) Tips or gratuities collected by a restaurant or other food establishment and passed on to
18 employees;

19 (W) Receipts realized by a vehicle dealer certified under ORS 822.020 or a person described in
20 ORS 320.400 (8)(a)(B) from the sale or other transfer of a motor vehicle, as defined in ORS 801.360,
21 to another vehicle dealer for the purpose of resale by the transferee vehicle dealer, but only if the
22 sale or other transfer was based upon the transferee's need to meet a specific customer's preference
23 for a motor vehicle or is an exchange of new vehicles between franchised motor vehicle dealerships;

24 (X) Registration fees or taxes collected by a vehicle dealer certified under ORS 822.020 or a
25 person described in ORS 320.400 (8)(a)(B) at the sale or other transfer of a motor vehicle, as defined
26 in ORS 801.360, that are owed to a third party by the purchaser of the motor vehicle and passed to
27 the third party by the dealer;

28 (Y) Receipts from a financial institution for services provided to the financial institution in
29 connection with the issuance, processing, servicing and management of loans or credit accounts, if
30 the financial institution and the recipient of the receipts have at least 50 percent of their ownership
31 interests owned or controlled, directly or constructively through related interests, by common own-
32 ers;

33 (Z) In the case of amounts retained as commissions by a holder of a license under ORS chapter
34 462, an amount equal to the amounts specified under ORS chapter 462 that must be paid to or col-
35 lected by the Department of Revenue as a tax and the amounts specified under ORS chapter 462 to
36 be used as purse money;

37 (AA) Receipts of residential care facilities as defined in ORS 443.400 or in-home care agencies
38 as defined in ORS 443.305, to the extent that the receipts are derived from or received as compen-
39 sation for providing services to a medical assistance or Medicare recipient;

40 (BB) Dividends received;

41 (CC) Distributive income received from a pass-through entity;

42 (DD) Receipts from sales to a wholesaler in this state, if the seller receives certification at the
43 time of sale from the wholesaler that the wholesaler will sell the purchased property outside this
44 state;

45 (EE) Receipts from the wholesale or retail sale of groceries, including receipts of a person that

1 owns groceries at the time of sale and compensation of any consignee engaged in effecting the sale
2 of groceries on behalf the owner of the groceries, but only to the extent that the compensation re-
3 lates to grocery sales;

4 (FF) Receipts from transactions among members of a unitary group;

5 (GG) Moneys, including public purpose charge moneys collected under ORS 757.612 and moneys
6 collected to plan for and pursue cost-effective energy efficiency resources under ORS 757.054, that
7 are collected from customers, passed to a utility and approved by the Public Utility Commission and
8 that support energy conservation, renewable resource acquisition and low-income assistance pro-
9 grams;

10 (HH) Moneys collected by a utility from customers for the payment of loans through on-bill fi-
11 nancing;

12 (II) Surcharges collected under ORS 757.736;

13 (JJ) Moneys passed to a utility by the Bonneville Power Administration for the purpose of
14 effectuating the Regional Power Act Exchange credits or pursuant to any settlement associated with
15 the exchange credit;

16 (KK) Moneys collected or recovered, by entities listed in ORS 756.310, cable operators as de-
17 fined in 47 U.S.C. 522(5), telecommunications carriers as defined in 47 U.S.C. 153(51) and providers
18 of information services as defined in 47 U.S.C. 153(24), for fees payable under ORS 756.310, right-of-
19 way fees, franchise fees, privilege taxes, federal taxes and local taxes;

20 (LL) Charges paid to the Residential Service Protection Fund required by chapter 290, Oregon
21 Laws 1987;

22 (MM) Universal service surcharge moneys collected or recovered and paid into the universal
23 service fund established in ORS 759.425;

24 (NN) Moneys collected for public purpose funding as described in ORS 759.430;

25 (OO) Moneys collected or recovered and paid into the federal universal service fund as deter-
26 mined by the Federal Communications Commission;

27 (PP) In the case of a seller or provider of telecommunications services, the amount of tax im-
28 posed under ORS 403.200 for access to the emergency communications system that is collected from
29 subscribers or consumers;

30 (QQ) In the case of a transient lodging tax collector, the amount of tax imposed under ORS
31 320.305 and of any local transient lodging tax imposed upon the occupancy of transit lodging;

32 (RR) In the case of a seller of bicycles, the amount of tax imposed under ORS 320.415 upon retail
33 sales of bicycles;

34 (SS) In the case of a qualified heavy equipment provider, the amount of tax imposed under ORS
35 307.872 upon the rental price of heavy equipment;

36 (TT) Farmer sales to an agricultural cooperative in this state that is a cooperative organization
37 described in section 1381 of the Internal Revenue Code;

38 (UU) Revenue received by a business entity that is mandated by contract or subcontract to be
39 distributed to another person or entity if the revenue constitutes sales commissions that are paid
40 to a person who is not an employee of the business entity, including, without limitation, a split-fee
41 real estate commission; and

42 (VV) Receipts from the sale of fluid milk by dairy farmers that are not members of an agricul-
43 tural cooperative.

44 (2) "Cost inputs" means:

45 (a) The cost of goods sold as calculated in arriving at federal taxable income under the Internal

1 Revenue Code; or

2 (b) In the case of a taxpayer that is engaged in a farming operation, as defined in ORS 317A.102,
3 and that does not report cost of goods sold for federal tax purposes, the taxpayer's operating ex-
4 penses excluding labor costs.

5 (3) "Doing business" means engaging in any activity, whether legal or illegal, that is conducted
6 for, or results in, the receipt of commercial activity at any time during a calendar year.

7 (4) "Excluded person" means any of the following:

8 (a) Organizations described in sections 501(c) and 501(j) of the Internal Revenue Code, unless the
9 exemption is denied under section 501(h), (i) or (m) or under section 502, 503 or 505 of the Internal
10 Revenue Code.

11 (b) Organizations described in section 501(d) of the Internal Revenue Code, unless the exemption
12 is denied under section 502 or 503 of the Internal Revenue Code.

13 (c) Organizations described in section 501(e) of the Internal Revenue Code.

14 (d) Organizations described in section 501(f) of the Internal Revenue Code.

15 (e) Charitable risk pools described in section 501(n) of the Internal Revenue Code.

16 (f) Organizations described in section 521 of the Internal Revenue Code.

17 (g) Qualified state tuition programs described in section 529 of the Internal Revenue Code.

18 (h) Foreign or alien insurance companies, but only with respect to the underwriting profit de-
19 rived from writing wet marine and transportation insurance subject to tax under ORS 731.824 and
20 731.828 or if an insurance company is subject to the retaliatory tax under ORS 731.854 and 731.859.

21 (i) Governmental entities.

22 (j) Any person with commercial activity that does not exceed \$750,000 for the tax year, other
23 than a person that is part of a unitary group as provided in ORS 317A.106 with commercial activity
24 in excess of \$750,000.

25 (k) Hospitals subject to assessment under ORS 414.855, long term care facilities subject to as-
26 sessment under ORS 409.801 or any entity subject to assessment under ORS 414.880 or section 3 or
27 5, chapter 538, Oregon Laws 2017.

28 (L) Manufactured dwelling park nonprofit cooperatives organized under ORS chapter 62.

29 (5) "Financial institution" has the meaning given that term in ORS 314.610, except that "finan-
30 cial institution" does not include a credit union.

31 (6)(a) "FR Y-9" means the consolidated or parent-only financial statements that a holding com-
32 pany is required to file with the Federal Reserve Board pursuant to 12 U.S.C. 1844.

33 (b) In the case of a holding company required to file both consolidated and parent-only financial
34 statements, "FR Y-9" means the consolidated financial statements that the holding company is re-
35 quired to file.

36 (7) "Governmental entity" means:

37 (a) The United States and any of its unincorporated agencies and instrumentalities.

38 (b) Any incorporated agency or instrumentality of the United States wholly owned by the United
39 States or by a corporation wholly owned by the United States.

40 (c) The State of Oregon and any of its unincorporated agencies and instrumentalities.

41 (d) Any county, city, district or other political subdivision of the state.

42 (e) A special government body as defined in ORS 174.117.

43 (f) A federally recognized Indian tribe.

44 (8) "Groceries" means food as defined in 7 U.S.C. 2012(k), but does not include cannabinoid
45 edibles or marijuana seeds.

1 (9)(a) “Hedging transaction” means a hedging transaction as defined in section 1221 of the
 2 Internal Revenue Code or a transaction accorded hedge accounting treatment under Financial Ac-
 3 counting Standards Board Statement No. 133.

4 (b) “Hedging transaction” does not include a transaction in which an actual transfer of title of
 5 real or tangible property to another entity occurs.

6 (10) “Insurer” has the meaning given that term in ORS 317.010.

7 (11) “Internal Revenue Code,” except where the Legislative Assembly has provided otherwise,
 8 refers to the laws of the United States or to the Internal Revenue Code as they are amended and
 9 in effect on December 31, [2021] **2022**.

10 (12) “Labor costs” means total compensation of all employees, not to include compensation paid
 11 to any single employee in excess of \$500,000.

12 (13)(a) “Motor vehicle fuel or any other product used for the propulsion of motor vehicles”
 13 means:

14 (A) Motor vehicle fuel as defined in ORS 319.010; and

15 (B) Fuel the use of which in a motor vehicle is subject to taxation under ORS 319.530.

16 (b) “Motor vehicle fuel or any other product used for the propulsion of motor vehicles” does not
 17 mean:

18 (A) Electricity; or

19 (B) Electric batteries or any other mechanical or physical component or accessory of a motor
 20 vehicle.

21 (14) “Person” includes individuals, combinations of individuals of any form, receivers, assignees,
 22 trustees in bankruptcy, firms, companies, joint-stock companies, business trusts, estates, partner-
 23 ships, limited liability partnerships, limited liability companies, associations, joint ventures, clubs,
 24 societies, entities organized as for-profit corporations under ORS chapter 60, C corporations, S cor-
 25 porations, qualified subchapter S subsidiaries, qualified subchapter S trusts, trusts, entities that are
 26 disregarded for federal income tax purposes and any other entities.

27 (15) “Retailer” means a person doing business by selling tangible personal property to a pur-
 28 chaser for a purpose other than:

29 (a) Resale by the purchaser of the property as tangible personal property in the regular course
 30 of business;

31 (b) Incorporation by the purchaser of the property in the course of regular business as an in-
 32 gredient or component of real or personal property; or

33 (c) Consumption by the purchaser of the property in the production for sale of a new article of
 34 tangible personal property.

35 (16) “Taxable commercial activity” means commercial activity sourced to this state under ORS
 36 317A.128, less any subtraction pursuant to ORS 317A.119.

37 (17)(a) “Taxpayer” means any person or unitary group required to register, file or pay tax under
 38 ORS 317A.100 to 317A.158.

39 (b) “Taxpayer” does not include excluded persons, except to the extent that a tax-exempt entity
 40 has unrelated business income as described in the Internal Revenue Code.

41 (18) “Tax year” means, except as otherwise provided in ORS 317A.103, a taxpayer’s annual ac-
 42 counting period used for federal income tax purposes under section 441 of the Internal Revenue
 43 Code.

44 (19)(a) “Unitary business” means a business enterprise in which there exists directly or indi-
 45 rectly between the members or parts of the enterprise a sharing or exchange of value as demon-

1 strated by:

- 2 (A) Centralized management or a common executive force;
- 3 (B) Centralized administrative services or functions resulting in economies of scale; or
- 4 (C) Flow of goods, capital resources or services demonstrating functional integration.

5 (b) “Unitary business” may include a business enterprise the activities of which:

6 (A) Are in the same general line of business, such as manufacturing, wholesaling or retailing;

7 or

8 (B) Constitute steps in a vertically integrated process, such as the steps involved in the pro-
9 duction of natural resources, which might include exploration, mining, refining and marketing.

10 (20) “Unitary group” means a group of persons with more than 50 percent common ownership,
11 either direct or indirect, that is engaged in business activities that constitute a unitary business.

12 (21) “Wholesaler” means a person primarily doing business by merchant distribution of tangible
13 personal property to retailers or to other wholesalers.

14 **SECTION 27.** ORS 458.670, as amended by section 27, chapter 83, Oregon Laws 2022, is

25 of the Internal Revenue Code as amended and in effect on December 31, [2021] **2022**; or

26 (b) A federally recognized Oregon Indian tribe that is located, to a significant degree, within the

- 29 (a) An organization regulated under ORS chapters 706 to 716 or 723; or
- 30 (b) In the case of individual development accounts established for the purpose described in ORS
31 458.685 (1)(c), a financial institution as defined in ORS 178.300.

32 (4) “Individual development account” means a contract between an account holder and a
33 fiduciary organization, for the deposit of funds into a financial institution by the account holder and
34 the deposit of matching funds into a designated account by the fiduciary organization, to allow the
35 account holder to accumulate assets for use toward achieving a specific purpose approved by the
36 fiduciary organization.

37 (5) “Lower income household” means a household having an income equal to or less than the
38 greater of the following:

39 (a) 80 percent of the median household income for the area as determined by the Housing and
40 Community Services Department. In making the determination, the department shall give consider-
41 ation to any data on area household income published by the United States Department of Housing
42 and Urban Development.

43 (b) 200 percent of the poverty guidelines as determined by the Housing and Community Services
44 Department. In making the determination, the department shall give consideration to poverty
45 guidelines published by the United States Department of Health and Human Services and may con-

2 (6)(a) “Net worth” means a calculation based on the net value of assets of a household estab-

6 (B) Holdings in pension accounts valued at less than \$120,000.

7 (7) “Resident of this state” has the meaning given that term in ORS 316.027.

8 **SECTION 28.** ORS 657.010, as amended by section 28, chapter 83, Oregon Laws 2022, is
 9 amended to read:

10 657.010. As used in this chapter, unless the context requires otherwise:

11 (1) “Base year” means the first four of the last five completed calendar quarters preceding the
 12 benefit year.

13 (2) “Benefits” means the money allowances payable to unemployed persons under this chapter.

14 (3) “Benefit year” means a period of 52 consecutive weeks commencing with the first week with
 15 respect to which an individual files an initial valid claim for benefits, and thereafter the 52 consec-
 16 utive weeks period beginning with the first week with respect to which the individual next files an
 17 initial valid claim after the termination of the individual’s last preceding benefit year except that
 18 the benefit year shall be 53 weeks if the filing of an initial valid claim would result in overlapping
 19 any quarter of the base year of a previously filed initial valid claim.

20 (4) “Calendar quarter” means the period of three consecutive calendar months ending on March
 21 31, June 30, September 30 or December 31, or the approximate equivalent thereof, as the Director
 22 of the Employment Department may, by rule, prescribe.

23 (5) “Contribution” or “contributions” means the taxes that are the money payments required by
 24 this chapter, or voluntary payments permitted, to be made to the Unemployment Compensation Trust
 25 Fund.

26 (6) “Educational institution,” including an institution of higher education, means an institution:

27 (a) In which participants, trainees or students are offered an organized course of study or
 28 training designed to transfer to them knowledge, skills, information, doctrines, attitudes or abilities
 29 from, by or under the guidance of an instructor or teacher;

30 (b) That is accredited, registered, approved, licensed or issued a permit to operate as a school
 31 by the Department of Education or other government agency, or that offers courses for credit that
 32 are transferable to an approved, registered or accredited school;

33 (c) In which the course or courses of study or training that it offers may be academic, technical,
 34 trade or preparation for gainful employment in a recognized occupation; and

35 (d) In which the course or courses of study or training are offered on a regular and continuing
 36 basis.

37 (7) “Employment office” means a free public employment office or branch thereof, operated by
 38 this state or maintained as a part of a state-controlled system of public employment offices.

39 (8) “Hospital” has the meaning given that term in ORS 442.015.

40 (9) “Institution of higher education” means an educational institution that:

41 (a) Admits as regular students only individuals having a certificate of graduation from a high
 42 school, or the recognized equivalent of such a certificate;

43 (b) Is legally authorized in this state to provide a program of education beyond high school;

44 (c) Provides an educational program for which it awards a bachelor’s or higher degree, or pro-
 45 vides a program that is acceptable for full credit toward such a degree, a program of post-graduate

1 or post-doctoral studies, or a program of training to prepare students for gainful employment in a
 2 recognized occupation; and

3 (d) Is a public or other nonprofit institution.

4 (10) “Instructional capacity” does not include services performed as an instructional assistant
 5 as defined in ORS 342.120.

6 (11) “Internal Revenue Code” means the federal Internal Revenue Code, as amended and in ef-
 7 fect on December 31, [2021] **2022**.

8 (12) “Nonprofit employing unit” means an organization, or group of organizations, described in
 9 section 501(c)(3) of the Internal Revenue Code that is exempt from income tax under section 501(a)
 10 of the Internal Revenue Code.

11 (13) “State” includes, in addition to the states of the United States of America, the District of
 12 Columbia and Puerto Rico. However, for all purposes of this chapter the Virgin Islands shall be
 13 considered a state on and after the day on which the United States Secretary of Labor first approves
 14 the Virgin Islands’ law under section 3304(a) of the Federal Unemployment Tax Act as amended by
 15 Public Law 94-566.

16 (14) “Taxes” means the money payments to the Unemployment Compensation Trust Fund re-
 17 quired, or voluntary payments permitted, by this chapter.

18 (15) “Valid claim” means any claim for benefits made in accordance with ORS 657.260 if the
 19 individual meets the wages-paid-for-employment requirements of ORS 657.150.

20 (16) “Week” means any period of seven consecutive calendar days ending at midnight, as the
 21 director may prescribe by rule.

22 **SECTION 29.** ORS 657B.010, as amended by section 1, chapter 24, Oregon Laws 2022, and sec-
 23 tion 29, chapter 83, Oregon Laws 2022, is amended to read:

24 657B.010. As used in this chapter:

25 (1) “Alternate base year” means the last four completed calendar quarters preceding the benefit
 26 year.

27 (2) “Average weekly wage” means the amount calculated by the Employment Department as the

30 (3) “Base year” means the first four of the last five completed calendar quarters preceding the

41 (a) A biological child, adopted child, stepchild or foster child of a covered individual or of the

45 (c) A person who is or was in a relationship of in loco parentis with a covered individual or

1 with the covered individual's spouse or domestic partner.

2 (7) "Contribution" or "contributions" means the money payments made by any of the following
3 under ORS 657B.150:

- 4 (a) An employer;
- 5 (b) An eligible employee;
- 6 (c) A self-employed individual;
- 7 (d) A tribal government; or
- 8 (e) An employee of a tribal government.

9 (8) "Covered individual" means any one of the following who qualifies to receive family and
10 medical leave insurance benefits:

- 11 (a) An eligible employee;
- 12 (b) A self-employed individual; or
- 13 (c) An employee of a tribal government.

14 (9) "Domestic partner" means an individual joined in a domestic partnership.

15 (10) "Domestic partnership" has the meaning given that term in ORS 106.310.

16 (11) "Eligible employee" means:

17 (a)(A) An employee who has earned at least \$1,000 in wages during the base year; or
18 (B) If an employee has not earned at least \$1,000 in wages during the base year, an employee
19 who has earned at least \$1,000 in wages during the alternate base year; and

20 (b) Who may apply for paid family and medical leave insurance benefits under ORS 657B.015.

21 (12) "Eligible employee's average weekly wage" means an amount calculated by the Director of
22 the Employment Department by dividing the total wages earned by an eligible employee during the
23 base year by the number of weeks in the base year.

24 (13)(a) "Employee" means:

25 (A) An individual performing services for an employer for remuneration or under any contract
26 of hire, written or oral, express or implied.

27 (B) A home care worker as defined in ORS 410.600.

28 (b) "Employee" does not include:

29 (A) An independent contractor as defined in ORS 670.600.

30 (B) A participant in a work training program administered under a state or federal assistance
31 program.

32 (C) A participant in a work-study program that provides students in secondary or postsecondary
33 educational institutions with employment opportunities for financial assistance or vocational train-
34 ing.

35 (D) A railroad worker exempted under the federal Railroad Unemployment Insurance Act.

36 (E) A volunteer.

37 (14)(a) "Employer" means any person that employs one or more employees working anywhere in
38 this state or any agent or employee of such person to whom the duties of the person under this
39 chapter have been delegated.

40 (b) "Employer" includes:

41 (A) A political subdivision of this state or any county, city, district, authority or public corpo-
42 ration, or any instrumentality of a county, city, district, authority or public corporation, organized
43 and existing under law or charter;

44 (B) An individual;

45 (C) Any type of organization, corporation, partnership, limited liability company, association,

1 trust, estate, joint stock company or insurance company;

2 (D) Any successor in interest to an entity described in subparagraph (C) of this paragraph;

3 (E) A trustee, trustee in bankruptcy or receiver; or

4 (F) A trustee or legal representative of a deceased person.

5 (c) “Employer” does not include the federal government or a tribal government.

6 (15) “Employment agency” has the meaning given that term in ORS 658.005.

7 (16) “Family and medical leave insurance benefits” means the wage replacement benefits that
8 are available to a covered individual under ORS 657B.050 or under the terms of an employer plan
9 approved under ORS 657B.210, for family leave, medical leave or safe leave.

10 (17)(a) “Family leave” means leave from work taken by a covered individual:

11 (A) To care for and bond with a child during the first year after the child’s birth or during the
12 first year after the placement of the child through foster care or adoption; or

13 (B) To care for a family member with a serious health condition.

14 (b) “Family leave” does not mean:

15 (A) Leave described in ORS 659A.159 (1)(d);

16 (B) Leave described in ORS 659A.159 (1)(e); or

17 (C) Leave authorized under ORS 659A.093.

18 (18) “Family member” means:

19 (a) The spouse of a covered individual;

20 (b) A child of a covered individual or the child’s spouse or domestic partner;

21 (c) A parent of a covered individual or the parent’s spouse or domestic partner;

22 (d) A sibling or stepsibling of a covered individual or the sibling’s or stepsibling’s spouse or
23 domestic partner;

24 (e) A grandparent of a covered individual or the grandparent’s spouse or domestic partner;

25 (f) A grandchild of a covered individual or the grandchild’s spouse or domestic partner;

26 (g) The domestic partner of a covered individual; or

27 (h) Any individual related by blood or affinity whose close association with a covered individual
28 is the equivalent of a family relationship.

29 (19) “Medical leave” means leave from work taken by a covered individual that is made neces-
30 sary by the individual’s own serious health condition.

31 (20) “Parent” means:

32 (a) A biological parent, adoptive parent, stepparent or foster parent of a covered individual;

33 (b) A person who was a foster parent of a covered individual when the covered individual was
34 a minor;

35 (c) A person designated as the legal guardian of a covered individual at the time the covered
36 individual was a minor or required a legal guardian;

37 (d) A person with whom a covered individual was or is in a relationship of in loco parentis; or

38 (e) A parent of a covered individual’s spouse or domestic partner who meets a description under
39 paragraphs (a) to (d) of this subsection.

40 (21) “Safe leave” means leave taken for any purpose described in ORS 659A.272.

41 (22) “Self-employed individual” means:

42 (a) An individual who has self-employment income as defined in section 1402(b) of the Internal
43 Revenue Code as amended and in effect on December 31, [2021] **2022**; or

44 (b) An independent contractor as defined in ORS 670.600.

45 (23) “Serious health condition” has the meaning given that term in ORS 659A.150.

1 (24) “Third party administrator” means a third party that enters into an agreement with the
 2 Director of the Employment Department to implement and administer the paid family and medical
 3 leave program established under this chapter.

4 (25) “Tribal government” has the meaning given that term in ORS 181A.940.

5 (26) “Wages” has the meaning given that term in ORS 657.105.

6 **SECTION 30.** (1) **Except as provided in subsections (2) and (3) of this section, the**
 7 **amendments to statutes by sections 1 to 29 of this 2023 Act apply to transactions or activities**
 8 **occurring on or after January 1, 2023, in tax years beginning on or after January 1, 2023.**

9 (2) **The effective and applicable dates, and the exceptions, special rules and coordination**
 10 **with the Internal Revenue Code, as amended, relative to those dates, contained in the Su-**
 11 **preme Court Security Funding Act of 2022 (P.L. 117-167) and the Inflation Reduction Act of**
 12 **2022 (P.L. 117-169) and other federal law amending the Internal Revenue Code and enacted**
 13 **before January 1, 2023, apply for Oregon personal income and corporate excise and income**
 14 **tax purposes, to the extent they can be made applicable, in the same manner as they are**
 15 **applied under the Internal Revenue Code and related federal law.**

16 (3)(a) **If a deficiency is assessed against any taxpayer for a tax year beginning before**
 17 **January 1, 2023, and the deficiency or any portion thereof is attributable to any retroactive**
 18 **treatment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842,**
 19 **314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2**
 20 **and 14 to 26 of this 2023 Act, then any interest or penalty assessed under ORS chapter 305,**
 21 **314, 315, 316, 317, 317A or 318 with respect to the deficiency or portion thereof shall be can-**
 22 **celed.**

23 (b) **If a refund is due any taxpayer for a tax year beginning before January 1, 2023, and**
 24 **the refund or any portion thereof is due the taxpayer on account of any retroactive treat-**
 25 **ment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842, 314.011,**
 26 **314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2 and 14**
 27 **to 26 of this 2023 Act, for a tax year beginning before January 1, 2023, then notwithstanding**
 28 **ORS 305.270 or 314.415 or any other law, the refund or portion thereof shall be paid without**
 29 **interest.**

30 (c) **Any changes required because of the amendments to ORS 178.300, 178.375, 305.239,**
 31 **305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and**
 32 **317A.100 by sections 1, 2 and 14 to 26 of this 2023 Act, for a tax year beginning before January**
 33 **1, 2023, shall be made by filing an amended return within the time prescribed by law.**

34 (d) **If a taxpayer fails to file an amended return under paragraph (c) of this subsection,**
 35 **the Department of Revenue shall make any changes under paragraph (c) of this subsection**
 36 **on the return to which the changes relate within the period specified for issuing a notice of**
 37 **deficiency or claiming a refund as otherwise provided by law with respect to that return, or**
 38 **within one year after a return for a tax year beginning on or after January 1, 2023, and be-**
 39 **fore January 1, 2024, is filed, whichever period expires later.**

40 **SECTION 31.** **This 2023 Act takes effect on the 91st day after the date on which the 2023**
 41 **regular session of the Eighty-second Legislative Assembly adjourns sine die.**
