SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Authorizes method by which Department of State Lands may dispose of personal property left on state lands.

Requires Director of Department of State Lands to adopt rules establishing fees related to removal or fill permit applications, wetland delineation reports and general authorizations. **Removes specified fee amounts from statute.** Takes effect on 91st day following adjournment sine die.

8	SECTION 1. Section 2 of this 2023 Act is added to and made a part of ORS chapter 273.

11	to an individual, including books, photographs, personal documents such as identification and
