

# House Bill 2267

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor Kate Brown for Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Removes requirement that term of office for voting member of Oregon Geographic Information Council begins on January 1. Modifies term of office when vacancy occurs so successor voting member serves new four-year term and nonvoting member serves new two-year term.

## A BILL FOR AN ACT

2 Relating to the Oregon Geographic Information Council; amending ORS 276A.503.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 276A.503 is amended to read:

5 276A.503. (1) The Oregon Geographic Information Council is established within the office of  
6 Enterprise Information Services. The State Chief Information Officer shall provide administrative  
7 and staff support and facilities that are necessary for the council to carry out the purposes set forth  
8 in this section. The purposes of the council are to:

9 (a) Serve as the statewide governing body for sharing and managing geospatial framework data;

10 (b) Oversee the preparation and maintenance of a plan to enhance geographic framework infor-  
11 mation sharing and management and to enhance coordination with respect to geographic framework  
12 information among public bodies within this state; and

13 (c) Coordinate geospatial framework data sharing and management that occurs among public  
14 bodies.

15 (2) The membership of the council consists of:

16 (a) Two members of the Legislative Assembly appointed as follows:

17 (A) The President of the Senate shall appoint one member from the Senate who has an interest  
18 in geographic information systems and in enhancing geospatial framework data sharing among pub-  
19 lic bodies; and

20 (B) The Speaker of the House of Representatives shall appoint one member from the House of  
21 Representatives who has an interest in geographic information systems and in enhancing geospatial  
22 framework data sharing among public bodies.

23 (b) The following members appointed by the Governor:

24 (A) One member who represents Indian tribes, as defined in ORS 97.740;

25 (B) One member who represents the Association of Oregon Counties;

26 (C) One member who represents the League of Oregon Cities;

27 (D) One member who represents the Special Districts Association of Oregon;

28 (E) One member who represents regional governments or councils of government within this  
29 state;

30 (F) One member who represents the Oregon State Association of County Assessors;

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (G) One member who represents a public safety answering point, as defined in ORS 403.105,  
 2 within this state;

3 (H) One member who represents the public universities listed in ORS 352.002;

4 (I) One member who represents a federal agency that is concerned with collecting, managing  
 5 or disseminating geospatial framework data;

6 (J) One member who represents a public utility within this state;

7 (K) One member who is a geographic information systems manager for a county or city in this  
 8 state;

9 (L) One member who represents the public and who has an interest in geographic information  
 10 systems and in enhancing geospatial framework data sharing among public bodies;

11 (M) The state geographic information officer that the State Chief Information Officer appoints  
 12 under ORS 276A.515;

13 (N) One member who represents a nonprofit professional organization with an interest in ge-  
 14 ographic information systems and in enhancing geospatial data sharing among public bodies;

15 (O) Three members from state agencies with responsibility for water, land, air quality, natural  
 16 resources or infrastructure;

17 (P) Two members from state agencies with responsibilities for public health, human services,  
 18 education or economic or community development; and

19 (Q) Two members from state agencies with responsibility for public safety or emergency man-  
 20 agement.

21 (3) Each group or entity identified in subsection (2)(b) of this section may recommend an indi-  
 22 vidual from the group or entity for membership on the council.

23 (4) Members of the Legislative Assembly appointed to the council are nonvoting members and  
 24 may act in an advisory capacity only.

25 (5)(a) A majority of the voting members of the council constitutes a quorum for transacting  
 26 business.

27 (b) A majority of the voting members of the council must approve the council's official actions.

28 (6) The council shall elect one of the council's members to serve as chairperson and one member  
 29 to serve as vice chairperson. The council shall specify in the charter described in ORS 276A.506  
 30 (1)(e) a process by which the council selects the chairperson and vice chairperson and the terms of  
 31 office for the chairperson and vice chairperson.

32 (7)(a) The term of office for each voting member of the council is four years, but the member  
 33 serves at the pleasure of the Governor.

34 (b) Before a voting member's term expires, the Governor shall appoint a successor[, *whose term*  
 35 *begins on January 1 following the Governor's appointment*]. A voting member is eligible for reap-  
 36 pointment.

37 (c) A nonvoting member's term of office is two years. A nonvoting member is eligible for reap-  
 38 pointment.

39 (d) If a vacancy occurs on the council for any reason, the appointing authority shall make an  
 40 appointment to become immediately effective and the new member shall serve: [*for the remainder of*  
 41 *the term.*]

42 **(A) For a voting member, a new four-year term.**

43 **(B) For a nonvoting member, a new two-year term.**

44 (8) The council shall meet at times and places that the chairperson or a majority of the voting  
 45 members of the council specifies.

1           (9) Members of the council who are not members of the Legislative Assembly may not receive  
2 compensation, but the State Chief Information Officer, at the State Chief Information Officer's dis-  
3 cretion, may reimburse council members for actual and necessary travel and other expenses the  
4 members incur in performing the members' official duties, in the manner and amounts provided for  
5 in ORS 292.495, from funds appropriated to the State Chief Information Officer for carrying out the  
6 council's purposes.

7           (10) All agencies of state government, as defined in ORS 174.111, shall assist the council in  
8 performing the council's duties and, to the extent permitted by laws relating to confidentiality, shall  
9 furnish information and advice the council considers necessary to perform the council's duties.
