12 "(2) A public employer that employs a retired member during [calendar year 2020, 2021, 2022, 13 2023 or 2024] any calendar year through calendar year 2034, shall contribute to the Public Employees Retirement Board the percentage of the member's wages that would have been contributed 14 15 to the board under ORS 238.225 if the member were an active member of the Public Employees Retirement System. Employer contributions made under this section are in addition to employer con-16 tributions made under ORS 238.225. The board shall apply contributions made by a public employer 17under this subsection against the liabilities of the public employer. "(3) This section does not apply to any member who retires under the provisions of ORS 238.280
(1), (2) or (3), unless the person is absent from employment with all participating public employers
for at least six months before the date the person is employed under this section.

"(2) A public employer that employs a retired member during [*calendar year 2020, 2021, 2022, 2023 or 2024*] any calendar year through calendar year 2034, shall contribute to the board the

1 percentage of the member's wages that would have been contributed to the board under ORS 2 238A.220 if the member were an active member of the Public Employees Retirement System. Em-3 ployer contributions made under this section are in addition to employer contributions made under 4 ORS 238A.220. The board shall apply contributions made by a public employer under this subsection 5 against the liabilities of the public employer. The board shall adopt rules governing payments made 6 under this subsection.

"(3) This section does not apply to any member who retires under the provisions of ORS
238A.185, unless the person is absent from employment with all participating public employers for
at least six months before the date the person is employed under this section.
