

House Bill 2411

Sponsored by Representative OWENS, Senator FINDLEY (at the request of Curt Sisson) (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Dissolves Oregon Alfalfa Seed Commission.
Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to the Oregon Alfalfa Seed Commission; creating new provisions; amending ORS 576.062;
3 repealing ORS 576.372; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Consistent with the amendments to ORS 576.062 by section 3 of this 2023**
6 **Act and the repeal of ORS 576.372 by section 4 of this 2023 Act, the Oregon Alfalfa Seed**
7 **Commission is dissolved.**

8 **SECTION 2. Section 1 of this 2023 Act is repealed on the day after the effective date of**
9 **this 2023 Act.**

10 **SECTION 3.** ORS 576.062 is amended to read:

1 **SECTION 4. ORS 576.372 is repealed.**

2 **SECTION 5. This 2023 Act being necessary for the immediate preservation of the public**
3 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**
4 **on its passage.**
