# B-Engrossed House Bill 2421

Ordered by the Senate May 17  
Including House Amendments dated April 6 and Senate Amendments  
dated May 17

Sponsored by Representative REYNOLDS; Representative NELSON (at the request of Paul Terdal) (Pre-session filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Health Licensing Office to establish guidelines for professional methods and procedures used by registered behavior analysis interventionists. Allows applied behavior analysis professional to provide outpatient treatment for mental or emotional disorder or chemical dependency to certain patients without parental consent. Requires applied behavior analysis professionals to report child abuse and to report prohibited or unprofessional conduct of another applied behavior analysis professional. Prohibits applied behavior analysis professional from practicing conversion therapy.

Takes effect on 91st day following adjournment sine die.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 676.802 is amended to read:

7 676.802. As used in [*this section, ORS 676.806 and 676.810 to 676.820*] **ORS 676.802 to 676.830:**

8 (1)(a) "Applied behavior analysis" means the design, implementation and evaluation of environ-  
9 mental modifications, using behavioral stimuli and consequences, to produce significant improvement  
10 in human social behavior, including the use of direct observation, measurement and functional  
11 analysis of the relationship between environment and behavior.

12 (b) "Applied behavior analysis" does not mean psychological testing, neuropsychology,  
13 psychotherapy, cognitive therapy, sex therapy, psychoanalysis, hypnotherapy or long-term counseling  
14 as treatment modalities.

15 (2) "Licensed health care professional" means an individual whose scope of practice includes  
16 applied behavior analysis and who is licensed by:

17 (a) The Occupational Therapy Licensing Board;

18 (b) The Oregon Board of Licensed Professional Counselors and Therapists;

19 (c) The Oregon Medical Board;

20 (d) The Oregon State Board of Nursing;

21 (e) The Oregon Board of Physical Therapy;

22 (f) The State Board of Examiners for Speech-Language Pathology and Audiology;

23 (g) The State Board of Licensed Social Workers; or

2 **SECTION 2.** ORS 676.815 is amended to read:

3 676.815. (1) The Health Licensing Office, **in consultation with the Behavior Analysis Regu-**  
4 **latory Board**, shall establish by rule criteria for the registration of behavior analysis  
5 interventionists. The criteria must include, but are not limited to, the requirement that the appli-  
6 cant:

7 [(1)] (a) Have a high school diploma, a modified diploma, a certificate for passing an approved  
8 high school equivalency test such as the General Educational Development (GED) test or a degree  
9 from a post-secondary institution;

10 [(2)] (b) Be at least 18 years of age;

11 [(3)] (c) Have successfully completed a state and nationwide criminal records check that re-  
12 quires fingerprinting;

13 [(4)] (d) Have completed at least 40 hours of professional training in applied behavior analysis  
14 approved by the office by rule; and

15 [(5)] (e) Receive ongoing training and supervision by a licensed behavior analyst, by a licensed  
16 assistant behavior analyst or by another licensed health care professional.

31 (a)(A) "Applied behavior analysis" means the design, implementation and evaluation of environ-  
32 mental modifications, using behavioral stimuli and consequences, to produce significant improvement  
33 in human social behavior, including the use of direct observation, measurement and functional  
34 analysis of the relationship between environment and behavior, that is provided by:

35 (i) A licensed health care professional as defined in ORS 676.802;

36 (ii) A behavior analyst or assistant behavior analyst licensed under ORS 676.810; or

37 (iii) A behavior analysis interventionist registered under ORS 676.815 who receives ongoing  
38 training and supervision by a licensed behavior analyst, by a licensed assistant behavior analyst or  
39 by a licensed health care professional.

40 (B) "Applied behavior analysis" does not mean psychological testing, neuropsychology,  
41 psychotherapy, cognitive therapy, sex therapy, psychoanalysis, hypnotherapy and long-term coun-  
42 seling as treatment modalities.

43 (b) "Autism spectrum disorder" has the meaning given that term in the fifth edition of the Di-  
44 agnostic and Statistical Manual of Mental Disorders (DSM-5) published by the American Psychiatric  
45 Association.

1 (c) "Diagnosis" means medically necessary assessment, evaluation or testing.

2 (d) "Health benefit plan" has the meaning given that term in ORS 743B.005.

3 (e) "Medically necessary" means in accordance with the definition of medical necessity that is  
4 specified in the policy or certificate for the health benefit plan and that applies to all covered ser-  
5 vices under the plan.

6 (f) "Treatment for autism spectrum disorder" includes applied behavior analysis for up to 25  
7 hours per week and any other mental health or medical services identified in the individualized  
8 treatment plan, as described in subsection (6) of this section.

9 (2) A health benefit plan shall provide coverage of:

10 (a) The screening for and diagnosis of autism spectrum disorder by a licensed neurologist,  
11 pediatric neurologist, developmental pediatrician, psychiatrist or psychologist, who has experience  
12 or training in the diagnosis of autism spectrum disorder; and

13 (b) Medically necessary treatment for autism spectrum disorder and the management of care, for  
14 an individual who begins treatment before nine years of age, subject to the requirements of this  
15 section.

16 (3) This section does not require coverage for:

17 (a) Services provided by a family or household member;

18 (b) Services that are custodial in nature or that constitute marital, family, educational or  
19 training services;

20 (c) Custodial or respite care, equine assisted therapy, creative arts therapy, wilderness or ad-  
21 venture camps, social counseling, telemedicine, music therapy, neurofeedback, chelation or  
22 hyperbaric chambers;

23 (d) Services provided under an individual education plan in accordance with the Individuals with  
24 Disabilities Education Act, 20 U.S.C. 1400 et seq.;

25 (e) Services provided through community or social programs; or

26 (f) Services provided by the Department of Human Services or the Oregon Health Authority,  
27 other than employee benefit plans offered by the department and the authority.

28 (4) An insurer may not terminate coverage or refuse to issue or renew coverage for an individ-  
29 ual solely because the individual has received a diagnosis of autism spectrum disorder or has re-  
30 ceived treatment for autism spectrum disorder.

31 (5) Coverage under this section may be subject to utilization controls that are reasonable in the  
32 context of individual determinations of medical necessity. An insurer may require:

33 (a) An autism spectrum disorder diagnosis by a professional described in subsection (2)(a) of this  
34 section if the original diagnosis was not made by a professional described in subsection (2)(a) of this  
35 section.

36 (b) Prior authorization for coverage of a maximum of 25 hours per week of applied behavior  
37 analysis recommended in an individualized treatment plan approved by a professional described in  
38 subsection (2)(a) of this section for an individual with autism spectrum disorder, as long as the  
39 insurer makes a prior authorization determination no later than 30 calendar days after receiving the  
40 request for prior authorization, notwithstanding ORS 743B.423.

41 (6) If an individual is receiving applied behavior analysis, an insurer may require submission of  
42 an individualized treatment plan, which shall include all elements necessary for the insurer to ap-  
43 propriately determine coverage under the health benefit plan. The individualized treatment plan  
44 must be based on evidence-based screening criteria. An insurer may require an updated individual-  
45 ized treatment plan, not more than once every six months, that includes observed progress as of the

1 date the updated plan was prepared, for the purpose of performing utilization review and medical  
2 management. The insurer may require the individualized treatment plan to be approved by a pro-  
3 fessional described in subsection (2)(a) of this section, and to include the:

4 (a) Diagnosis;

5 (b) Proposed treatment by type;

6 (c) Frequency and anticipated duration of treatment;

7 (d) Anticipated outcomes stated as goals, including specific cognitive, social, communicative,  
8 self-care and behavioral goals that are clearly stated, directly observed and continually measured  
9 and that address the characteristics of the autism spectrum disorder; and

10 (e) Signature of the treating provider.

11 (7)(a) Once coverage for applied behavior analysis has been approved, the coverage continues  
12 as long as:

13 (A) The individual continues to make progress toward the majority of the goals of the individ-  
14 ualized treatment plan; and

15 (B) Applied behavior analysis is medically necessary.

16 (b) An insurer may require periodic review of an individualized treatment plan, as described in  
17 subsection (6) of this section, and modification of the individualized treatment plan if the review  
18 shows that the individual receiving the treatment is not making substantial clinical progress toward  
19 the goals of the individualized treatment plan.

20 (8) Coverage under this section may be subject to requirements and limitations no more re-  
21 strictive than those imposed on coverage or reimbursement of expenses arising from the treatment  
22 of other medical conditions under the policy or certificate, including but not limited to:

23 (a) Requirements and limitations regarding in-network providers; and

24 (b) Provisions relating to deductibles, copayments and coinsurance.

25 (9) This section applies to coverage for up to 25 hours per week of applied behavior analysis for  
26 an individual if the coverage is first requested when the individual is under nine years of age. This  
27 section does not limit coverage for any services that are otherwise available to an individual under  
28 ORS 743A.168 or 743A.190, including but not limited to:

29 (a) Treatment for autism spectrum disorder other than applied behavior analysis or the services  
30 described in subsection (3) of this section;

31 (b) Applied behavior analysis for more than 25 hours per week; or

32 (c) Applied behavior analysis for an individual if the coverage is first requested when the indi-  
33 vidual is nine years of age or older.

34 (10) Coverage under this section includes treatment for autism spectrum disorder provided in the  
35 individual's home or a licensed health care facility or, for treatment provided by a licensed health  
36 care professional as defined in ORS 676.802 or a behavior analyst or assistant behavior analyst li-  
37 censed under ORS 676.810 **or a behavior analysis interventionist registered under ORS**  
38 **676.815**, in a setting approved by the health care professional, behavior analyst or assistant behavior

40 (11) An insurer that provides coverage of applied behavior analysis in accordance with a deci-  
41 sion of an independent review organization that was made prior to January 1, 2016, shall continue  
42 to provide coverage, subject to modifications made in accordance with subsection (7) of this section.

45 109.675. (1) A minor 14 years of age or older may obtain, without parental knowledge or

2 (a) Outpatient diagnosis or treatment of a mental or emotional disorder or a chemical depend-  
3 ency, excluding methadone maintenance, by a physician or physician assistant licensed by the  
4 Oregon Medical Board, a psychologist licensed by the Oregon Board of Psychology, a nurse practi-  
5 tioner registered by the Oregon State Board of Nursing, a clinical social worker licensed by the  
6 State Board of Licensed Social Workers, a professional counselor or marriage and family therapist  
7 licensed by the Oregon Board of Licensed Professional Counselors and Therapists, a naturopathic  
8 physician licensed by the Oregon Board of Naturopathic Medicine or a community mental health  
9 program established and operated pursuant to ORS 430.620 when approved to do so by the Oregon  
10 Health Authority pursuant to rule.

11 (b) **Outpatient applied behavior analysis, as defined in ORS 676.802, as a treatment of a**  
12 **mental or emotional disorder or a chemical dependency, excluding methadone maintenance,**  
13 **by a behavior analyst or assistant behavior analyst licensed under ORS 676.810 or a behavior**

16 at variance with the explanation given of the injury.

17 (B) Any mental injury to a child, which shall include only observable and substantial impairment  
18 of the child's mental or psychological ability to function caused by cruelty to the child, with due  
19 regard to the culture of the child.

20 (C) Rape of a child, which includes but is not limited to rape, sodomy, unlawful sexual pene-  
21 tration and incest, as those acts are described in ORS chapter 163.

22 (D) Sexual abuse, as described in ORS chapter 163.

23 (E) Sexual exploitation, including but not limited to:

24 (i) Contributing to the sexual delinquency of a minor, as defined in ORS chapter 163, and any  
25 other conduct which allows, employs, authorizes, permits, induces or encourages a child to engage
