**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Transfers jurisdiction of **portion of Hall Boulevard** to City of Tigard. **Directs Department of Transportation to upgrade portion of Hall Boulevard to state of good repair before transfer. Appropriates moneys from General Fund to department for costs of upgrading. Declares emergency, effective July 1, 2023.**

**A BILL FOR AN ACT**

2 Relating to jurisdictional transfer of highways; creating new provisions; amending ORS 366.483; and  
3 declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 366.483 is amended to read:

6 366.483. (1) In accordance with ORS 374.329, the Department of Transportation shall transfer  
7 jurisdiction of the following state highways to the following cities:

8 (a) Pacific Highway West, State Highway 99, from the department to the City of Eugene. The  
9 department shall transfer the following two portions:

10 (A) The portion beginning where the highway intersects with the Beltline Highway and ending  
11 where the highway intersects with Washington Street, but excluding the bridge at milepost 121.42.

12 (B) The portion beginning where the highway intersects with Walnut Street and ending where  
13 the highway intersects with Interstate 5, but excluding the bridge at milepost 126.02.

14 (b) Springfield Highway, State Highway 228 to the City of Springfield.

15 (2) Notwithstanding section 71d (4), chapter 750, Oregon Laws 2017, the department shall use  
16 the funds described in section 71d, chapter 750, Oregon Laws 2017, for the transfer of Powell Bou-  
17 levard to upgrade the portion of Southeast Powell Boulevard beginning where the highway inter-  
18 sects with Interstate 205 and ending where the highway intersects with the city limits. After the  
19 upgrades are completed, in accordance with ORS 374.329, the department shall transfer jurisdiction  
20 of the upgraded portion to the City of Portland. The department may upgrade and transfer portions  
21 of the highway in phases.

22 **(3) The department shall upgrade the portion of Hall Boulevard that is located within the**  
23 **city limits of the City of Tigard to a state of good repair, including multimodal enhance-**  
24 **ments. After the upgrades are completed, in accordance with ORS 374.329, the department**  
25 **shall transfer jurisdiction of the upgraded portion to the City of Tigard.**

26 [(3)] (4) In accordance with ORS 366.290:

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (a) The department shall transfer jurisdiction of the portion of Territorial Highway, State  
2 Highway 200, that is located within Lane County from the department to the county. The depart-  
3 ment may transfer portions of the highway in phases. The department shall retain jurisdiction of  
4 bridges on Territorial Highway located at milepoints 4.59, 7.07, 17.92, 18.72, 18.98, 19.28 and 25.49.  
5 The department shall transfer the jurisdiction of the bridges after the bridges are replaced.

6 (b) The department shall transfer jurisdiction of the portion of the Springfield-Creswell Highway,  
7 State Highway 222, beginning where it intersects with Jasper-Lowell Road and ending where it  
8 intersects with Emerald Parkway to Lane County. The department shall retain jurisdiction of  
9 bridges on Springfield-Creswell Highway located at mileposts 5.20, 5.41, 5.64 and 13.36. The depart-  
10 ment shall transfer the jurisdiction of a bridge after the bridge is replaced.

11 (c) Lane County shall transfer jurisdiction of the portion of Delta Highway beginning where the  
12 highway intersects with Interstate 105 and ending where the highway intersects with the Randy  
13 Pape Beltline from the county to the department.

14 (d) Multnomah County and Washington County shall transfer jurisdiction of the portion of  
15 Cornelius Pass Road beginning where the highway intersects with U.S. Highway 30 and ending  
16 where the highway intersects with U.S. Highway 26 from the counties to the department. The  
17 counties may transfer portions of the highway in phases.

18 **SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-**  
19 **ated to the Department of Transportation, for the biennium beginning July 1, 2023, out of the**  
20 **General Fund, the amount of \$50,000,000 for costs related to upgrading the portion of Hall**  
21 **Boulevard that is located within the city limits of the City of Tigard to a state of good repair,**  
22 **including multimodal enhancements, and transferring that portion to the City of Tigard.**

23 **SECTION 3. This 2023 Act being necessary for the immediate preservation of the public**  
24 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**  
25 **July 1, 2023.**

26
