SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes requirements for approving recovery schools. Prescribes standards and funding provisions related to approved recovery schools.
Declares emergency, effective July 1, 2023.

A BILL FOR AN ACT

Relating to recovery schools; creating new provisions; amending ORS 294.383, 326.603, 327.254, 329.451, 329.901, 339.326, 339.347, 339.370, 419A.305 and 659.852; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. (1) As used in this section, "approved recovery school" means a school that is under an agreement with the Department of Education to provide students enrolled in the school with a holistic approach to:

(a) Educational services for grades 9 through 12; and

(b) Health care services related to recovery from substance use disorders.

(2) The department shall provide or cause to be provided appropriate education for students enrolled in an approved recovery school. For the purpose of paying the costs of providing education to students enrolled in an approved recovery school, the Superintendent of Public Instruction shall make the following:

(a) Payments from amounts available from the State School Fund under section 7 of this 2023 Act.

(b) Payments from the Statewide Education Initiatives Account, as provided by rule adopted by the State Board of Education in collaboration with the advisory committee convened under section 5 of this 2023 Act. The rules adopted as provided by this paragraph may include a minimum amount, a maximum amount or both for approved recovery schools.

(3) The Superintendent of Public Instruction may contract with a school district, an education service district or a public charter school to provide or cause to be provided appropriate education to students enrolled in an approved recovery school. Unless otherwise specified, any educational services provided under a contract entered into under this subsection shall be paid as described in this section and not by any other state moneys distributed based on average daily membership that are available to the school district, education service district or public charter school for the purpose of providing educational services.

1 **(4) The State Board of Education shall adopt by rule the standards for a recovery school**
2 **to become and operate as an approved recovery school. The standards must provide that:**

3 **(a) The recovery school must align, to the extent identified by the board, with standards**
4 **for accreditation established by a nonprofit accrediting organization composed of represen-**
5 **tatives of recovery schools and individuals who support the growth of recovery schools. The**
6 **standards must include requirements that:**

7 **(A) The recovery school, in compliance with timelines established by the department, be**
8 **accredited by a nonprofit accrediting organization that establishes standards for recovery**
9 **schools. Nothing in this subparagraph requires the recovery school to be accredited at the**
10 **time the superintendent first enters into a contract with the recovery school.**

11 **(B) Student enrollment in the recovery school is voluntary. No school district or state**
12 **or local agency may compel or otherwise require a student to enroll in a recovery school.**
13 **Students enrolled in an approved recovery school may not be counted in determining the**
14 **number of pupils in average daily membership for purposes of ORS 334.175 (5).**

15 **(C) All students who reside in this state and who meet the eligibility criteria established**
16 **under subsection (8) of this section may enroll in an approved recovery school if space is**
17 **available. If space is not available, the approved recovery school may prioritize for enroll-**
18 **ment student groups identified in ORS 327.180 (2)(b).**

19 **(D) The school district, education service district or public charter school with which the**
20 **department has entered into a contract for a recovery school must agree to award high**
21 **school diplomas, modified diplomas, extended diplomas and alternative certificates as pro-**
22 **vided by ORS 329.451 and 339.877. An entity that awards high school diplomas as provided by**
23 **this subparagraph:**

24 **(i) May not impose requirements for a high school diploma that are in addition to the**
25 **requirements prescribed by ORS 329.451 (2)(a) or by rule of the State Board of Education;**
26 **and**

27 **(ii) Must accept any credits previously earned by students in another school or educa-**
28 **tional program in this state and apply those credits toward the requirements prescribed by**
29 **ORS 329.451 (2)(a) or by rule of the State Board of Education.**

30 **(E) Except as provided by subparagraph (F) of this paragraph, the recovery school must**
31 **satisfy the same laws that apply to public charter schools under ORS 338.115.**

32 **(F) All administrators and teachers at the recovery school must be licensed by the**
33 **Teacher Standards and Practices Commission.**

34 **(b) Recovery schools will be approved, to the greatest extent practicable, in a manner**
35 **that:**

36 **(A) Represents a geographic distribution across this state; and**

37 **(B) Takes into consideration the needs for services by the community in which the re-**
38 **covery school would be located.**

39 **(5) Any school that provides the services of a recovery school may enter into a contract**
40 **with the superintendent to become an approved recovery school, including schools already**
41 **providing the services of a recovery school and schools that are proposing to provide the**
42 **services of a recovery school.**

43 **(6) An approved recovery school may enter into agreements with other entities, including**
44 **community-based organizations and federally recognized tribes of this state, for the purposes**
45 **of providing educational and health care services to students enrolled in the approved re-**

1 recovery school.

2 (7)(a) The department shall be responsible for:

3 (A) Identifying, locating and evaluating students enrolled in an approved recovery school
4 who may be in need of special education and related services; and

5 (B) Ensuring that eligible students receive special education and related services.

6 (b) For the purpose of this subsection, the department may enter into a contract with a
7 school district or an education service district.

8 (8) The department shall establish eligibility criteria for students to enroll in an approved
9 recovery school, based on input from the advisory committee convened under section 5 of
10 this 2023 Act and based on research from a nonprofit organization composed of represen-
11 tatives of recovery schools and individuals who support the growth of recovery schools and
12 other relevant organizations.

13 (9) For the purposes of administering this section:

14 (a) The State Board of Education shall adopt any necessary rules.

15 (b) The department shall collaborate with the Oregon Health Authority, the Youth De-
16 velopment Division, the Alcohol and Drug Policy Commission, the Oregon Youth Authority,
17 the Department of Human Services and local public health and mental health authorities or
18 providers and shall coordinate, to the greatest extent practicable, funding of services pro-
19 vided in relation to approved recovery schools.

20 (10) Each biennium, the Department of Education shall prepare a report on the progress,
21 successes and challenges of approved recovery schools and submit that report to:

22 (a) The interim committees of the Legislative Assembly related to education; and

23 (b) The advisory committee convened under section 5 of this 2023 Act.

24 **SECTION 2.** No later than January 1, 2028, the Department of Education, in collaboration
25 with the advisory committee convened under section 5 of this 2023 Act, shall submit the first
26 report to the interim committees of the Legislative Assembly related to education as re-
27 quired by section 1 (10) of this 2023 Act.

28 **SECTION 3.** Notwithstanding section 1 of this 2023 Act, the Department of Education
29 may not enter into agreements with more than nine recovery schools to become approved
30 recovery schools.

31 **SECTION 4.** Section 3 of this 2023 Act is repealed July 1, 2029.

32 **SECTION 5.** (1) The Department of Education shall convene an advisory committee re-
33 lated to the approval of recovery schools under section 1 of this 2023 Act.

34 (2) The purposes of the advisory committee convened under this section are to provide
35 recommendations, community input and guidance related to:

36 (a) Fulfilling the intent of approved recovery schools.

37 (b) Monitoring approved recovery schools.

38 (c) Providing technical assistance that is necessary or beneficial for approved recovery
39 schools.

40 (d) Recommending legislative and policy changes that will assist in the creation and
41 sustainability of approved recovery schools.

42 (3) The advisory committee convened under this section shall consist of no more than
43 15 members appointed by the Superintendent of Public Instruction. Membership must in-
44 clude:

45 (a) Three members with experience in establishing or operating recovery schools.

1 (b) One member from the Department of Education.

2 (c) One member from the Youth Development Division.

3 (d) One member from the Alcohol and Drug Policy Commission.

4 (e) One member from the Oregon Health Authority.

5 (f) One member from local public health or mental health authorities or providers.

6 (g) One member who is a family member or caregiver of a student recovering from a
7 substance use disorder and who has experience with recovery schools or assisting others
8 with overcoming substance use disorders.

9 (h) One youth who has experience with a recovery school or who has overcome a sub-
10 stance use disorder.

11 (i) One member who is an administrator of a school district or an education service dis-
12 trict, with preference for an administrator who has experience collaborating with a recovery
13 school.

14 (4) To the greatest extent practicable, the superintendent shall make appointments under
15 subsection (3) of this section in a manner that reflects the demographic and geographic di-
16 versity of this state.

17 (5) The advisory committee convened under this section shall meet no less than four
18 times each year.

19 **SECTION 6.** Section 7 of this 2023 Act is added to and made a part of ORS 327.006 to
20 327.077.

21 **SECTION 7.** (1) The State Board of Education shall adopt by rule definitions and proce-
22 dures to be applied to the computation of the State School Fund allocations and Statewide
23 Education Initiatives Account allocations to be used for approved recovery schools, as de-
24 fined in section 1 of this 2023 Act. When adopting rules, the board must collaborate with the
25 advisory committee established by section 5 of this 2023 Act.

26 (2) For allocations made from the State School Fund, each approved recovery school shall
27 receive for each school year a special State School Fund grant, consisting of a general pur-
28 pose grant that is equal to the amount that each student's resident school district would
29 receive for the student, but without consideration of any percentage limitations that may
30 be applicable under ORS 327.013 (1)(c)(A)(i). The amount that the student's resident school
31 district would receive for the student shall:

32 (a) Be based on the school district's general purpose grant per ADM as calculated under
33 ORS 327.013; and

34 (b) Include any additional amounts attributable to the student under ORS 327.013 (1)(c),
35 subject to any applicable limitations under ORS 327.013 (1)(c)(C).

36 (3) For allocations made from the Statewide Education Initiatives Account, the rules
37 adopted under this section shall provide, to the greatest extent practicable but subject to the
38 discretion of the board, that allocations shall be in an amount necessary to pay the difference
39 between:

40 (a) The actual cost for providing education to students at the approved recovery school;
41 and

42 (b) The amounts received for providing education to students at the approved recovery
43 school from allocations made from the State School Fund under subsection (2) of this sec-
44 tion.

45 (4) Funds allocated to approved recovery schools from the State School Fund and the

1 **Statewide Education Initiatives Account shall remain with the Department of Education and**
2 **shall be adjusted in the year following the distribution to reflect the actual ADMw of stu-**
3 **dents in the approved recovery schools in the same manner as for school districts under ORS**
4 **327.101.**

5 **SECTION 8.** ORS 329.451, as amended by section 5, chapter 81, Oregon Laws 2022, is amended
6 to read:

7 329.451. (1)(a) At or before grade 12, a school district or public charter school shall award a high
8 school diploma to a student who completes the requirements established by subsection (2) of this
9 section.

10 (b) A school district or public charter school shall award a modified diploma to a student who
11 satisfies the requirements established by subsection (7) of this section, an extended diploma to a
12 student who satisfies the requirements established by subsection (8) of this section or an alternative
13 certificate to a student who satisfies the requirements established by subsection (9) of this section.

14 (c) A school district or public charter school may not deny a student who has the documented
15 history described in subsection (7)(b) or (8)(b) of this section the opportunity to pursue a diploma
16 with more stringent requirements than a modified diploma or an extended diploma for the sole rea-
17 son that the student has the documented history.

18 (d) A school district or public charter school may award a modified diploma or extended diploma
19 to a student only upon receiving consent as provided by subsection (6) of this section.

20 (2)(a) In order to receive a high school diploma from a school district or public charter school,
21 a student must satisfy the requirements established by the State Board of Education and the school
22 district or public charter school and, while in grades 9 through 12, must complete at least:

23 (A) Twenty-four total credits;

24 (B) Three credits of mathematics; and

25 (C) Four credits of language arts.

26 (b) If a school district or public charter school requires a student to complete more than 24 total
27 credits, as provided by paragraph (a)(A) of this subsection, the school district or public charter
28 school may only require the student to complete additional credits for:

29 (A) Subjects for which the State Board of Education has established academic content standards
30 under ORS 329.045;

31 (B) Courses provided as part of a career and technical education program; or

32 (C) Courses that provide, or qualify to provide, credit at post-secondary institutions of education.

33 (c)(A) A school district or public charter school that requires students to satisfy any require-
34 ments not specified by paragraph (a) of this subsection or by rule of the State Board of Education
35 must grant to a student a waiver of the requirements established by the school district or public
36 charter school if the student is or, at any time from grade 9 to 12, was:

37 (i) A foster child, as defined in ORS 30.297;

38 (ii) Homeless, as determined under rules adopted by the State Board of Education based on
39 standards adopted by the Department of Human Services;

40 (iii) A runaway, as determined under rules adopted by the State Board of Education based on
41 standards adopted by the Department of Human Services;

42 (iv) A child in a military family covered by the Interstate Compact on Educational Opportunity
43 for Military Children, as determined under rules adopted by the State Board of Education;

44 (v) A child of a migrant worker, as determined under rules adopted by the State Board of Edu-
45 cation; [or]

1 (vi) Enrolled in the Youth Corrections Education Program or the Juvenile Detention Education
2 Program[.]; **or**

3 **(vii) Enrolled in an approved recovery school under section 1 of this 2023 Act.**

4 (B)(i) For any student identified under subparagraph (A) of this paragraph, a school district or
5 public charter school must accept any credits earned by the student in an educational program in
6 this state and apply those credits toward requirements specified by paragraph (a) of this subsection
7 or by rule of the State Board of Education if the credits satisfied those requirements in that edu-
8 cational program in this state.

9 (ii) As used in this subparagraph, “educational program in this state” means an educational
10 program that is:

11 (I) Provided by a school district, a public charter school, **an approved recovery school**, the
12 Youth Corrections Education Program or the Juvenile Detention Education Program; or

13 (II) Funded as provided by ORS 343.243 for students in a long term care or treatment facility
14 described in ORS 343.961 or a hospital identified in ORS 343.261.

15 (3) A student providing work samples to demonstrate proficiency in Essential Learning Skills
16 as may be required under subsection (2) of this section must be allowed to use accommodations de-
17 scribed in the student’s individualized education program or the student’s plan developed in ac-
18 cordance with section 504 of the Rehabilitation Act of 1973, 29 U.S.C. 794. As used in this
19 subsection, the term “accommodations”:

20 (a) Includes, but is not limited to:

21 (A) Additional time to demonstrate proficiency.

22 (B) The ability to demonstrate proficiency in an alternative location that is secure and
23 proctored.

24 (C) The use of text-to-speech or speech-to-text technology or other assistive technology.

25 (b) Does not include modifications that lower the proficiency standards or that are used solely
26 to earn modified credit.

27 (4) A student may satisfy the requirements of subsection (2) of this section in less than four
28 years. If a student satisfies the requirements of subsection (2) of this section and a school district
29 or public charter school has received consent as provided by subsection (6) of this section, the
30 school district or public charter school shall award a high school diploma to the student.

31 (5) If a school district or public charter school has received consent as provided by subsection
32 (6) of this section, the school district or public charter school may advance the student to the next
33 grade level if the student has satisfied the requirements for the student’s current grade level.

34 (6)(a) For the purpose of receiving consent as provided by subsections (1)(d), (4) and (5) of this
35 section, consent shall be provided by:

36 (A) The parent or guardian of the student, if the student:

37 (i) Is under 18 years of age and is not emancipated pursuant to ORS 419B.550 to 419B.558; or

38 (ii) Has been determined not to have the ability to give informed consent regarding the student’s
39 education pursuant to a protective proceeding under ORS chapter 125; or

40 (B) The student, if the student is 18 years of age or older or is emancipated pursuant to ORS
41 419B.550 to 419B.558.

42 (b) For the purpose of awarding a modified diploma or extended diploma as provided by sub-
43 section (1)(d) of this section or of awarding a high school diploma as provided by subsection (4)
44 of this section, consent must be received during the school year for which the diploma will be awarded.

45 (7) A school district or public charter school shall award a modified diploma only to students

1 who have demonstrated the inability to meet the full set of academic content standards for a high
2 school diploma with reasonable modifications and accommodations. To be eligible for a modified di-
3 ploma, a student must:

4 (a) Satisfy the requirements for a modified diploma established by the State Board of Education;
5 and

6 (b) Have a documented history of an inability to maintain grade level achievement due to sig-
7 nificant learning and instructional barriers or have a documented history of a medical condition that
8 creates a barrier to achievement.

9 (8) A school district or public charter school shall award an extended diploma only to students
10 who have demonstrated the inability to meet the full set of academic content standards for a high
11 school diploma with reasonable modifications and accommodations. To be eligible for an extended
12 diploma, a student must:

13 (a) While in grade nine through completion of high school, complete 12 credits, which may not
14 include more than six credits earned in a self-contained special education classroom and shall in-
15 clude:

16 (A) Two credits of mathematics;

17 (B) Two credits of language arts;

18 (C) Two credits of science;

19 (D) Three credits of history, geography, economics or civics;

20 (E) One credit of health;

21 (F) One credit of physical education; and

22 (G) One credit of the arts or a world language; and

23 (b) Have a documented history of:

24 (A) An inability to maintain grade level achievement due to significant learning and instruc-
25 tional barriers;

26 (B) A medical condition that creates a barrier to achievement; or

27 (C) A change in the student's ability to participate in grade level activities as a result of a se-
28 rious illness or injury that occurred after grade eight.

29 (9) A school district or public charter school shall award an alternative certificate to a student
30 who does not satisfy the requirements for a high school diploma, a modified diploma or an extended
31 diploma if the student meets requirements established by the board of the school district or public
32 charter school.

33 (10) A student shall have the opportunity to satisfy the requirements of subsection (7), (8) or (9)
34 of this section by the later of:

35 (a) Four years after starting grade nine; or

36 (b) The student reaching the age of 21 years, if the student is entitled to a public education until
37 the age of 21 years under state or federal law.

38 (11)(a) A student may satisfy the requirements described in subsection (7), (8) or (9) of this sec-
39 tion in less than four years if consent is provided in the manner described in subsection (6)(a) of this
40 section.

41 (b) The consent provided under this subsection must be written and must clearly state that the
42 parent, guardian or student is waiving the time allowed under subsection (10) of this section. A
43 consent may not be used to allow a student to satisfy the requirements of subsection (7), (8) or (9)
44 of this section in less than three years.

45 (c) A copy of all consents provided under this subsection for students in a school district must

1 be forwarded to the district superintendent.

2 (d) Each school district must provide to the Superintendent of Public Instruction information
3 about the number of consents provided during a school year.

4 (12)(a) A student who qualifies to receive or receives a modified diploma, an extended diploma
5 or an alternative certificate shall:

6 (A) Have the option of participating in a high school graduation ceremony with the class of the
7 student; and

8 (B) Have access to instructional hours, hours of transition services and hours of other services
9 that are designed to:

10 (i) Meet the unique needs of the student; and

11 (ii) When added together, provide a total number of hours of instruction and services to the
12 student that equals at least the total number of instructional hours that is required to be provided
13 to students who are attending a public high school.

14 (b)(A) The number of instructional hours, hours of transition services and hours of other ser-
15 vices that are appropriate for a student shall be determined by the student's individualized education
16 program team. Based on the student's needs and performance level, the student's individualized ed-
17 ucation program team may decide that the student will not access the total number of hours of in-
18 struction and services to which the student has access under paragraph (a)(B) of this subsection.

19 (B) A school district may not unilaterally decrease the total number of hours of instruction and
20 services to which the student has access under paragraph (a)(B) of this subsection, regardless of the
21 age of the student.

22 (c) If a student's individualized education program team decides that the student will not access
23 the total number of hours of instruction and services to which the student has access under para-
24 graph (a)(B) of this subsection, the school district shall annually:

25 (A) Provide the following information in writing to the parent or guardian of the student:

26 (i) The school district's duty to comply with the requirements of paragraph (a)(B) of this sub-
27 section; and

28 (ii) The prohibition against a school district's unilaterally decreasing the total number of hours
29 of instruction and services to which the student has access.

30 (B) Obtain a signed acknowledgment from the parent or guardian of the student that the parent
31 or guardian received the information described in subparagraph (A) of this paragraph.

32 (C) Include in the individualized education program for the student a written statement that
33 explains the reasons the student is not accessing the total number of hours of instruction and ser-
34 vices to which the student has access under paragraph (a)(B) of this subsection.

35 (d) For purposes of paragraph (a)(B) of this subsection, transition services and other services
36 designed to meet the unique needs of the student may be provided to the student through an inter-
37 agency agreement entered into by the school district if the individualized education program devel-
38 oped for the student indicates that the services may be provided by another agency. A school
39 district that enters into an interagency agreement as allowed under this paragraph retains the re-
40 sponsibility for ensuring that the student has access to the number of service hours required to be
41 provided to the student under this subsection. An agency is not required to change any eligibility
42 criteria or enrollment standards prior to entering into an interagency agreement as provided by this
43 paragraph.

44 (13) A school district or public charter school shall:

45 (a) Ensure that students have on-site access to the appropriate resources to achieve a high

1 school diploma, a modified diploma, an extended diploma or an alternative certificate at each high
2 school in the school district or at the public charter school.

3 (b) Provide literacy instruction to all students until graduation.

4 (c) Annually provide, to the parents or guardians of a student who has the documented history
5 described in subsection (8)(b) of this section, information about the availability of a modified di-
6 ploma, an extended diploma and an alternative certificate and the requirements for the diplomas and
7 certificate:

8 (A) Beginning in grade five; or

9 (B) Beginning after a documented history described in subsection (8)(b) of this section has been
10 established.

11 (14) A school district or public charter school shall allow a student to participate in the high
12 school graduation ceremony with the class of the student and to wear:

13 (a) Native American items of cultural significance as provided by ORS 332.112; or

14 (b) A dress uniform issued to the student by a branch of the Armed Forces of the United States
15 if the student:

16 (A) Qualifies to receive a high school diploma, a modified diploma, an extended diploma or an
17 alternative certificate under this section; and

18 (B) Has completed basic training for, and is an active member of, a branch of the Armed Forces
19 of the United States.

20 **SECTION 9.** ORS 329.451, as amended by section 1, chapter 175, Oregon Laws 2021, and section
21 6, chapter 81, Oregon Laws 2022, is amended to read:

22 329.451. (1)(a) At or before grade 12, a school district or public charter school shall award a high
23 school diploma to a student who completes the requirements established by subsection (2) of this
24 section.

25 (b) A school district or public charter school shall award a modified diploma to a student who
26 satisfies the requirements established by subsection (7) of this section, an extended diploma to a
27 student who satisfies the requirements established by subsection (8) of this section or an alternative
28 certificate to a student who satisfies the requirements established by subsection (9) of this section.

29 (c) A school district or public charter school may not deny a student who has the documented
30 history described in subsection (7)(b) or (8)(b) of this section the opportunity to pursue a diploma
31 with more stringent requirements than a modified diploma or an extended diploma for the sole rea-
32 son that the student has the documented history.

39 (A) Three credits of mathematics;

40 (B) Four credits of language arts; and

42 (b) If a school district or public charter school requires a student to complete more than 24 total
43 credits, as provided by paragraph (a) of this subsection, the school district or public charter school
44 may only require the student to complete additional credits for:

45 (A) Subjects for which the State Board of Education has established academic content standards

1 under ORS 329.045;

2 (B) Courses provided as part of a career and technical education program; or

3 (C) Courses that provide, or qualify to provide, credit at post-secondary institutions of education.

4 (c)(A) A school district or public charter school that requires students to satisfy any require-
5 ments not specified by paragraph (a) of this subsection or by rule of the State Board of Education
6 must grant to a student a waiver of the requirements established by the school district or public

17 (vi) Enrolled in the Youth Corrections Education Program or the Juvenile Detention Education
18 Program[.]; **or**

19 **(vii) Enrolled in an approved recovery school under section 1 of this 2023 Act.**

20 (B)(i) For any student identified under subparagraph (A) of this paragraph, a school district or
21 public charter school must accept any credits earned by the student in an educational program in
22 this state and apply those credits toward requirements specified by paragraph (a) of this subsection
23 or by rule of the State Board of Education if the credits satisfied those requirements in that edu-
24 cational program in this state.

25 (ii) As used in this subparagraph, “educational program in this state” means an educational
26 program that is:

27 (I) Provided by a school district, a public charter school, **an approved recovery school**, the
28 Youth Corrections Education Program or the Juvenile Detention Education Program; or

21 lieves is evidence of a violation of a state or federal law, rule or regulation.

22 (3) A student, or a parent or guardian of a student under 18 years of age, who alleges a violation
23 of subsection (2) of this section may bring a civil action under ORS 659A.885.

24 **SECTION 20. This 2023 Act being necessary for the immediate preservation of the public**
25 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**
26 **July 1, 2023.**
